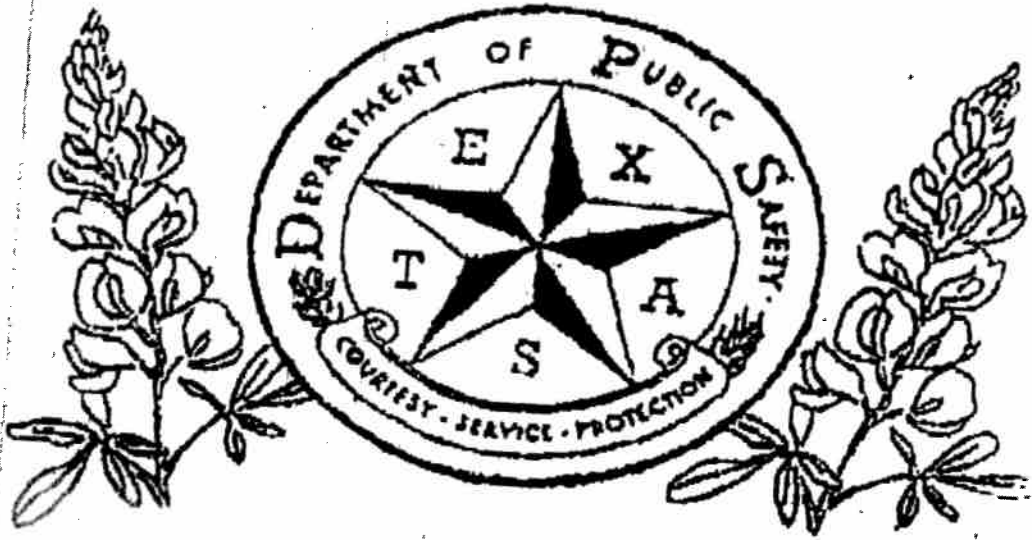

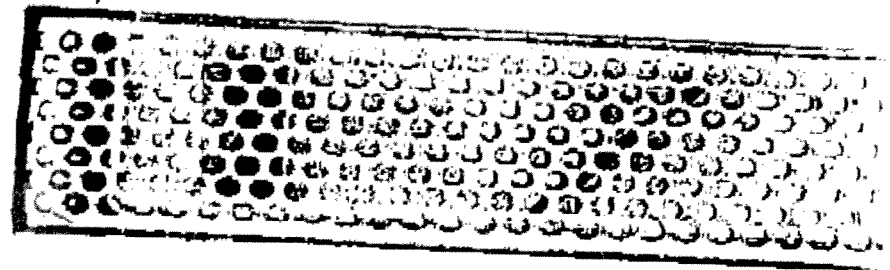

STATEMENT OF STEVEN DOUGLAS HARBACH

M: Now Steven maybe we could just start by you telling me about America's Most Wanted show that you mentioned you saw and how the information you might have could relate to that?

S: Okay. I was watching America's Most Wanted with my girlfriend. It was the last taping of the show and they aired a segment on there about John Walsh's son Adam, apparently had been murdered abducted and murdered. And on the last they were asking that anybody with information with an early model 1970's white Cadillac with anybody with information to please phone in regardless how small it may seem to them. And dah, which triggered back in 1981 I been hitch hiking and been picked up by a white Cadillac.

M: Now you're sure it was the show America's Most Wanted?

S: Yes.

M: And the segment was on John Walsh's son that was murdered down in the States back in 81?

S: Yes.

M: Now that would have aired how long ago roughly?

S: Approximately a month and a half to two months ago.

M: Okay and it was the last show for America's Most Wanted?

S: Yes.

M: Maybe you could just describe the circumstances of what you know about this white vehicle or or white vehicle that you had contact with?

S: Well. It was definitely a early 70's model. Early 70's model white Cadillac. Um. When the, the fellow pulled over to pick me up he had a set of bull horns attached to the front of it. And ah, that's about the on. He had a CB in it and dah, that's about and it was white coloured. That's about dah, the only distinguishable things on the car itself.

M: Okay now. You're hitch hiking just outside of Brandon, Manitoba?

S: Yes.

M: Can you remember the highway that you were picked up on?

S: It was Trans Canada.

M: Now the vehicle. We'll talk about the vehicle firstly. It's a. It's a white Cadillac.

S: Yes.

M: Early 70's.

S: Yes.

M: Interior the vehicle, remember the colours?

S: It was all leather interior. Ah, I can't be exact on the colours. Can't be exact on the colours.

M: Was there anything inside the vehicle that you could remember ah, ah, decals or stickers or a, anything that could be kind of distinguishing?

S: Not that I can remember no.

M: Two door or a four door?

S: Ah, four door.

M: Now the the tires and the wheels were on the vehicle.

S: Pardon me. Two door.

M: Two door?

S: Yes.

M: Tires and wheels were on the outside of the vehicle. Ah, whitewalls, mags, what ah, can you recall what the wheels were like?

S: White walls.

M: Where they? What type of rims were they?

S: Well I would imagine they were Cadillac rims original rims that were on the car.

M: Okay so there was nothing distinguishing or really different from?

S: No like they weren't ah, highly polished chrome plated rims or anything like that or an after market rim.

M: Okay so it appeared to you that the standard type issued for the Cadillac.

S: Yes.

M: Now was there anything else around the outside of the vehicle that could be distinguishing?

S: Yes. Bull horns on the front.

M: Okay.

S: On the hood.

M: Can you describe the or were he had them on the hood.

S: He had them mounted right on the very front centre of the vehicle. On the front and they were removable. They could be put on or taken off in a matter of a minute.

M: Colour of the bullhorns?

S: Well kind of a brownish with white in them and they ah, black kind of a hairy centre piece in between were the horns come out.

M: Now when you're talking bull horns are we talking cows like here in Ontario or are we talking the the big Texas horns?

S: Texas Horns. They were quite quite distinguishable.

M: Okay they were. So they were larger than?

S: Yes. Larger than a normal cows.

M: Okay. Alright. Anything else on the outside of the vehicle. Ah, was the glass tinted, ah, extra chrome; stickers; scratches; dents; anything like that?

S: No not that I can recall.

M: Can you remember what ah, license plates were on the vehicle?

S: I believe they were British Columbia plates.

M: Okay. So you get into this vehicle with this fellow and your heading to where?

S: I am heading to Vancouver. He is heading to Vernon, B.C.

M: Can you describe the fellow?

S: Ah, he's about 6'2 to 6'4 - 220-240 lbs. Ah, kind of a heavy built. Ah. No facial hair.

M: Okay colour of hair?

S: Ah, black.

M: Length?

S: Um, just medium here.

M: Did he have any distinguishing marks, scars, tattoos, bruises anything like that?

S: Not that I could tell.

M: Ah, how about his vocabulary. Did he speak with any type of an accent?

S: No.

M: Didn't walk with any limps? Have any missing fingers or arms, anything like that?

S: No.

M: Glasses?

S: No

M: Now when you get into the car? This the way I guess initially. You thought everything was kind of all right. You were hitch hiking. Somebody was good enough to pick you up.

S: Yes cause it was raining out and I was like a drowned rat. At the time I was just drenched.

M: So as the the trip progressed, what kind of came to mind that made made you think that this guy was maybe not a 100%?

S: Well after couple 100 miles of travel he pulled over and on the side of the road and took his bull horns off the front of his car. It only took him about a minute to do it. Took the bull horns off and put them in the trunk.

M: Okay. Did....

S: I.

M: Did you ever ask him why?

S: No. No I never.

M: Now did they stay there for the rest of the trip?

S: No he had pulled over. After Medicine Hat I believe it was and put them back on. Took them out of the trunk and put them back on.

M: And you never asked him why he was....

S: No.

M: Doing this switching?

S: No, no, I thought it a little weird, but I never questioned about it.

M: Now is there anything that that happened during this trip that made you think things weren't quite right?

S: Yes, he had picked up a girl hitch hiking and dah, after about maybe 50 - 75 miles pulled over on this small rest stop. And dah, he said that he was going to get it on with her and that that I could participate if I wanted and I said no I did not want no part of this. I got out of the car. I guess he started feeling her up a bit that I could hear her I could hear protesting. And I said know I want no part of this. After about 10 - 15 minutes he stopped doing what he was doing. I got back into the car. He drove. We were driving for awhile. He got on his CB and started asking truckers if there were anybody was interested in getting laid that he had a hitch hiker that was going to Vancouver and he wasn't going that far that dah, he would meet anyone at a mile marker just name the mile marker.

M: Now this girl were did she get picked up?

S: Um. Little after Medicine Hat, Alberta.

M: Now when she got into the car: um, did she give a name or did you guys?

- S: No I was in ah, the back seat actually he told me to get into the back seat so I did and dah. She looked like she's. She was pretty haggard and that she like a street person and. And dah, he started talking to her. Asked her were she was going. Were she was from. She was quite quiet. Wasn't volunteering much information.
- M: Did she use a name or anything?
- S: Not that.
- M: That you can recall?
- S: Not that I can remember no.
- M: Can you remember what she looked like?
- S: She was about 5'8. Thin, long dirty blond hair. Ah, very pot marked face. Wearing ah, dirty blue jeans and a white top.
- M: Now when you say that ah, he was starting dah, to make advances to her and she started to protest. What could you hear going on? What was being said?
- S: I could hear him saying come on. Come on ah, you'll pay for your ride this way. And her saying no, no I don't want to. I can get out here and walk.
- M: Okay so how long does this girl stay with yous on this, on this trip?
- S: All together I would say approximately 2 1/2 to 3 hours.
- M: Okay.
- S: From being picked up to dropped off again.
- M: Alright. And it's the last you seen or heard of this girl. She gets out and gets in a truck.
- S: She got out and dah, got into a truck that had pulled up behind us at a mile marker.

- M: So from that point on what happens with you guys?
- S: Ah, didn't really say much for awhile. Um. We drove on through the night. Ah, we got across the B.C. - Alberta border. He pulled in to Golden, B.C. and bought a bottle of liquor and started drinking it while he was driving through the mountains. He says well it ain't far now until Vernon. And dah, before I never. I was going to get off on the cut off that went to Vernon. I was going to Vancouver myself. But he kind of said well you can come and spend a few days with me at my place in Vernon. Which I did.
- M: And while you were in Vernon did anything happen or transpire? Why did you leave?
- S: Well he had got me to go to the welfare office and get him a food voucher, which ah, which I did. And he had sold it to somebody on the street for some cash money. He went and bought a couple more bottles of liquor. He went back to his place. We were drinking a bit. And dah, next thing I know he had slashed his wrists quite quite deeply. So I phoned dah, the police and the ambulance. They came. They took him to the hospital. The police asked me who I was. I told them. They had advised me to pack my stuff and dah, get out of there. That's not the place for me to be.
- M: Did the police kind of indicate that they had prior knowledge of this guy?
- S: Yes.
- M: Alright. Um. So after he slashed his wrists and they took him to the hospital you never saw him after that?
- S: No.
- M: You know what hospital they took him to in Vernon?
- S: I believe there's only one hospital...
- M: Okay.
- S: In Vernon.

- M: Do you know what police department would have responded to that?
- S: Not sure if it was the loc, local police or the RCMP.
- M: Okay now can you give me a time line on when this may have happened?
- S: This happened about 10:00 o'clock at night. Somewhere between 9 and 10 at 10:00 o'clock at night. Ah. I left. I asked the police if I could stay there that night because it was late and I'd leave first thing in the morning. They said yes that would be fine.
- M: Now month, year, day?
- S: Ah, this was. Late summer, early fall. It was late summer, early fall.
- M: Okay what year?
- S: 1981.
- M: 81.
- S: Um huh.
- M: Okay. Now when in your discussions with this guy, did he ever use a name or identify himself to you?
- S: He told me his name was Ian.
- M: Did he ever mention to you what he was doing in Manitoba?
- S: Yes he said he sah, discussed finished visiting his wife after divorcing her. He was there on a visit.
- M: So he was originally or he was from Nelson the way you took it?

S: From Nelson?

M: Or from Vernon sorry?

S: From Vernon. Um. No one else lived at his townhouse. There was no evidence of anybody else living there but him.

M: Now the townhouse were he lived. Can you describe the townhouse?

S: Well there probably only a couple years old. There were fairly nice units. There was ah. Row of 8 of them, I believe and then 2 off separate to the side where the manager, where the management lived and apparently he knew the management fairly good because they come over and had a few drinks with him.

M: Now can you remember on what part of town it was or a street or anything like that.

S: I don't remember the street. It's. It was on a a hill cause Vernon is in a valley. It was on a hill. I would say the east side of Vernon. Would be the east side of Vernon.

M: Okay now what did the townhouses look like? Ah, colour wise, design, shape?

S: Brick. Um. There was three levels to the townhouse.

M: Colour of brick?

S: Brownish, brownish with little specks of black in the brick and stuff like that.

M: Where did he park his vehicle?

S: Ah, right in front of his townhouse.

M: Okay, so no garages?

S: No garages.

- M: Is there anything else that you can kind of recall? Like did you have any discussions with him along the way. Like you guys drove together quite a long time.
- S: He asked. I remember him asking me if I knew how to grow marijuana. And I said yes, I've had some experience in grown

it just a small bit. Like a plant here and a plant there. I remember him taking me up the side of a mountain to this small little farm. Small little farm where he showed me a small marijuana growing operation and asked me they said they fired their last guy for ripping them off. They asked me if I could start some plants for them.

M: So they're asking you?

S: They're asking me if I could start some plants. So they showed me a drying operation they had there and that and this was all knew to me.



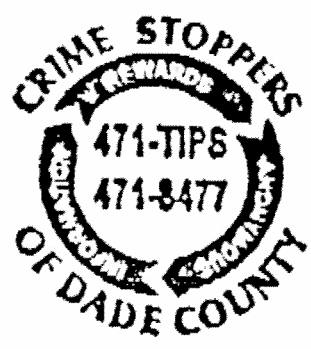
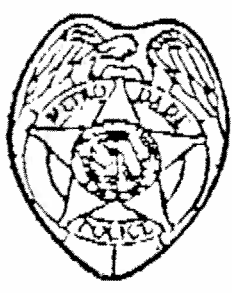
S U M M A R Y
INVESTIGATIVE FINDINGS

This thirty-eight year old white female died in the intensive care unit of Winter Haven Hospital on the 15th of November, 1981. She had been brought to the hospital with an overdose of alcohol, Sinequan, and Navane. There was anatomic evidence at autopsy that she had attempted suicide or at least made a suicidal gesture in the past.

It is the conclusion of the autopsy examination and examination of the hospital chart that death in this case was due to a drug overdose, and that the manner of death was suicide.

TIPSTER STATED THAT DARREN HOLDEN WAS WORKING IN GAINESVILLE DURING THE TIME PERIOD THAT KRISTA HOYT WAS MURDERED. HE HAD A CUT ON HIS PINKY FINGER AND CUTS OR DEEP SCRATCHES ON HIS ARM FROM THE WRIST TO THE ELBOW, AS IF SCRATCHED BY SOMEONE FIGHTING HIM. HE WAS WORKING FOR RYAN JONES BUILDING MAINTENANCE CO. P.O. BOX 24056, GAINESVILLE, PRIOR TO THE MURDERS. AFTER THE MURDERS HE CHANGED JOBS AND WENT TO WORK FOR SONNY'S ~~B-B-Q~~, AT 3631 SW ARCHER ROAD, GAINESVILLE. AT RYAN'S HE USED HIS OWN SOCIAL SECURITY NUMBER OF 267-59-1468. AT SONNY'S HE USED HIS MOTHER'S SOCIAL SECURITY NUMBER OF 265-53-7183. DURING THE WEEKEND OF THE MURDERS, DARREN REMARKED TO OTHER EMPLOYEES OF RYAN'S THAT HE FELT LIKE HE WAS LOSING HIS MIND.

TIPSTER IS CLOSE TO DARREN'S MOTHER AND ACCOMPANIED HER ON A TRIP FROM WINTER PARK, FL TO GAINESVILLE, FL, TO VISIT DARREN IN A WORK RELEASE PROGRAM. DARREN'S MOTHER STATED THAT SHE IS AFRAID THAT IT'S POSSIBLE THAT DARREN HAS KILLED TIFFANY SESSIONS, KRISTA HOYT AND ADAM WALSH. HE CONTINUALLY TALKS ABOUT 'CUTTING PEOPLE'S HEADS OFF' AND DISMEMBERING THEM.

DURING THE SAME TIME PERIOD THAT TIFFANY SESSIONS WAS REPORTED MISSING, DARREN WAS IN GAINESVILLE FOR HIS MOTHERS EYE SURGERY.

DARREN'S FATHER RESIDES IN WEST PALM BEACH. AT THE TIME OF ADAM WALSH'S DISAPPEARANCE, HE WAS STAYING WITH HIS FATHER IN PALM BEACH.

TIPSTER BELIEVES THAT DARREN HAS COMMITTED THE ABOVE MURDERS AND THAT HIS BROTHER LEROY HOLDEN HELPED. TIPSTER FURTHER STATED THAT ONCE DARREN THREATENED HER STATING HE WOULD KILL HER LIKE KRISTA HOYT, 'HE WOULD CUT HER HEAD OFF BEFORE SHE WAS KILLED, DEMONSTRATING AS HE TOLD HER, AND WOULD SET IT ON THE STEREO SPEAKERS, THEN HE WOULD CUT HER OPEN FROM HER 'FEMALE PRIVATE PARTS' TO HER RIBCAGE, REMOVE THE SKIN, THEN REMOVE HER INTESTINES'.

DARRENS MOTHER IS JUANITA HOLDEN WHO WORKS AT WINTER PARK HOSPITAL. A MAN NAMED WAYNE DEFAZIO USED TO WORK WITH JUANITA HOLDEN. HE WAS REPORTED MISSING AND PRESUMED KILLED, AS BLOOD WAS FOUND IN HIS APT. AND HIS VEHICLE WAS LEFT IN THE DRIVEWAY. JUANITA STATED THAT HE WOULD NEVER LEAVE HIS 6 YR OLD SON. JUANITA THINKS THAT DARREN MAY HAVE HAD SOMETHING TO DO WITH THAT MURDER ALSO, AS HE WAS IN WINTER PARK AT THAT TIME.

Mr. Richard Witt:

This information I am sending you is not a hoax, I have believed for the last several months that a man I know may be the one who murdered Adam Walsh, but I didn't feel I had enough hard reason's to believe it because it was at first only a strong feeling because for one he fits the discription of someone who would very well do such a thing to a child, two he is a pedaphile, he also is involved in networking on the internet pornographic material and I am almost positive he is involved in child pornography.

He left his wife and eighteen month old daughter in 1980 or 1981 and traveled with a drug group of musicians and came to Florida. Right around the time Adam Walsh was murdered he was in the area but went to the Ke. right after the murder and then he went to Nashville for a few years or actually from 1981 till 1989 or 90 when he then returned to Florida. He moved many times within Florida and received many many tickets for non-registered vehicles, no insurance, ficticious plates, etc.

He now would appear to most as a respectable person in the manner of which he dresses and he now has a short haircut and is actually married again, but as the old saying goes you can't judge a book by it's cover he is a perfect example of it. In 1980 he had lingish hair, an earring, and drifted around drinking and drugging and it is believed that he is gay and loves little boys. His last three girlfriends were on disability checks as he seems to seek woman with an income guaranteed as he hates to work, except with his computer. He hasn't paid income tax in the last eight years or so and he usually works freelance, sometime taking on a job for a short time. He is presently married to a woman who also recieve a disability check.

Knowing all of this and knowing him I still could not send you this information on just a very stong feeling, until I read some of the evidence and information that was printed in the paper since you released the files. It stated that children had noticed a van outside the sears entrance and I know he had a van and I believe it was at that time. Too often people don't take what children say as so important but I have found that children notice much more than they are given credit for and they had no reason to lie. I also know that he was always getting tickets and always having to go to court, just maybe he was in court that day on Hollywood Blvd. and just maybe he visited the sears store as he always loved going in to play video games.

He now drives a yellow cadillac, license plate SRU-97K and he lives in Boynton Beach, He goes by the name of Jeff, but his full name is James Jeffrey Lawlor. If you can somehow find out what and who he is internet-ing the pornography with you may find out more than you expect. I'm not trying to place him as Adams Killer for any reason except I believe he would definetly do such a thing and I have this gut feeling that he is the one.
