ALSO PRESENT AT THIS TIME IS UNDERSHERIFF BILL ARNOLD AND THE STATEMENT IS COMMENCING ON 3-9-96 AT APPROX. 9:30 LOCAL TIME AM.

Q. DENNIS, AT THIS TIME I'D LIKE TO PLACE YOU UNDER OATH BY VIRTUE OF MY COMMISSION AS A POLICE OFFICER FOR THE CITY OF HOLLYWOOD, COUNTY OF BROWARD, STATE OF FL. FIRST OFF, ARE YOU AWARE IT IS A CRIME TO LIE UNDER OATH?

A. EXCUSE ME?

Q. ARE YOU AWARE IT IS A CRIME TO LIE UNDER OATH?

A. YES

Q. OH, COULD YOU RAISE YOUR RIGHT HAND PLEASE? LET THE RECORD REFLECT HE'S DOING SO. DO YOU SOLEMNLY SWEAR TO TELL THE TRUTH, THE WHOLE TRUTH AND NOTHING BUT THE TRUTH SO HELP YOU GOD?

A. YES SIR

DENNIS LANCASTER HAVING APPEARED BEFORE ME AS A POLICE OFFICER FOR THE CITY OF HOLLYWOOD, COUNTY OF BROWARD, STATE OF FL HAVING BEEN DULY SWORN DEPOSES AND STATES:

Q. FOR THE RECORD SIR, WOULD YOU JUST STATE YOUR FULL NAME AND BIRTH DATE FOR ME PLEASE?

A. DENNIS ANTHONY LANCASTER, 3-13-47, MARCH 13

Q. 1947

A. YEAH

Q. ALRIGHT DENNIS, I TOLD YOU, I MADE AN INTRODUCTION OF MYSELF OUTSIDE AND TOLD YOU WHY I WAS HERE, UH, AND IT'S REGARDING THE ADAM WALSH CASE WHICH OCCURRED IN 1981, AND IT OLD YOU THAT UH, I'M HERE JUST TO INTERVIEW YOU AS AN EX-EMPLOYEE OF SEARS. I TOLD YOU I'VE BEEN INTERVIEWING CURRENT EMPLOYEES, PRETTY MUCH JUST ANYBODY THAT UH, YOU KNOW, THAT HAD ANY CONNECTION WITH SEARS AT ANY TIME IN HOLLYWOOD. OK? AND OF COURSE WE'RE SITTING HERE IN YOUR HOME AND UH, THE INTERVIEW IS TAKING PLACE AND, AND THAT'S THE PREFACE I WANT TO JUST BRING TO YOUR ATTENTION JUST TO KEEP IN MIND THAT'S WHY I'M HERE.

UH, FIRST OFF, CAN YOU TELL ME AS MUCH AS YOU CAN, AS MUCH AS YOU REMEMBER ABOUT WHEN UH, WHEN YOU BEGAN WORKING AT SEARS. IN OTHER WORDS, WHEN DID YOU START? DO YOU REMEMBER?





- Q. WHAT PART OF CALIF. DID YOU LIVE IN?
- A. OH, POMONA, CALIF.
- Q. POMONA? WHEN YOU MOVED OUT TO CALIF. DID YOU WORK?
- A. YES, I WAS, I WAS A WAITER AT OH, AT (UH) RESTAURANT. UH, UH.
- Q. WHAT'S THE NAME OF THE PLACE?
- A. WIDOW BROWN'S WAS THE NAME OF THE RESTAURANT.
- Q. IS THAT IN POMONA?
- A. IT'S IN ONTARIO, CALIF.
- Q. ONTARIO. HOW FAR IS ONTARIO FROM POMONA?
- A. ABOUT 20 MINUTES.
- Q. DO YOU REMEMBER WHEN YOU STARTED WORKING THERE? WHAT MONTH WAS IT IMMEDIATELY WHEN YOU MOVED OUT THERE OR
- A. UH, ABOUT 3 WEEKS
- Q. 3 WEEKS?
- A. UH, HUH
- Q. AND YOU SAID YOU WERE A WAITER.
- A. A WRITER.
- Q. WHEN UH, WHEN YOU MOVED OUT TO, YOU SAID IT WAS POMONA, WHERE WERE YOU LIVING?
- A. AT THE YMCA
- Q. AT THE YMCA IN POMONA?
- A. YES.
- Q. AND THEY, THEY PROVIDED HOUSING?
- A. YES, BECAUSE THEY HAVE.
- Q. WERE YOU STAYING WITH ANYBODY IN PARTICULAR?
- A. NO.
- Q. YOU JUST STAYED BY YOURSELF?

- Q. UM HUH, YEE
- Q. NOW ABOUT YOUR FRIENDS THAT WERE OUT THERE? WHERE DID THEY LIVE?
- A. THEY WENT TO OHV ON TO OHV, UPS, MENTONA, CALIF. WHICH IS NORTH OF OHV. OHV, LOS ANGELES.
- Q. NORTH OF LOS ANGELES.
- A. A LITTLE BIT.
- Q. IS THAT NEAR ANAHEIM?
- A. YEAH, CLOSE TO ANAHEIM.
- Q. WHEN OHV, SO HOW LONG DID YOU OHV, KEEP THAT JOB THAT YOU'RE TALKING ABOUT?
- A. I WAS THERE FOR ABOUT 2 OR 3 YRS.
- Q. 2 OR 3 YRS? SO NOW WE'RE TALKING OHV, 1983 - 1984?
- A. I THINK '83, THEREABOUTS, YEAH.
- Q. UP TO 1983?
- A. ABOUT '83, YEAH.
- Q. DID OHV, DID YOU OPERATE ANY MOTOR VEHICLES WHEN YOU LIVED OUT THERE? DID YOU OWN A CAR?
- A. YEAH.
- Q. DID YOU HAVE ACCESS TO CARS OR YOU OWNED A CAR OR WHAT?
- A. I OWNED THE CAR.
- Q. WHAT KIND OF CAR DID YOU HAVE?
- A. I HAD A CADILLAC. IT WAS A '74 OR '73 CADILLAC.
- Q. OHV, YOU BOUGHT THAT OUT THERE?
- A. UM HUH.
- Q. OHV, WHAT HAPPENED? WHY, IN '83 DID YOU STOP LIVING IN CALIF.
- A. YEAH, I STARTED WORKING AT THE WILSONS GRAPE PLANTATION IN '83.
- Q. CALIFORNIA GRAPE?

- Q. UM, YEAH, IN WILMINGTON.
- Q. HOW FAR IS THAT FROM POMONA?
- A. UM, THAT WAS ABOUT HALF AN HOUR DRIVE.
- Q. YOU STILL LIVED IN POMONA?
- A. UM, YEAH.
- Q. DID YOU STILL LIVE AT THAT ADDRESS IN POMONA FOR AWHILE?
- A. YEAH, UM, HUH.
- Q. YES?
- A. YEAH.
- Q. OK, FROM UM, AT WHAT POINT DID YOU UM, DID YOU MOVE TO, YOU SAID YOU LIVED IN PHOENIX?
- A. YEAH, IN '86 I MOVED TO UM PHOENIX.
- Q. DID YOU EVER LIVE IN PHOENIX BEFORE THAT?
- A. NO.
- Q. DID YOU EVER MOVE BACK TO FLORIDA?
- A. WE MOVED BACK I THINK IT WAS A YEAR, IT WAS '91 I THINK IT WAS.
- Q. JUST WHAT, WHAT YOU CAN REMEMBER.
- A. YEAH, I THINK IT WAS '91 WE MOVED BACK TO FL AND I WAS WORKING AT MR. GROCER IN UM.
- Q. THAT'S ALRIGHT, WHATEVER YOU CAN RECALL.
- A. IT WAS NORTH OF UM, ST. LAUDERDALE AND I CAN'T THINK OF THE NAME OF THE TOWN THAT MR. GROCER.
- Q. POMPANO HAYBAG?
- A. POMPANO, MR. GROCER.
- Q. WHY DID YOU MOVE BACK TO FL?
- A. UM, I HAVE HAD PROPERTY IN FL, I WANTED TO CHECK ON THE PROPERTY THAT I HAD IN FL, OUT IN ANDLER CITY AND HE WANTED TO, YOU KNOW, SETTLE DOWN OUT THERE AND I, I DIDN'T WORK OUT, SO HE JUST STAYED, I THINK IT WAS ALMOST A YEAR, WE STAYED THERE AND THEN HE MOVED OUT TO UM, BACK TO PHOENIX, UM, IT WAS LESS THAN A YEAR, THEN WE MOVED BACK TO PHOENIX.

Q. IS IT SAFE TO SAY FROM THE ADV. OF THE 1950'S THAT YOU WOULD NOT BE IN FLORIDA?

A. UM HUH, JUST THAT ONE TIME YOU THRU THE 50'S WAS IN FL. THAT ONE TIME. I LEFT FL. IN '78.

Q. AND WHEN YOU CAME BACK TO FL. YOU SAID IN '71. HOW DID YOU COME BACK?

A. I DROVE OUT THERE.

Q. DRIVE BACK TO FL.?

A. UM HUH.

Q. HOW DID YOU MOVE TO CALIF.?

A. DROVE.

Q. DROVE? WHAT CAR DID YOU HAVE BACK THEN WHEN YOU LEFT?

A. I HAD A FORD UM, FORD GALAXIE OR SOMETHING. I DROVE THE CAR OUT TO UM, TO CALIF.

Q. NOW, WHEN YOU WORKED AT SEARS, DURING THE YEARS YOU WORKED AT SEARS, OH, WHAT DID YOU LOOK LIKE? I MEAN, DID YOU LOOK THE SAME, JUST DARKER HAIR? I SEE YOU HAVE SOME GRAY IN YOUR HAIR NOW.

A. DARKER HAIR, YEAH.

Q. AND UM, AT THE TIME THAT YOU WERE UM, WORKING AT SEARS, DO YOU WEAR GLASSES BY THE WAY?

A. YEAH, UM HUH.

Q. DID YOU WEAR GLASSES BACK WHEN YOU WORKED AT SEARS?

A. YEAH, UM HUH.

Q. UM, UM, SO YOU WORKED THERE FOR A GOOD AMOUNT OF TIME AND A LOT OF UM, WERE A LOT OF PEOPLE, DID YOU KNOW A LOT OF PEOPLE THAT CAME THROUGH THE STORE?

A. UM HUH.

Q. WAS YOUR UM, UM, YOU MENTIONED THAT YOU WERE NOT BACK IN FL. IN '71, WHICH IS WHEN THE FBI WENT TO FLORIDA.

A. YEAH, I HADN'T LIVED IN FL. UNTIL.

Q. WOULD YOU EXPLAIN TO ME UM, WITH A MOMENT WITH A FIVE MINUTE TIME FRAME, HOW YOU GOT OUT THERE IN JULY, 1971?

A. I DON'T KNOW WHY IN THE WORLD YOU'D ASK THAT, 'CAUSE I WAS BEING

Q. EVEN

Q. SHE KNEW YOU.

A. SHE LEFT IN '76 AND HAVEN'T BEEN BACK THERE SINCE UNTIL 1991.

Q. YEAR WELL, THIS WOMAN IS VERY CONFIDENT THAT SHE KNEW WHO YOU WERE AND THAT SHE SAW YOU IN JULY OF 1971 INSIDE THE BEARS STORE.

A. I WASN'T EVEN THERE, NO WAY. I WAS LIVING IN CALIF.

Q. I UNDERSTAND THAT BUT

A. YES

Q. BUT OH, BUT YOU DO DRIVE.

A. YEAR

Q. COULD YOU BE MISTAKEN?

A. NO, I WASN'T LIVING IN FL IN '71

Q. NO, I KNOW YOU WEREN'T LIVING IN FL IN '81.

A. AND I DIDN'T, I DIDN'T HAVE ANY EXTRA MONEY TO EVEN MAKE A TRIP BACK THERE.

Q. OK, WHO WERE YOU LIVING WITH AT THE TIME?

A. IN CALIF?

Q. IN 1981 I'M TALKING ABOUT.

A. OH, WHAT'S HIS NAME? I CAN'T EVEN THINK OF HIS NAME. I DON'T BELIEVE I CAN'T EVEN THINK OF HIS NAME. IT WAS MY ROOMMATE THAT I HAD IN CALIF. IT'S A BLANK.

Q. THE CAR YOU SAY YOU WERE DRIVING, WHAT KIND OF CAR WAS IT?

A. OH, IT WAS A GOLD, GOLD CADILLAC.

Q. OH, OH

A. 1978 GOLD CADILLAC

Q. AND THAT'S THE CAR YOU WERE DRIVING IN '71?

A. OH, OH

Q. OH, WHEN I JUST TOLD YOU WHAT A WOMAN POLICE TOLD ME SAID, SHE SAID SHE KNEW YOU SAID SHE SAW YOU THERE, WAS SHE MISTAKEN?



Q. DEFINITELY. CAUSE I WAS NOT EMPLOYED.

Q. OK. ARE YOU CONFIDENT WITH THAT?

A. OH YEAH. I WAS DEFINITELY LIVING IN CALIF.

Q. WELL, I UNDERSTAND YOU WERE LIVING IN CALIF. NOW.

A. UH HUH.

Q. BUT THAT DOESN'T MEAN THAT YOU COULDN'T HAVE BEEN IN HOLLYWOOD, FL IN 1981.

A. NO I WASN'T. I WAS NOT IN FL IN '78 AND DIDN'T MOVE BACK UNTIL '81. THAT'S SOMETHIN' I CAN OWEAR ON A STACK OF BIBLES ON.

Q. WHEN YOU UH, WHEN YOU SAY YOU WERE WORKING, WHERE WERE YOU WORKING AT THAT TIME?

A. IN '81 I WAS WORKING AT THE CRUSHED GRAPE REST.

Q. CRUSHED GRAPE?

A. REST. IN W. FLORIDA.

Q. SO THEY SHOULD HAVE WORK RECORDS FOR YOU WORKING THERE AT THAT TIME, RIGHT?

A. UH HUH.

Q. IN JULY OF 1981?

A. YEAH. I WAS RIGHT THERE. UH. I USED TO GO TO THE OFF. AT 181 EAST UH, IN UH, IN FLORIDA.

Q. THE ALIBI EAST? WHAT'S THAT?

A. ALIBI EAST IS A BAR IN NASH.

Q. YEAH.

A. AND THEY KNOW HE THERE. I'M TRYIN TO THINK OF A WORKER WHO'D REMEMBER MY ROOMMATE'S NAME. IT'S A COUPLE OF BLOCKS.

Q. DID YOU TAKE A VACATION WHILE YOU WAS WORKING AT THE CRUSHED GRAPE?

A. NO.

Q. YOU DIDN'T TAKE A VACATION?

A. UH HUH.

Q. YOU WERE THERE EVERY DAY. NEVER TOOK ANY TIME OFF?

- Q. 3 DAYS A WEEK, 5 DAYS A WEEK.
- A. YOU NEVER TOOK ANY TIME OFF.
- Q. UH UH, NO.
- A. ALL WORK, NO PLAY, HUH?
- Q. JUST ABOUT.
- Q. SO THEY'LL HAVE, THEY'LL HAVE WORK RECORDS FOR YOU FOR THAT TIME PERIOD.
- A. THEY SHOULD.
- Q. FOR THAT MONTH, IN THE SUMMER OF 1981.
- A. THEY SHOULD HAVE RECORDS, YEAH.
- Q. AND YOU CAN'T REMEMBER YOUR ROOMMATE'S NAME AT THE TIME.
- A. I WISH I COULD REMEMBER IT. ALL THE NAMES AREN'T, AREN'T CLIPPING. THE PEOPLE THAT I WORKED WITH AND THE FRIEND AND EVERYTHING. IT'S BEEN SO LONG I FORGOT ALL THEIR NAMES. UH BUT I HAD A ROOMMATE. UH, WE LIVED IN ONTARIO ON UH, E. AL. IN ONTARIO IN AN APT. COMPLEX THERE. IT WAS RIGHT BEHIND THE UH, THAT CAR DEALERSHIP. UH, AND I STAYED, WE STAYED THERE ALL THE WAY UP UNTIL UH, '84.
- Q. SO THEN WHEN YOU WERE LIVING THERE, WHO WERE YOU LIVING WITH?
- A. THE ROOMMATE, WAYNE, NOW IT'S COMING TO ME, UH, WAYNE HIS NAME WAS, WAYNE HURST?
- Q. HOW LONG HAVE YOU KNOWN THAT PERSON?
- A. THAT WAS THE ROOMMATE I HAD FOR ALMOST 2, 3 YRS. IN CALIF. THE ONE I WAS LIVING WITH. UH, I MOVED IN WITH HIM IN UH, '80 AND STAYED WITH HIM FOR ABOUT 4 YRS.
- Q. AND THAT'S WAYNE?
- A. GAINBURY?
- Q. GAINBURY?
- A. GAINBURY?
- Q. DO YOU KNOW HOW THAT'S SPELLLED?
- A. G-A-I-N-B-U-R-Y, I BELIEVE.
- Q. HOW DID YOU MEET WAYNE HURST?

Q. UH, ABOUT MY AGE.

Q. SO DID YOU OR WAYNE EVER TRAVEL TOGETHER?

A. NO. HE HAD HIS CAR AND HE WORKED IN OH, AT A DONUT UH-  
FACTORY MAKING DONUTS.

Q. WHAT KIND OF CAR DID HE HAVE?

A. UH, HIS WAS A, LIKE A FALCON OR SOMETHING LIKE THAT

Q. FORD

A. FORD FALCON

Q. WHAT COLOR?

A. UH, GREENS

Q. SO, AND I KNOW IT'S BEEN A LONG TIME. I KNOW IT'S BEEN A FEW  
YEARS.

A. UH HUH

Q. BUT COULD YOU NOT BE MISTAKEN WHEN YOU SAY YOU WERE NOT DOWN  
IN S.F.L IN 1981?

A. I WASN'T IN FL IN '81

Q. ABSOLUTELY NO DOUBT IN YOUR MIND.

A. ABSOLUTELY SURE I WASN'T THERE.

Q. NOT EVEN FOR A COUPLE DAYS.

A. NO, THAT MUCH I KNOW

Q. WHEN YOU LIVED IN FOMONA, DID YOU EVER WORK IN ANAHEIM?

A. NO

Q. DID YOU EVER LIVE IN ANAHEIM?

A. NO

Q. WOULD THERE BE ANYBODY YOU KNOW WHO DID LIVE THERE?

A. NOT IN ANAHEIM, NO

Q. YOU NEVER LIVED THERE OR HAD AN OPPORTUNITY TO GO DOWN TO  
ANAHEIM?

A. UH UH

- Q. YOU EVER GO TO FLORIDA?
- A. JUST MIAMI, POMONA AND LOS ANGELES, PASADENA AND ONTARIO.
- Q. IF YOU WENT TO LOS ANGELES YOU WENT TO (U)?
- A. I DON'T EVEN KNOW, LISTING IN
- Q. YEAR?
- A. MAYBE. I'M NOT QUITE SURE IF IT WOULD BE OF THE AREA.
- Q. DID YOU EVER WORK IN LOS ANGELES. DID YOU SAY?
- A. NEVER WORKED IN LOS ANGELES.
- Q. YOU LIVED, WE'RE TALKING CITIES NOW, AND YOU LIVED IN LOS ANGELES AT SOME TIME?
- A. NO, JUST TRAVELED IN TO VISIT AT FRIENDS AND THEM, BUT I LIVED IN POMONA ALL THE TIME I WAS IN LOS, IN CALIF.
- Q. OK, WELL, THE WOMAN I'M TALKING ABOUT UN, SAID SHE'S, SHE'D KNOWN YOU FOR MANY YEARS, FROM BEARS, AND THE DAY SHE'S TALKING ABOUT SHE SAID SHE'S CONFIDENT SHE SAW YOU.
- A. I WASN'T, I WASN'T IN FL, AND I, I KNOW I WASN'T IN FL, YOU KNOW. I DEFINITELY KNOW I WASN'T IN FL AT ALL, PERIOD.
- Q. CAN YOU EXPLAIN WHY SHE, IT'S SOMEONE AND SHE KNEW YOU BY NAME TOO.
- A. I HAVE NO IDEA, BUT I DEFINITELY HAVE NOT BEEN TO FL, EXCEPT FOR THAT ONE TIME, YOU KNOW, SINCE I LEFT IN '70 WHEN WE LIVED OUT THERE FOR THE YEAR AND THAT WAS '69 - '71, ABOUT.
- Q. ARE YOU SURE ABOUT THAT?
- A. UM HUH.
- Q. BECAUSE YOU DON'T SEEM SO SURE ABOUT THAT.
- A. IT WAS '69 WHEN WE MOVED OUT THERE.
- Q. I'M TALKING ABOUT, I'M TALKING ABOUT WHAT THIS WOMAN'S SAYING, YOU DON'T SEEM SO SURE ABOUT IT.
- A. I HAVEN'T BEEN IN FL AT ALL, THROUGH EYEBROW FOR THAT ONE YEAR, WHICH WAS '70 AND I HAVE NO IDEA WHY THE HECK SHE WOULD SAY THAT I WAS THERE. I KNOW I HAVEN'T BEEN THERE, JUST THAT I LEFT IN '70 AND THEN WE LIVED BATH POLE AND I, FOR THE ENTIRE YEAR ONLY BEYOND THERE WAS ALMOST I, I GUESS IT WAS 2 MONTHS OR SO, TO BETHANY, ALMOST A YEAR IT WAS. I HAVE NO IDEA WHY SHE SAID I, I WAS THERE, I, I HAVEN'T

BEEN THERE AND I CAN SWEAR ON A STACK OF BIBLES I HAVE NOT BEEN THERE.

Q. I'M JUST CONCERNED WHY THAT SHE WAS SO CERTAIN

A. YEAR

Q. I MEAN I CAN UNDERSTAND IT BEING A LONG TIME NOW.

A. YEAR

Q. AND THAT YOU WOULD BE MISTAKEN BUT OH, SHE WASN'T

A. I, I KNOW I HAVEN'T BEEN THERE SINCE '79. THEN WE MOVED BACK DOWN THERE IN '91

Q. I'M TALKING, I'M TALKING MAYBE JUST FOR A SHORT TIME.

A. NO, NOT AT ALL, JUST THE ONE. WHEN I LEFT IN '79, I DIDN'T GO BACK UNTIL '91 AND I STAYED THERE FOR ALMOST A YEAR AND THAT WAS ALL.

Q. DO YOU REMEMBER GETTING AN ID CARD WHEN YOU WENT BACK TO HLT?

A. YEAH, WE DID GET AN ID CARD I BELIEVE.

Q. WHAT WOULD YOU SAY IF I TOLD YOU THAT WAS 1989?

A. '89?

Q. I CAN UNDERSTAND THAT'S BEEN A LONG TIME, MAYBE YOU'RE GETTING MIXED UP ON DATES A LITTLE BIT.

A. IT MIGHT HAVE BEEN '89 - '90

Q. OH, NOW WE'RE IN 1989. OK, NOW, ARE YOU LESS CERTAIN NOW ABOUT WHAT THE WOMAN SAID SHE SAW?

A. OH, I WAS DEFINITELY NOT THERE IN '91. I KNOW THAT. DEFINITELY WASN'T THERE IN '91. I MIGHT BE WRONG ON THE '89 OR '90 OR '91, YOU KNOW, BUT I DEFINITELY DID NOT GO BACK THERE ONCE I LEFT IN '79. THAT MUCH I KNOW. I'M CERTAIN OF THAT. I DID NOT GO BACK. THAT MUCH I KNOW.

Q. EVEN THOUGH THIS WOMAN THAT SAID SHE KNOWS YOU TAW YOU,

A. SHE SHOULDN'T HAVE SEEN ME BECAUSE I WASN'T THERE.

Q. WHAT KIND OF GLASSES DID YOU WEAR BACK THEN

A. OH, OH, REGULAR

Q. WITH A BLACK FRAME?

A. NO, THEY WERE ONLY LIKE DOWNY
