A. They took us to Baltimore.

Q. How did they get you there?

A. A car.

Q. A car or a truck?

A. A truck I think it was.

Q. After your grandmother's death is that when you first went to the west coast to California or....

Q. You didn't go to Maryland until later on is that correct?
