This statement is commencing on Tuesday January 26, 1982 at approximately 11:57 a.m.

A. The first contact I had was approximately on the third day of Adam Walsh missing, I called the Hollywood Police Department and asked to speak to a detective pertaining to the Adam Walsh case and then they connected me and a gentleman got on the phone by the name of Jim Campbell, introduced himself to be a relative of John Walsh's and I didn't proceed to ask him if he was a detective or whatever because I just assumed that he worked somewhere around here.

Q. Do you know what time of the day this call was?

It had to, I'm thinking it was before noon, early noon.

Q. Okay what did you inquire from Mr. Campbell?

A. I told him that I had seen Adam Walsh's picture on the T.V. and this has never happened to me before and I really didn't understand what was going on, but I wanted to call up and assure everybody that he was still alive.

Q. Can you explain to us that this has never happened to you before, transpired to you causing you to make this phone call?

A. Well after I saw his picture on the T.V. I just got a certain feelings about the child that I really couldn't explain so I figured that it would be better if I just called down here and I just tell them that the child was alive, it was certain, I knew that the child was still alive even though I hadn't known any history about it, I really didn't know that he had been taken by the Mall, I just saw, I don't know I just saw his picture on T.V.

Q. Did you ever have these feelings at previous times ?

A. No, first time.

Q. What did Mr. Campbell relate to you then?

A. Mr. Campbell related to me that he needed. he needed all the help he could get. he never mentioned the detectives or the police department here and I told him that Adam Walsh was taken out of the mall by someone that he knew, a friend, and that this person had never done this before and the person had never committed a crime or anything and all he wanted to do was be his friend, and that no harm would come to the child unless the person was backed against the wall and Jim Campbell said that any time that I have this information quote-unquote, be sure that I talk to him and don't talk to anyone else.

Q. But he told you personally that you shouldn't speak to anyone in the Hollywood Police Department other than himself?

A. Right and he told me any time that I called there to leave my name and leave a message he would get right back to me.

Q. That was the third day of the investigation?

A. This was the third day.

Q. Do you know what time of the day it was?

A. It was early afternoon when I called the first time.

Q. Did he indicate to you why he only wished you to speak to him and no one else?

A. No I just thought he was really on top of this that he was the major leader, so called leader of this massive hunt, and that he would be the top, thats the impression that he gave me, you know that he was in charge.

Q. You furnished him with your name and telephone number where you could be reached?

A. Right, he never asked for my address.

Q. Then what was the next time you had contact with him?

A. He called me back in about, I think it was less than an hour, he called me back up and he wanted to know if I had any more feelings, I said I just got off the telephone with you, but the more that I talked to the man, the more I could feel something, I even explained to him, I told him Jim Campbell its most as if I'm in his mind and I said I don't know if you can relate that and he said that he could understand what I was talking about and probably

only he could know what I was saying.

Q. He felt that nobody else would understand you?

A. Yeah.

Q. Did you ever tell Mr. Campbell at this time, your first conversation that you had a description of the suspect that may have abducted Adam?

A. No, no I didn't have it at that time, but I did discuss with Jim Campbell that the boy was not forced out of the mall that he was taken out of the mall by his friend and that the person wouldn't hurt him he just wanted him, he just wanted the child, and not to back him against the wall and don't have too much publicity, that was our main conversation. Every time he called me he tried to drill me.

Q. What do you mean he tried to drill you?

A. He tried to like pump me for information, almost as if, it was like, he wanted me to do some talking as if to give him ideas.

Q. Mrs. Gordon the duration of the conversation was it three minutes, five minutes, ten minutes?

A. Oh he stayed on the phone as long as I would you know he never hung up on me, he just, he was very calm, cool and collected, just like lingered there.

Q. Did he ever say to you well thats all I, thats all?

A. No uh uh I always said theres nothing I can tell you, theres nothing re to tell and he said, I can use all the help that I can get and if you have anything please call me immediately and I will stay in touch with you.

The next time he called me was that night again, he called me three times that day, and it was merely the same conversation, and the more that I talked to the man, the more I was get out of the feelings that I, the more that I would talk to him the more I would feel and right after I got off the telephone with him I used to get certain vibrations like danger you know and stuff like this it was really amazing and when he called me up on the phone the third time I just told him that everything was about the same that you know they could not find the boy in the area that they were looking and I even told him on the telephone don't bothr looking out in the everglades or whatever, because the man does not intend to hurt him at the time and he told me I was right. he said I feel that your right, but, if I would have known more about who I was working with it probably would have hit me sooner.

Q. Then what occurred when was the next time?

A. The next time he called me the following morning and I think I just reemphasized what I had told him the other conversations, I really, I couldn't really get anything until after I hung up the phone with him and I remember the last time, the last time that I talked to Jim Campbell it was in the morning and that night, I got, it was very unusual that this happened, I could see a dark area and hammering, very loud hammering and just like when your in the dark and you see pieces of wood in front of you you can see

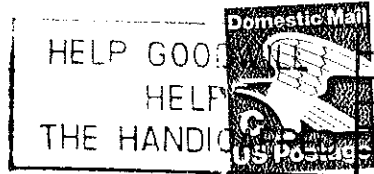
