Dear Commissioner Moore:

Our office has been assisting the Hollywood Police Department in the continuing investigation into the murder of Adam Walsh that occurred in July, 1981. Recently information has come to us indicating that some violent activity in connection with the murder of Adam Walsh may have occurred on a wooden foot bridge located at mile marker 174 of the Florida Turnpike. This location is just north of the Fort Pierce exit in Indian River County. Access to the foot bridge is from the shoulder of the northbound lane of the Florida Turnpike at the aforementioned mile marker.

Recent information uncovered indicates that there may exist blood evidence on this foot bridge. Although it has been fifteen (15) years since the homicide of Adam Walsh we feel that we must investigate the possibility that such blood evidence may still be recoverable. Therefore Since FDLE has already assisted the Hollywood Police in serology work connected with this case we are again asking your assistance in examining the foot bridge.

It is our understanding that Senior Crime Lab Analyst Ted Yeshion of the Tampa Regional Crime Laboratory has vast expertise in the use of luminal and in recovering blood evidence that has been deposited and left for A long periods of time. In addition if

such evidence is recovered there would be additional lab work in the form of DNA examinations required which we understand Mr. Yeshion is also quite capable of conducting.

If you agree to assist our office and the Hollywood Police Department in the search of the evidence at the foot bridge would you kindly make arrangements to have Mr. Yeshion contact State Attorney Investigator Phil Mundy (954-831-6368) so that they can coordinate their efforts.
