HUNTSVILLE, Texas — Hen-Ty Lee Lucas, a convicted killer who figured prominently in the kidnapping and murder investigation of 6-year-old Adam Walsh mearly 20 years ago, has died in orison. He was 64.

Lucas was best known for making numerous confessions that prompted law officers nationwide to clear hundreds of unsolved killings. At one point, he confessed to more than 600 murders — then recanted them all.

Prison officials in Huntsville said Lucas was found dead in his bed Monday night at the Ellis I prison unit where he was serving sentences for nine murders, the Texas Department of Criminal Jüstice said. The one-eyed drifter and former mental patient was narrowly saved from execution three years ago when then-Gov. George W. Bush commuted a death sentence to life in prison because of flimsy evidence in his capital case. After the commuta-

Two weeks after Adam's disap pearance two fisherman found the boy's severed head floating in a canal near Vero Beach. The body was never found.

Toole, who was serving a life sentence on an unrelated Florida arson and murder charge when he died four years ago, was never charged with the murder of Adam. But he remained a prime suspect because blood was found on the floor of his 1971 Cadillac and on the machete he told Jacksonville police he used to cut off Adam's head. Toole was 49 when he died of cirrhosis of the liver at Union Correctional Institution in Raiford in September 1996.

Adam's father, John Walsh, went on to create the television show, America's Most Wanted, which is dedicated to tracking down fugitives.

## Henry Lee Lucas, convicted murderer and figure in Adam Walsh case, dead at 64 in Texas

A DNA link was never established, however, and key evidence was lost by police. Hollywood Police also learned that Toole might have been fed specific details about the Walsh murder by a Jacksonville detective who hoped to profit with a book deal.

Toole was 49 when he died of cirrhosis of the liver at Union Correctional Institution in Raiford in September

Adam's dad, John Walsh, went on to found the television show, *America's Most Wanted*, which is dedicated to tracking down fugitives.

Larry Fitzgerald, a spokesman for the state prison system in Texas, said Henry Lee Lucas' death appeared to be from natural causes. Lucas had a history of heart problems and had been hospitalized in the last two months.

Fitzgerald said Lucas' body was taken to the Huntsville Funeral Home, where it will be determined whether there are relatives who want to claim the remains.

Lucas' confession spree prompted authorities to clear their books of more than 600 unsolved killings -- but he later recanted. Many murder cases were never reopened.

Bush in 1998 commuted the death sentence of Lucas four days before the Death Row inmate was scheduled for lethal injection in the 1979 slaying in Williamson County of an unidentified woman known only as "Orange Socks."

In recent years, Lucas insisted he committed just one murder, killing his mother in Michigan in 1960 -- a crime for which he served time in prison and a Michigan mental hospital. Besides the life term for the Orange Socks killing, Lucas had six other life sentences and 210 years in prison for three other slayings.

In 1999, Lucas told reporters he had become fascinated by Rafael Resendez-Ramirez, the fugitive authorities had since connected with at least eight slayings in Texas, Kentucky and Illinois.

"If this was 1983," Lucas told the *Houston Chronicle* at the time, "I'd claim these murders, too ... I made the police look stupid. I was out to wreck Texas law enforcement."

Fitzgerald said that Lucas had been in state custody since 1985 and spent most of his time working as a sewing machine operator in a garment factory that produces trousers for correctional officers' uniforms.

"He spent all of his time running the sewing machine," he said. "He was our best."

After the death of Ottis TOOLE on September 14, 1996 Henry Lee LUCAS began making statements to the news media regarding the Adam Walsh murder. The purpose of this investigative memo is to place on the record the response to LUCAS' claims.

LUCAS was originally questioned about the Adam WALSH murder on December 6, 1983 by Det. J. HOFFMAN and Lt. J.B. SMITH and LUCAS denied any knowledge of the crime.

To our knowledge LUCAS remained silent on the WALSH murder until April 1996 when at his request a telephone interview between LUCAS and Det. Mark SMITH was arranged. LUCAS' claims in that statement were compared to known facts and it was concluded by both Det. SMITH and this investigator that he was lying. Some of the more pertinent assertions in his statement are:

a) He and TOOLE drove in a northwest direction from the mall for about twenty to twenty five miles to the location where the body was. At that location TOOLE told him the boy's head was in a nearby canal.

FACT: According to TOOLE he took a southwest route from the mall. The distance to where the victim's head was found is about 120 miles and approximately a two hour drive.

b) The body was underneath some brush and the boy's genitals had been cut off and TOOLE had them in a pint jar and displayed them to LUCAS.

FACT: LUCAS approximates his viewing of the body as around mid-November relating the date to the death of Toole's sister Drucilla Arzetta Carr. Normal decomposition from July to November would have made it impossible for LUCAS to even be able to discern the sex of the body. The same is true for any body part that TOOLE would have kept in a jar.

- c) There were maggots and flies on the body.
- FACT: After four months the cycle of flies and maggots would have been completed.
  - d) He saw a birthmark on the right side of the body.

FACT: The condition of the body after four months in the open air would have made such an observation impossible.

There are some statements made by LUCAS that indicate he had some knowledge of the crime by the time he gave Det. SMITH the 1996 statement. By this time LUCAS could have gained the information from TOOLE or news sources. However, on the specifics, especially concerning the condition of the body, he is obviously lying.

On October 2, 1996 WSVN-Channel 7 aired their interview with LUCAS and the statements LUCAS made in that conversation that can be compared with case facts are:

a) Adam WALSH knew TOOLE because TOOLE had done work for John WALSH.

FACT: Mr. Walsh did not know OTTIS TOOLE.

b) When LUCAS saw the body it was not totally decomposed.

Dr. Price of the Broward County Medical Examiner's Office was consulted regarding the condition of the body and concurs with the facts stated herein.

A video copy of the WSVN broadcast was made and will be retained in the investigative case file.

Henry Lee LUCAS is currently on death row at the Texas State Prison in Huntsville, Texas. When he contacted Det. SMITH in April, 1996 TOOLE was still alive but it is suspected that LUCAS may have been looking for some way to delay his execution and perhaps obtain a trip to Florida which might have afforded him a chance to escape. His assertions after the death of TOOLE seem to have the same motive as well as affording him a great deal of publicity. Prison officials in Huntsville said Lucas was found dead in his bed Monday night at the Ellis I prison unit where he was serving sentences for nine murders, the Texas Department of Criminal Justice said. The one-eyed drifter and former mental patient was narrowly saved from execution three years ago when then-Gov. George W. Bush commuted a death sentence to life in prison because of flimsy evidence in his capital case. After the commuta-



A DNA link was never established, however, and key evidence was lost by police. Hollywood Police also learned that Toole might have been fed specific details about the Walsh murder by a Jacksonville detective who hoped to profit with a book deal.

Toole was 49 when he died of cirrhosis of the liver at Union Correctional Institution in Raiford in September 1996

Adam's dad, John Walsh, went on to found the television show, *America's Most Wanted*, which is dedicated to tracking down fugitives.

Larry Fitzgerald, a spokesman for the state prison system in Texas, said Henry Lee Lucas' death appeared to be from natural causes. Lucas had a history of heart problems and had been hospitalized in the last two months.

Fitzgerald said Lucas' body was taken to the Huntsville Funeral Home, where it will be determined whether there are relatives who want to claim the remains.

Lucas' confession spree prompted authorities to clear their books of more than 600 unsolved killings -- but he later recanted. Many murder cases were never reopened.

Bush in 1998 commuted the death sentence of Lucas four days before the Death Row inmate was scheduled for lethal injection in the 1979 slaying in Williamson County of an unidentified woman known only as "Orange Socks."

In recent years, Lucas insisted he committed just one murder, killing his mother in Michigan in 1960 -- a crime for which he served time in prison and a Michigan mental hospital. Besides the life term for the Orange Socks killing, Lucas had six other life sentences and 210 years in prison for three other slayings.

In 1999, Lucas told reporters he had become fascinated by Rafael Resendez-Ramirez, the fugitive authorities had since connected with at least eight slayings in Texas, Kentucky and Illinois.

"If this was 1983," Lucas told the *Houston Chronicle* at the time, "I'd claim these murders, too ... I made the police look stupid. I was out to wreck Texas law enforcement."

Fitzgerald said that Lucas had been in state custody since 1985 and spent most of his time working as a sewing machine operator in a garment factory that produces trousers for correctional officers' uniforms.

"He spent all of his time running the sewing machine," he said. "He was our best."
