A LETTER WAS RECEIVED FROM A SUBJECT, BEING ANTHONY SAVAGE (WHITE MALE, 03/08/66), AN INMATE AT THE FEDERAL CORRECTIONAL INSTITUTION IN MARIANNA, FL.

SAVAGE STATES HE IS INCARCERATED FOR DRUG TRAFFICKING IN MARIJUANA. HE SAID IN HIS LETTER THAT AT ONE TIME HE WORKED FOR THE BAZZANO FAMILY, AND SAVAGE WAS INVOLVED WITH DRUG TRAFFICKING WITH THEM. HE IS WRITING THIS LETTER BECAUSE OF THE ADAM WALSH BOY. SAVAGE STATES HE KNOWS THE PLACE THE BOY WAS KILLED, WHY, AND WHO DID IT.

02/17/99 AT 0830 HRS

CONTACT WITH THE FEDERAL CORRECTIONAL INSTITUTION WAS MADE, AND IT WAS CONFIRMED THAT ANTHONY SAVAGE (REGISTRATION #30846-004) WAS INCARCERATED FOR THE OFFENSE OF POSSESSION OF MARIJUANA WITH INTENT TO DISTRIBUTE. THE OFFENSE WAS IN AUGUST 1994 AND SAVAGE WAS CONVICTED IN JUNE 1996.

02/19/99 AT 1450 HRS

IN THE CONTINUING INVESTIGATION, THE ARRESTING AGENCY WAS FOUND TO BE THE UNITED STATES CUSTOMS. AGENT LARRY SAPP OF SAVANNA, GA (PHONE #(912)652-4344) WAS THE ARRESTING OFFICER.

AN INTERVIEW OF AGENT SAPP ON THE ABOVE DATE AND TIME REVEALED THAT ANTHONY SAVAGE WAS NOT A KEY PLAYER IN THE ARREST MADE IN THIS CASE. SINCE THE ARREST AND CONVICTION OF SAVAGE, HE HAS GIVEN INFORMATION ON CRIMINALS SEVERAL TIMES WHERE THE INFORMATION WAS NOT GOOD. AGENT SAPP STATES THAT SAVAGE'S ASSOCIATES REFER TO HIM AS PINOCCHIO, DUE TO HIS HABITUAL LYING.

09/23/99 AT 0830 HRS

THIS OFFICER MET WITH ANTHONY SAVAGE AT THE FEDERAL CORRECTIONAL INSTITUTION IN MARIANNA, FL. SAVAGE TOLD THIS WRITER THAT APPROXIMATELY 1986 HE WAS AT SUBJECT ROBERT "ROCK" BAZZANO'S RESIDENCE IN COOPER CITY. HE DESCRIBES THE RESIDENCE BEING NORTH OF STIRLING RD AND SOUTH GRIFFIN ROAD, JUST OFF OF 100TH AVE. PRESENT WAS HIMSELF, SUBJECT "ROCK", A WHITE MALE KNOWN AS GEORGE (IN HIS SIXTIES), SUBJECT KNOWN AS "CRAZY BILLY" (WHITE MALE, LATE THIRTIES), A SUBJECT JIMMY (LATE THIRTIES). A SHIPMENT OF COCAINE HAD COME IN AND BILLY IS THE PILOT THAT SMUGGLED THE COCAINE. GEORGE ASKED JIMMY HOW MANY KILOS WERE

BROUGHT TO WILLIE. JIMMY SAID WILLIE WAS SLOW AT PAYING FOR THE COCAINE. GEORGE WAS MAD, AND SAID, "I'LL KILL HIM".

THE JOHN WALSH T.V. SHOW WAS ON AT THE TIME AND GEORGE REFERRED TO JOHN WALSH AS TAKING DRUG MONEY THAT WAS BEING LAUNDERED AT THE HOTEL IN THE BAHAMAS, WHERE JOHN WALSH WAS WORKING.

GEORGE THEN SAID HE WOULD KILL WILLIE NELSON'S KID LIKE THEY KILLED ADAM WALSH.

THE CONVERSATION CONTINUED FOR A PERIOD OF TIME. THE CONVERSATION PROCEEDED AND TOWARDS THE END OF THE INTERVIEW, THIS DETECTIVE ASKED ANTHONY SAVAGE HOW DID THIS RELATE TO GEORGE AND ADAM WALSH'S DEATH. SAVAGE THEN ADDS THAT IN THE CONVERSATION WITH THE AFOREMENTIONED PARTIES PRESENT, GEORGE TOLD HIS BODY GUARD, WHO WASN'T PREVIOUSLY IDENTIFIED AS BEING THERE, "BECAUSE OF YOU THEY FOUND PARTS OF THE BODY", AND JOHN WALSH IS MAKING MONEY ON TV. SAVAGE REFERRED TO THIS AS BEING STATED IN CONNECTION WITH THE ADAM WALSH DEATH. SAVAGE SAID THAT THE BODY GUARD IS A WHITE MALE, 7'0 TALL. SAVAGE REFUSED TO GIVE A TAPED STATEMENT.

SAVAGE STATES THAT HE NEVER SAW JOHN WALSH, BUT HIS WIFE WORKED OUT AT THE APOLLO GYM LOCATED AT 441 IN THE NORTHERN AREA OF HOLLYWOOD. MR. SAVAGE MADE NO MENTION AS TO THE PLACE WHERE THE VICTIM WAS KILLED, ALTHOUGH IN HIS LETTER HE STATED THAT HE KNEW THE PLACE WHERE THE CHILD WAS MURDERED. THE INTERVIEW CONCLUDED AT 1000 HOURS.

10/21/99 AT 1000 HRS

ASSIGNED CONTACTED DETECTIVE V. SINGLETON, OF THE HOLLYWOOD POLICE DEPARTMENT. DETECTIVE SINGLETON WAS BRIEFED ON THE INTERVIEW OF ANTHONY SAVAGE. INTELLIGENCE WOULD BE DONE ON THE BAZZANO NAME.

10/27/99 AT 0845 HRS

DETECTIVE SINGLETON CONTACTED THIS WRITER. BAZZANO IS NOT A KNOWN ORGANIZED CRIME FAMILY. A ROBERT BAZZANO IS MENTIONED IN A METROPOLITAN INTELLIGENCE UNIT REPORT. ROBERT BAZZANO'S DATE OF BIRTH IF 02/07/51, AND RESIDES AT 10168 SW 52ND ST, COOPER CITY. ROBERT BAZZANO'S WIFE IS JUDITH WITH A DATE OF BIRTH OF 07/28/52.

METROPOLITAN INTELLIGENCE UNIT REPORTS

ON 01/19/89, A REQUEST WAS MADE ON A SUSPECTED DRUG DEALER SAL BAZZANO, WHO OPERATES "PAMPER ME HAIL SALON" SOMEWHERE IN PLANTATION.

M.I.U. REPORTS YIELDED NEGATIVE RESULTS, AND AS DID F.B.I.

AND D.E.A. INQUIRES. SEBASTIAN BAZZANO, WHITE MALE, DATE OF BIRTH 07/02/28 OF 10168 SW 52ND ST, COOPER CITY, WAS FOUND THROUGH VOTER'S REGISTRATION. ROBERT BAZZANO, AND JUDITH BAZZANO ARE LISTED AS RESIDING AT THIS ADDRESS AS WELL.

ON 06/02/89, A M.I.U. REPORT STATES A REQUEST FROM PLANTATION POLICE DEPARTMENT WAS MADE REQUESTING INFORMATION IN REFERENCE TO "PAMPER ME BEAUTY SALON" OPERATED BY SEBASTIAN AND JUDITH BAZZANO. TWO WHITE FEMALE EMPLOYEES WERE CHARGED WITH COCAINE VIOLATIONS, BEING POSSESSION AND DELIVERY OF COCAINE.

ON 03/08/91 A M.I.U. REPORT REFLECTS THAT DANIEL RICCIARDI, A LUCCHESI CRIME FAMILY ASSOCIATE, TELEPHONED THE "PAMPER ME NAIL AND FASHION BOUTIQUE" OF 1915 N PINE ISLAND RD, PLANTATION. THE OWNER IS SEBASTIAN A. BAZZANO OF 10168 SW 52ND ST, COOPER CITY. A SAL BAZZANO IS LISTED ON CORPORATION RECORDS, BUT NO IDENTIFIERS COULD BE FOUND.

IN THE M.I.U. REPORTS NO MENTIONED OF ANTHONY SAVAGE IS MADE, CONNECTING SAVAGE WITH BAZZANO. A CHECK OF ANTHONY SAVAGE'S CRIMINAL HISTORY AND ROBERT BAZZANO'S CRIMINAL HISTORY REVEALED NO MATCHING ARREST ON FILE.
