- A. He never discussed anything about travelling anywhere. All he ever, well he discussed that he ah that he had been to Bakersville, California and that he was living out there with an old lady, him and LUCAS and that he had not left there too long when he came here and ah that's all I remember. And then he told me one time that he had been in jail for auto theft.
- Q. Did he ever discuss that he was ever in the South Florida area, Miami Fort Lauderdale?
- A. No, only thing he ever talked anything about was that he had a brother or sister that run a junk yard in Daytona.
- Q. Did you ever have the opportunity to meet HENRY LUCAS?
- A. Yes.
- Q. And was that through OTTIS you met him?
- A. OTTIS had been working here three or four months and one day just out of a blue sky, LUCAS came in. I don't know where he came from but OTTIS seemed to be awful glad to see him and he said that was his best friend.

- A. Yes that was a month or so before, say two months before my house got burned here in '82, of January of '82.
- Q. Your house was burnt down in '82?
- A. Yes.

me on the phone and he told me, he said I didn't burn your house mom, he called me mom all the time.

- Q. Was it ever proven that ah he was the one who burned your house?
- A. Ah I said OTTIS, I said LUCAS in Texas told the police that he waited in a car for you to come in and throw gasoline on the house and set afire. And he said I didn't do that, he said I burnt the mission, I burnt the train terminal and I burnt Jones, old Jones Business college downthere and he said but I did not burn your house.
- Q. Did OTTIS ever discuss any murders with you?
- A. No he didn't discuss anything about no murders.
- Q. Okay at any time did OTTIS ever store any vehicles here on your property?
- A. After LUCAS came here he had ah, he went and him and LUCAS went out and bought some kinda car, at Spencers and then they started riding, every night they would get out and ride every night, you'd see 'em here and there you know riding in that car and they bought at Spencers.
- Q. Do you know what kind of car it was, the make?
- A. I think the first one they bought was a brown state on wagon but I'm not, I wouldn't be positive about it and then they went out one weekend and then they came in with a different car which was ah, a Torino or something that I believe that he said.
- Q. But this would all be in the fall of '81 after LUCAS arrived?
- A. Right. The last part, he was here during Christmas and ah about that time yes.

- Q. Okay is there anything else you would like to add to your statement at this time before we concluded it?
- A. Well he also, when he called me from the county jail, he admitted that he was with LUCAS the night that they went out to the motel and ah, said LUCAS went in the motel and killed the man and his wife and he was sittin in the car waitin on him and he said he came running out with a funny laugh and said ah, come on in I want to show you something and he said, he told him no, he said I'm not goin in, I don't want to see it, said LUCAS done things that made him sick after he killed people and he said that that job was done for a robbery deal. The second thing he told me, he said the girl

that got killed, I believe it's Ferdindina Beach, he said the police wondered how that car got over the top of her whenever ah, whenever they found her the car was sittin over top of her. He said LUCAS killed the girl and said they had a green pickup truck and he said they took that truck and pushed another car over the top of her body, he said that's how the car got there.

- Q. No since he's been in the county jail over here have you spoken to him on occasion?
- A. He calls here and ah he called the last time, the last time he called was a few days ago and he was cryin and he said his people had turned him down, nobody would come see him, nobody would buy him a pack of cigarettes and nobody would do anything to help him.
- Q. Approximately how many times have you spoken to him since he's been in the county jail?
- A. Oh I'd say about probably six times since he came from Raiford.
- Q. During those six times, the conversations you've had with him, has he ever mentioned the ADAM WALSH murder case to you?
- A. He, he called me a few days ago and he started talking to me and the county, I guess the county jail cut him off. He said Jacksonville Police or Sheriff's department down there had falsley accused him, said he had been killing people since he was fourteen years old and he said that was lie that he never killed those people when he was fourteen years old.
- Q. Okay.
- A. He said they kinda blame him with alot of things or put alot things on him that was false and bout that time the phone cut off, I didn't get the

- He has never said anything about it.

I didn't know that's what it was gettin down to you know when he called me I never knew that he was relating to that you know and like I said the jail seemed to have cut him off and he ah, I understood he was in a jail cell by hisself and why they cut him off from talking to me I don't know. But I could get all the information you wanted to know pretty well if I ever could talk to him long enough but they just won't seem to let him stay on the phone but a few minutes.
- 0. Does OTTIS trust you?
- Α. Yeah.
- Q. Okay.
- Ah but that's one thing that I kinda felt let down about, about all these murders and he's been sittin up here all these times and he's never let on in the least that he would do anything like that. He even told me I don't kill anybody, I would never kill anybody, but the only thing I ever heard him say, you know he would get kinda mad with somebody, he said well I just kill him and throw him in an old condemned house and set it afire and that would be the end of it and I thought it was just talk you know.
