For my particular investigation at that time I stopped the interview and I was putting my recorder away. Toole, Toole asked me, he asked me if uh, are you from Fort Lauderdale and I replied no that I wasn't. Toole asked me, are you sure, and then I explained to him, as the last hour, because I had talked to him a short period of time, it would be roughly an hour all total the last hour all we could talk about was the (unintelligible) When I went in there, when I introduced myself as an investigator from Brevard County uh so then I asked him, are you expecting someone from Fort Lauderdale and Toole said yeah, yeah I am. I asked him then I said uh, did you get into something there and Toole said yeah, yeah I did. I didn't really pursue the question but he's the one that brought up Fort Lauderdale. be to my advantage not to pursue the question. I really felt that it would

- And basically that's all he said to me about Fort Lauderdale. thing was that the interview we had had prior to this statement that he made to me, he admitted to me several murders. At one time he stated to me he committed 65 murders, some of them he laughed about. There was no remorse, no emotion during this particular session we had. When we started talking about Fort Lauderdale, or when he started talking about Fort Lauderdale, he completely changed. Prior to this he'd look me straight in the face and at one time this one particular murder he was talking about in Tampa that he actually laughed about, but when he talked about Fort Lauderdale all of a sudden he shifted, started looking to the floor, he started disputing about. His whole body just totally changed, his whole demeanor changed. The expression on his face, now he's looking everywhere but at me, and I felt with him changing the way he did that there had to be something involved in it. Now also prior to this, we didn't go into any great detail about it but I was aware of the fact that some of his victims and I'm not sure how many, had been dismembered or decapitated. All of them weren't but some of them were, keeping that in mind and keeping in mind what had occurred to Adam Walsh, that's how I related to it. He never mentioned Adam Walsh's name to me and I can only assume that he just got me confused with Broward County.
 - Q. You've been an investigator for a few years, you indicated this change in Ottis' demeanor when you interviewed him, did that mean anything to you?

- A. No, he never mentioned his name nor did I mention the name.
- Q. All he wanted to know was if you were from Broward County, that was his main concern?
- A. Fort Lauderdale.
- Q. Fort Lauderdale he mentioned?
- A. Yes he did.
- Q. He also admitted that he did expect somebody from the Fort Lauderdale area when you mentioned that to him that you were from Brevard County?
- A. Yes he did.
- Q. Is there anything else that occurred during that interview when you were in contact with Mr. Toole?
- A. No Sir.
- Q. I have no other questions to ask you at this time Steve. Has everything you've said in your statement been the complete truth as you know it to be?
