Tuesday, February 25, 1986, this detective received a telephone call from Assistant Administrator, Dennis Williamson, from the Florida Department of Law Enforcement (904-488-1040). Mr. Williamson informed this detective that the Las Vegas Police Department had recently arrested a white male by the name of Keith Allen Warren, DOB 7/15/58, for an Attempted Murder. Mr. Williamson further informed this detective that the victim in the Attempted Murder was left for dead in a remote area in Las Vegas by the suspect. According to Mr. Williamson, the suspect attempted to decapitate his victim, using a large, sharp bladed instrument. However, the victim survived this attack and Keith Allen Warren was arrested and charged with Attempted Murder.

Mr. Williamson furnished this detective with the investigative detective from Las Vegas, that being; Russell Shoemaker (702-386-3111). This detective then made telephone contact with Detective Russell Shoemaker of the Las Vegas Police Department. Detective Shoemaker informed this detective that Keith Allen Warren was arrested on February 2, 1986 for the Attempted Murder of Jack Taylor, W/M, 15 years old. Detective Shoemaker related that the victim had been hitchhiking and was picked up by Keith Warren. The victim was then driven to a remote area in Las Vegas, at which time Keith Warren displayed a large knife and forced the victim to disrobe. Keith Warren then sexually assaulted the victim and also cut locks of hair from the victim as a possible symbolic gesture. Keith Warren then

proceeded to cut the victim's throat with this large knife and then attempted to decapitate the victim by using this knife and hacking at the rear of the victim's neck. Detective Shoemaker indicated that Keith Warren is definitely a homosexual and that his criminal offenses appear to be all homosexual related.

When Keith Warren was interviewed by Detective Shoemaker, Warren spoke of similar murders that he has alleged to commit in the following states: Florida, Texas, St. Louis and New Hampshire. A criminal background check of Keith Allen Warren was completed with the following results; 10/6/76, arrested by New Hampshire Police Department, 10/26/77, arrested by Phoenix, Arizona Police Department, 3/15/78, arrested by Phoenix, Arizona Police Department, 10/18/78, arrested by Manchester, New Hampshire Police Department, 3/2/81, arrested by Tampa, Florida Police Department, 7/3/85, arrested by Phoenix, Arizona Police Department, and 8/19/85, arrested by Las Vegas Police Department. Detective Shoemaker informed this detective that the Public Defender representing Keith Warren is a Doug Smith (702-386-4685). This detective then telephoned the Public Defender's Office in Las Vegas and spoke with Mr. Doug Smith. Upon informing Doug Smith of this Agency's investigation, he advised that he did not have any objections of this Agency interviewing Keith Warren, as long as our interview was restricted to offenses occurring in Florida and not the present charges that Mr. Warren was facing in Las Vegas.

From 1979 through 1982, he was employed at the Coral Grill, Islamorada, Florida. For personal references, Mr. Warren listed a Denise Jurzyh of 3101 Houston Street, Ft. Lauderdale, (791-0189). He also listed a Donald Stearns of Springstreet, Colorado. While employed at the Coral Grill in Islamorada, Mr. Warren owned and operated a 1972 Ford Pinto.

Tuesday, 3/18/86, this detective along with Sgt. Wynn of the Homicide Division, traveled to Las Vegas, Nevada to interview Keith Allen Warren. Upon arrival in Las Vegas, this detective and Sgt. Wynn met with Det. Shoemaker of the Las Vegas Police Department. After being briefed by Det. Shoemaker, this detective and Sgt. Wynn, along with Det. Shoemaker, proceeded to the Clark County Jail.

At 3:40 P.M. Las Vegas time, a taped interview was conducted with Keith Allen Warren by Det. Hoffman and Sgt. Wynn. Also present was Det. Shoemaker. In this taped interview, Keith Allen Warren indicated that he was born in New London, Connecticut on July 15, 1958. From there his family moved to Andover, Massachusetts, where his mother and father presently reside. His mother's name is Claire Drivas and his father's name There was a total of five (5) children in the family with is Frank Warren.

Keith being the second youngest child. His mother and father are presently divorced and he believes his father is presently living in Arizona. father was a career military man and is presently retired from the United States Coast Guard. Mr. Warren indicated that his father had sexually assaulted him when he was a young boy. Keith Warren indicated that he started running away from home at the age of nine or ten because his father was extremely strict with him. Keith Warren states that he realized he was homosexual at an early age and did not date any females throughout his high school education and adult life.

When this detective and Sgt. Wynn spoke with Mr. Warren about any other possible homicides that he may have committed in other states, Warren responded that he did commit a murder in Monroe County, Florida, Texas and a city in northern Florida. Mr. Warren stated that all his victims were white males and were at least fifteen years old and older. Mr. Warren further stated that he had no relationships with young children or any females. When this detective spoke to Mr. Warren about the Adam Walsh homicide, he indicated that he read about it in the newspapers but he believes he was living up in Massachusetts at the time when this occurred. This detective then asked Mr. Warren that if he was responsible for the Adam Walsh homicide, would he confess to it, at which time he indicated that if he had committed that homicide, he would freely speak to these detectives about it. Wednesday, 3/26/86 at 1100 hours, this detective, along with Sgt. Wynn, met with W/F, Denise Jurzyh, DOB 1/5/31, who resides at 3101 Houston Street, Lauderdale, telephone number 791-6965. Ms. Jurzyh was informed of this Agency's ongoing investigation, at which time she informed the aforementioned detectives that she did know the subject, Keith Allen Warren, who resided with her sometime in 1981. Ms. Jurzyh informed this detective that her husband passed away on October 16, 1981 and that was when she first met Keith Warren in Connecticut. Keith Warren drove back to Florida with Ms. Jurzyh and lived with her at her Ft. Lauderdale residence in 1982. While Keith resided with Ms. Jurzyh, she indicated that he worked at a Denny's Restaurant somewhere in Ft. Lauderdale. Keith resided with Ms. Jurzyh for approximately eight months and then moved away in the Summer of 1982. Ms. Jurzyh last saw Keith in March 1984. Ms. Jurzyh went on to inform the aforementioned detectives that while Keith was residing at her residence, she went into his bedroom when he was not at home and noticed

that Keith had collected newspaper clippings of mass murderers who had been arrested and had been recently written about in the newspapers. When Ms. Jurzyh confronted Keith about these newspaper clippings, he mentioned that he was considering writing a paper about mass murderers.

This detective then recontacted Det. Owens of the Monroe County Sheriff's Department to speak to him about any unsolved homicides in his jurisdiction that Keith Allen Warren mentioned to the aforementioned detectives while out in Las Vegas. Det. Owens indicated that they did not have any unsolved homicides during the time that Keith Warren was living and working in Monroe County. A check with cities located in northern Florida having any possible unsolved homosexual homicides during the time that Keith Allen Warren may have been in their jurisdiction met with negative results.

At the time of this supplemental report, this detective does not have any reasons or evidence that may link Keith Allen Warren to the Adam Walsh homicide. It is further this detective's opinion that if Mr. Warren had been responsible for Adam Walsh's murder, he would probably have confessed to it.
