- Q. Can you explain to us that this has never happened to you before, transpired to you causing you to make this phone call?
- A. Well after I saw his picture on the T.V. I just got a certain feelings about the child that I really couldn't explain so I figured that it would be better if I just called down here and I just tell them that the child was alive, it was certain, I knew that the child was still alive even though I hadn't known any history about it, I really didn't know that he had been taken by the Mall, I just saw, I don't know I just saw his picture on T.V.
- Q. Did you ever have these feelings at previous times ?
- A. No, first time.
- Q. What did Mr. Campbell relate to you then?
- A. Mr. Campbell related to me that he needed. he needed all the help he could get he never mentioned the detectives or the police department here and I told him that Adam Walsh was taken out of the mall by someone that he knew, a friend, and that this person had never done this before and the person had never committed a crime or anything and all he wanted to do was be his friend, and that no harm would come to the child unless the person was backed against the wall and Jim Campbell said that any time that I have this ingreation quote-unquote, be sure that I talk to him and don't talk to anyone lelse.

- Q. Mrs. Gordon the duration of the conversation was it three minutes, five minutes, ten minutes?
- A. Oh he stayed on the phone as long as I would you know he never hung up on me, he just, he was very calm, cool and collected, just like lingered there.
- Q. Did he ever say to you well thats all I, thats all?
- A. No uh uh I always said theres nothing I can tell you, theres nothing re to tell and he said, I can use all the help that I can get and if you have anything please call me immediately and I will stay in touch with you.

The next time he called me was that night again, he called me three times that day, and it was merely the same conversation, and the more that I talked to the man, the more I was get out of the feelings that I, the more that I would talk to him the more I would feel and right after I got off the telephone with him I used to get certain vibrations like danger you know and stuff like this it was really amazing and when he called me up on the phone the third time I just told him that everything was about the same that you know they could not find the boy in the area that they were looking and I even told him on the telephone don't both. looking out in the everglades or whatever, because the man does not intend to hurt him at the time and he told me I was right he said I feel that your right, but, if I would have known more about who I was working with it probably would have hit me sooner.
- O. Then what occurred when was the next time?
- A. The next time he called me the following morning and I think I just reemphasized what I had told him the other conversations, I really, I couldn't really get anything until after I hung up the phone with him and I remember the last time, the last time that I talked to Jim Campbell it was in the morning and that night, I got, it was very unusual that this happened, I uld see a dark area and hammering, very loud hammering and just like when your in the dark and you see pieces of wood in front of you you can see

him a lot and she just said who is this, the whole thing, she didn't tell me that he was, she took down my telephone number and she told me that he would try and get back to me, that he was so busy but he would try to get back to me and I never heard and I called her about two to three times trying to reach him.

- Q. Do you recall the date of that call to Mrs. Walsh, how long into the investigation?
- A. It was the, oh....lets see when did I....
- Q. You say two or three days into the investigation he disappeared on the 27th so we're talking about the 30th or 31st was the first contact with Mr. Campbell, then when you had Mrs. Walsh how much longer than that day?
- A. It was two days before I picked up the shirt from Adam Walsh, it was Friday, and she couldn't tell me his whereabouts or anything.
- Q. That would have been the 7th of August, okay so a couple of days before that would have been the week of the 3rd of August, did she indicate....
