Decapitated young girl buried with only a detective to mourn

ST. LOUIS — (UPI) — The headless body of a young girl was buried in an unmarked pauper's grave with four mud-covered gravediggers as pallbearers despite the nine-month effort of a police veteran to locate her relatives.

"Maybe I grew so attached to this kid I didn't want to go through with it," said Detective Herb Riley, who led the investigation into the killing. "I kept thinking she would get a burial by the family."

Four empty chairs were at grave side Friday for the 5-minute burial service paid for by the city. No stone marked the grave, identified

only as Lot 270, Section 6, Grave 2 at the Washington Park Cemetery.

The ceremony was attended by the media, Riley and four gravediggers who carried the small white casket up a muddy hillside to the site they had prepared moments before.

Riley, an 18-year veteran of the homicide division, attended the ceremony on the "long-shot" hope that a relative, or even the girl's killer, would appear. Her body was found Feb. 28 in the basement of a vacant tenement.

"I've been in homicide too long to be surprised by anything," he said.

Riley said thousands of missing person reports were studied, school enrollments were examined and hundreds of people were interviewed. But no clues turned up to the girl's identity.

"We're no closer today than the day I picked her up in that building," he said. "I don't know of anything else to do. We never even found the head."

The Rev. John W. Heyward Jr., whose Union Memorial United Methodist Church is just a few blocks from where the body was found, prayed that the "dastardly crime" would be solved.

"We are here to commit this body of a pirl whose name we don't

know, but whose name is surely known to God," Heyward said.

A burial attendant scattered flower petals over a single spray of pink, white and yellow flowers placed on the casket.

The girl's body was clothed only in a yellow V-neck sweater when found. Authorities said she had been sexually assaulted, and her head neatly severed. The medical examiner's office said hours.

Gentlemen:

The Homicide Division of the St. Louis Police Department is presently conducting an investigation which began February 28, 1983.

This case involves the decapitation of a young, black female described as:

black female, 8 to 12 years of age, 5'3" to 5'4", medium brown skin, 75# estimated weight, thin build.

The victim was found clad only in a yellow long-sleeved V-neck orlon sweater. She had two coats of red fingernail polish on her fingernails and her hands were tied behind her back with a red and white nylon rope, possibly nautical type nylon rope.

Evidence revealed that the victim had apparently been slain in an undisclosed location and her body dumped in a vacant building at 5635 Clemens, which is a primarily black area in the west end of our city.

The Medical Examiner's Office determined that the victim had been sexually assaulted. The weight of the body was 70 pounds and the height is 4'8", without the head.

The victim's head has never been found and the victim has never been identified.

Our most recent action in this case, 10/20/83, has been a check of the N.C.I.C. list of missing persons matching the victim's description, which was provided by the F.B.I. Only one black female was reported missing from Boston, Massachusetts, and she has been located in Cambridge, Massachusetts.

As of this writing, we have been unable to place Otis Elwood Toole or Henry Lee Lucas, his apparent accomplice, in our city.
