On Tuesday, 2-16-82, this writer, upon entering the Sheriff's Department, was advised by Sheriff Charles Tue that a body of either a male or female had been found approximately one mile Northeast of Plainview on a County dirt road. The body was discover by a Mr. Manuel Ayala, a farmer.

This writer drover to the location given by Sheriff Tue and observed the body of a badly decomposed victim, laying on it's stomach in the bar ditch on the North side of the County dirt road. A closer examination of the body revealed that the victim's head was missing and that both of the victim's hands had been bound together with a bra.

Photo's were taken at the scene of the victim, and of the area surrounding the victim. From the decompose state of the body, it was impossible to determine how long the body had been in this location. Animals had eaten away most of the flesh.

There was no direct evidence to indicate that the victim had been killed at this location, no blood found at scene, but rather had been placed there after being killed at another location.

At approximately 8:30 p.m., Dr. Ralph R. Erdman arrived and the body was taken to Central Plains Hospita" and X-rays were taken. The X-rays showed no broken bones.

On 2-17-82, Dr. Erdman preformed an autopsy and came to the following conclusion: That the victim was a w/f, approximately 18-25 years of age, 5°5", approximately110#. Dr. Erdman further stated that the victim had been stabbed in the lower left chest area and that her head had been severed with a shapp instrument. He further advised that there were three chopped areas on her neck before the head was severed.

Dr. Erdman removed both of the victim's hands and Chief Dep. Gooch and this writer transported them to Austin DPS Lab for examination. Ten good prints were lifted by the Austin Lab. The prints were compared to Prints in Austin and with the FBI in Washington with negative result.

All of the identification information was sent to Denver, Colorado to the Nationals Center for missing persons with negative results.

Dr. Erdman later changed the description of the victim to be a w/f, approximately 18-45 years of age, 5'1'', to 5'7'', and weighing 100-140''; no color of hair was given.



PURPOSE: SYNOPSIS OF HOMICIDE AUGUST 17, 1976

VICTIM: SHARON MARIE COPP DOB. 3/31/42, DOD. 8/17/76

Sharon Marie Copp was in the process of divorcing her third husband, Donald Copp. At the time of the homicide, Donald Copp was confined to Pueblo County Jail on driving charges. The victim had just returned from a trip to California where her and her children (three girls, ages 10-8-5) visited a boyfriend of the victim. Relatives and friends describe the victim as being the type that would not back away from a fight and would say what was on her mind. Our investigation revealed that the victim was loose morally and probably was involved in some prostitution. She would strike up a conversation with a man in a tavern and then get up and leave. The man would leave shortly afterward. One older man informed us that he use to give her money for sexual favors and told about one time when they were taking a bath together and she asked him for some money. He refused to give her the money and she bit him very severely on the penis.

Sharon Copp contacted a fellow student at the Southwest Beauty College by the name of Joe Martinez, age 17, and ask him to babysit for her on 8/16/76. She left her home at 7:30PM and first went to Joe's 96 Tavern at 2102 E. 4th. St. She left there at 8:00PM and went to the White Horse Tavern at 627 E. 4th. St.

and left there around 8:50PM. She then went to Lee's Tavern at 806 Santa Fe Dr. and arrived there 9:05PM and left there at 9:45PM. At each one of these taverns Sharon talked to friends and had one drink. She arrived at Jeanne's Bar 1642 E. Evans at 10PM and had two tomato beers. She did talk to a couple of customers there that are presently unknown. All but one of the employees and customers at Jeanne's Bar state that Sharon left by herself just prior to 11PM. One customer stated that as he was leaving the Bar he saw Sharon get into a car with three or four other people that are presently unknown.

In the apartment complex where the victim lived (2207 E. 12th. St. apt.#74) we interviewed one neighbor that very definitely observed Sharon's car parked at the 2207 E. 12th. parking lot at 7PM on 8/17/76. Another neighbor states that one 8/17/76 at 1:30AM, she observed the victim argueing with an unknown male near her apartment. This arguement involved her making the statement that "Get the fuck away from me! You haven't given me one damn dime since the baby was born!". The male half of the arguement was heard to say, "If you don't shut your mouth, I'll cut your head off". The witness last observed the man grab the victim and twist her arm behind her back and walk her off toward the parking lot.

Sharon Copp has mothered six children. Three illigitimate children were given to the Welfare Department for adoption at the time of their birth. The victim has her three girls from the second marriage to William Joseph Sullivan. All of the fathers to these six children have been contacted but one. We have not been able to locate a Clarence Henry "Sandy" Betts that fathered her last child. The last child was consumated while the victim was still married to William Sullivan. Mr. Sullivan had had a vasectomy following his third child and left the victim when he discovered that she was pregnant. Clarence Betts moved in with the victim but disappeared in her 5th month of pregnancy and has not been seen since then.

On August 18, 1976 at 10AM, Mr. Donald Bowman of 1601 Jerry Murphy Rd. contacted me and wanted to report his daughter, Sharon Marie Sullivan, as a missing person. I was informed that Sharon's car was parked at Jeanne's Bar and that the babysitter, Joe Martinez, had notified Mr. Bowman that Sharon had not returned home at 7AM on 8/17/76. Mr. and Mrs. Bowman had picked up the children and waited another day to report her missing.

On August 18, 1976 at 10:30AM, a fisherman discovered a dark green plastic bag containing some body parts on the west end of the Pueblo Reservoir. This is a well traveled fishing area and the fisherman states that he fished the same area on 8/17/76 and did not see the bag at that time. The bag was placed in such a way that it could be easily spotted when just 20 feet on the opposite side of the road would have placed the bag in a muddy boggy area that would have probably concealed the bag forever.

Inside this bag was another "Hefty" type trash bag. Both bags were properly sealed. Articles found inside this bag are:

- 1. Both arms minus the hands
- 2. Both legs dis-connected at the knee and including the feet
- 3. Both breasts
- 4. Victim's mocassins, maroon slacks, violet blouse
- 5. Remington brand golf club shaft badly bent (Cheap brand)
- 6. Putter head to above golf club
- 7. Small pieces of badly weatered wood splinters
- 8. Regular size white sheet

This bag was found in Pueblo County and the investigation was handled by the Sheriff's Office. The victim's clothing was identified by Mrs. Bowman.

On 8/18/76 at 4:45PM a humane officer discovered the rest of the bodyparts in the alley behind 1323 E. 19th. St. Neighbors report seeing a dark green plastic bag setting in this alley as early as 6AM on 8/17/76. The residence

in the area thought that the sack contained a dead dog because a split in the bag revealed what they thought was dog hair. The humane officer discovered the body when she loaded the sack into her truck and the victim's head rolled out on the ground. This is a middle class neighborhood and most of the residences in the area are well kept. The sack was placed next to the ferre at 1323 E. 19th. where it pull easily be spotted. One block away was a large metal trash container of the type that a truck just hooks onto and dumps into the trash truck. Two blocks away at an all night convenience store, an unknown man purchased some dark green plastic "Hefty" bags at 1:30AM on 8/17/76. Articles found in this bag are:

- 1. Torso of Sharon Copp. Take special notfe of the pictures showing the marks on the buttocks. Is there a meaning, are they initials J. L.?
 - 2. Both hands , fingerprints were matched to Sharon Copp
 - 3. Victim's head (tear in sack allowed entry of maggots)
 - 4. Wood pieces or splinters that appeared badly weathered
- 5. Yellow "muscle" shirt with cartoon of a socker player on front. Childs size medium
 - 6. Gold colored, fitted, regular size, sheet
 - 7. Gold colored, fitted, twin size, sheet
 - 8. Large yellow "beach" towel
- 9. Matching yellow wash cloth and regular size towel

 would place the distance at eleven miles. By car, the distance is about 20

 miles on the odometer.

still missing is the actual crime scene. We are working on the theory that this had to have happened in a private dwelling. Motels and hotels have been checked. The body appeared to have been washed and there is no presence of dirt or sand with the body parts. We are also still missing the victims false, partial, upper dental plate consisting of the front four teeth. We

are also still missing her jewelry which consisted of a timex watch, a silver ring and a turquise ring.

The victim's purse was located on the highway to Beulah, Colorado (Highway #76) about 3 miles west of town. Most of her personal paper: were found on this same highway right on the edge of town. Two days later her bra was found with the cups neatly folded one inside the other, in the same area that had been walk-searched earlier. Her panties were found laying beside the bra. A savings accound book was found near the bra and panties and was actually on the paved portion of the highway. I can see so way that the searched could have missed these items of evidence.

Another possibility worth mentioning is the fact that the babysitter, Joey Martinez dob 9/25/58 did admit to this homicide during some heavy questioning. He was later partially discounted because of a polygraph test and the fact that none of the profile seemed to fit. He was a student, along with the victim, at the Southwest Beauty College and appears to have some homosexual tendencies. His past record shows a theft involving a pistol but no record of sex offenses. He admittedly does not have much to do with any women but did state that he did not like the victim. He is not from our area and is staying with his sister and brother-in-law. We have gotten some reports back where he has told most of his friends about our interrogating him.

The Coroner has ruled the cause of death as massive blows to the head.

Included please find a copy of his autopsy report. The Colorado Bureau of
Investigation did find some head hair and pubic hair, that was foreign to the
victim, on some of the sheets and towels found with the body. We have not
been able to match the hair samples with any of our suspects.

This body was discovered in multiple pieces found in separate garbage bags some 20 miles apart. The findings will be described as the specimens were received in the laboratory.

The first sack, found near the Pueblo Reservoir in Pueblo County, contained two arms without the hads, two breasts, and two legs amputated above the knees.

The right arm and forearm measures 43 cm. in length. There is minimal skin slippage. The anticubital fossa shows two questionable needle punctures with minimal ecclymoses of the surrounding soft tissues. The humerus has been irregularly fractured 15 cm. above the elbow although the surrounding soft tissues have been cleanly severed. The hand has been rather neatly amputated at the wrist.

The left arm and forearm measure 51 cm. in length. The humarus is irregularly fractured 23 cm. above the elbow. The metacarpal of the thumb is still attached at the wrist and the surrounding skin and soft tissues show some irregularity of the cut margins.

One amputated breast measures 18 cm. in diameter and shows some frregularity of the lacerated skin margins. The second breast has been cleanly amputated and measures 16 cm. in diameter. SEctions through the breasts are not remarkable.

The right leg has been amputated above the knee by sharp dissection through the knee joint. The posterior aspect of the proximal tibia shows a wound which appears to have been made by a saw and which nearly amputates the proximal tibia. There are irregular lacerations on the medial aspect of the knee and multiple superficial woundstrompatible with hacking about the knee. TA lateral laceration is 2 cm. in length.

The left leg has been amputated by sharp dissection through the knee joint. The patella is attached as it is on the righ knee. The posterior tibia again shows a clean wound apparently made by a saw which nearly amputates the proximal tibia. The dorsum of the left foot shows parallel surgical incisions 4 cm. in length and 3 cm. in length which are compatible with a previous surgical operation. Two incisions along the medial aspect measure 3½ and 3 cm. in length respectively.

Included with these body parts is the head of a silver golf putter which measures $11\frac{1}{2} \times 2\frac{1}{2} \times 1\frac{1}{2}$ cm. The shaft has been broken off 0.7 cm. from the base of the club.

The second sack, found in East Pueblo approximately 29 miles from the Pueblo Reservoir, contains a head, the torso and each hand. Also included in this sack is a small yellow T-shirt with a cartoon painting of a soccer player and a blood stained yellow contour sheet.

The head is covered with reddish blonds hair. There are extensive areas of swelling and ecchymoses about the forehead, each eye and the bridge of the nose. The eyes and mouth and the wounds on the head are filled with magots. There are some weads in the hair. The head has been neatly decapitated at about the level of C+2. The upper central and lateral incisors are missing and the adjacent canine teeth are loosened. Thehose and mandible show crepitation compatible with bony fractures.

The torso shows removal of the arms, legs, breasts, and head. The body shows magots in all wounds and orafices including the vagina which is packed with magots. There are extensive areas of bruising primarily over the lateral aspect of the thorax and abdomen and over the back and buttocks. An irregular bruise in the right upper quadrant has some resemblance to the previously described putter. There is extensive skin slippage throughout. Examination of the neck shows some skin creasing but this does not appear compatible with manual strangulation. linear lacerations are seen on the anterior surface of the abdomen and extend only through the skin. These appear to have been made with a very sharp instrument such as a razor blade. The entire torso contains extensive stab wounds and lacerations, the larger running parallel to the vagina and exposing the majority of the left Intestines are protruding through this wound. The right. side of the abdomen. flank contains numerous lacerations many of which extend into the retroperitoneal and peritoneal area and penetrate the underlying internal organs. A gapping wound marks the back along the left side and extends from the back to the left buttock. The buttocks are extensively bruised and have been marked with multiple linear lacerations extending throughout the thickness of the skin and into the underlying muscle mass. One gapping laceration extends through the anus and through the skin overlying the sacrum.

The uterus shows only slight enlargement. There is no evidence of pregnancy. The vagina as previously described is filled with magots and shows no evidence of lacerations. Vaginal swabs are not taken due to the marked decomposition of the body.

The right hand matches the dissection to the joint of the right wrist.

Multiple fingerprints are taken. The left hand matches the rather crude dissection at the left wrist.

LABORATORY STUDIES: Blood obtained from the legs is typed and is A Rh positive.

RADIOGRAPHS: X-rays of the skull show multiple fractures including fractures of the mandible, maxilla, left frontal bone, right temporal squamosa, and the occiput.

VICTIM: SHARON MARIE COPP DOB. 3/31/42, DOD. 8/17/76

Sharon Marie Copp was in the process of divorcing her third husband, Donald Copp. At the time of the homicide, Donald Copp was confined to Pueblo County Jail on driving charges. The victim had just returned from a trip to California where her and her children (three girls, ages 10-8-5) visited a boyfriend of the victim. Relatives and friends describe the victim as being the type that would not back away from a fight and would say what was on her mind. Our investigation revealed that the victim was loose morally and probably was involved in some prostitution. She would strike up a conversation with a man in a tavern and then get up and leave. The man would leave shortly afterward. One older man informed us that he use to give her money for sexual favors and told about one time when they were taking a bath together and she asked him for some money. He refused to give her the money and she bit him very severely on the penis.

Sharon Copp contacted a fellow student at the Southwest Beauty College by the name of Joe Martinez, age 17, and ask him to babysit for her on 8/16/76. She left her home at 7:30PM and first went to Joe's 96 Tavern at 2102 E. 4th. St. She left there at 8:00PM and went to the White Horse Tavern at 627 E. 4th. St.

and left there around 8:50PM. She then went to Lee's Tavern at 806 Santa Fe Dr. and arrived there 9:05PM and left there at 9:45PM. At each one of these taverns Sharon talked to friends and had one drink. She arrived at Jeanne's Bar 1642 E. Evans at 10PM and had two tomato beers. She did talk to a couple of customers there that are presently unknown. All but one of the employees and customers at Jeanne's Bar state that Sharon left by herself just prior to 11PM. One customer stated that as he was leaving the Bar he saw Sharon get into a car with three or four other people that are presently unknown.

In the apartment complex where the victim lived (2207 E. 12th. St. apt.#74) we interviewed one neighbor that very definitely observed Sharon's car parked at the 2207 E. 12th. parking lot at 7PM on 8/17/76. Another neighbor states that one 8/17/76 at 1:30AM, she observed the victim argueing with an unknown male near her apartment. This arguement involved her making the statement that "Get the fuck away from me! You haven't given me one damn dime since the baby was born!". The male half of the arguement was heard to say, "If you don't shut your mouth, I'll cut your head off". The witness last observed the man grab the victim and twist her arm behind her back and walk her off toward the parking lot.

Sharon Copp has mothered six children. Three illigitimate children were given to the Welfare Department for adoption at the time of their birth. The victim has her three girls from the second marriage to William Joseph Sullivan. All of the fathers to these six children have been contacted but one. We have not been able to locate a Clarence Henry "Sandy" Betts that fathered her last child. The last child was consumated while the victim was still married to William Sullivan. Mr. Sullivan had had a vasectomy following his third child and left the victim when he discovered that she was pregnant. Clarence Betts moved in with the victim but disappeared in her 5th month of pregnancy and has not been seen since then.

On August 18, 1976 at 10AM, Mr. Donald Bowman of 1601 Jerry Murphy Rd. contacted me and wanted to report his daughter, Sharon Marie Sullivan, as a missing person. I was informed that Sharon's car was parked at Jeanne's Bar and that the babysitter, Joe Martinez, had notified Mr. Bowman that Sharon had not returned home at 7AM on 8/17/76. Mr. and Mrs. Bowman had picked up the children and waited another day to report her missing.

On August 18, 1976 at 10:30AM, a fisherman discovered a dark green plastic bag containing some body parts on the west end of the Pueblo Reservoir. This is a well traveled fishing area and the fisherman states that he fished the same area on 8/17/76 and did not see the bag at that time. The bag was placed in such a way that it could be easily spotted when just 20 feet on the opposite side of the road would have placed the bag in a muddy boggy area that would have probably concealed the bag forever.

Inside this bag was another "Hefty" type trash bag. Both bags were properly sealed. Articles found inside this bag are:

- 1. Both arms minus the hands
- 2. Both legs dis-connected at the knee and including the feet
- 3. Both breasts
- 4. Victim's mocassins, maroon slacks, violet blouse
 - 5. Remington brand golf club shaft badly bent (Cheap brand)
 - 6. Putter head to above golf club
 - 7. Small pieces of badly weatered wood splinters
 - 8. Regular size white sheet

This bag was found in Pueblo County and the investigation was handled by the Sheriff's Office. The victim's clothing was identified by Mrs. Bowman.

On 8/18/76 at 4:45PM a humane officer discovered the rest of the bodyparts in the alley behind 1323 E. 19th. St. Neighbors report seeing a dark green plastic bag setting in this alley as early as 6AM on 8/17/76. The residence

in the area thought that the sack contained a dead dog because a split in the bag revealed what they thought was dog hair. The humane officer discovered the body when she loaded the sack into her truck and the victim's head rolled out on the ground. This is a middle class neighborhood and most of the residences in the area are well kept. The sack was placed next to the ferre at 1323 E. 19th. where it could easily be spotted. One block away was a large metal trash container of the type that a truck just hooks onto and dumps into the trash truck. Two blocks away at an all night convenience store, an unknown man purchased some dark green plastic "Hefty" bags at 1:30AM on 8/17/76. Articles found in this bag are:

- 1. Torso of Sharon Copp. Take special notfe of the pictures showing the marks on the buttocks. Is there a meaning, are they initials J. L.?
 - 2. Both hands , fingerprints were matched to Sharon Copp
 - Victim's head (tear in sack allowed entry of maggots)
 - 4. Wood pieces or splinters that appeared badly weathered
- 5. Yellow "muscle" shirt with cartoon of a socker player on front. Childs size medium
 - 6. Gold colored, fitted, regular size, sheet
 - 7. Gold colored, fitted, twin size, sheet
 - 8. Large yellow "beach" towel
- 9. Matching yellow wash cloth and regular size towel
 Drawing a straight line between the sites where both sacks were located
 would place the distance at eleven miles. By car, the distance is about 20
 miles on the odometer.

Still missing is the actual crime scene. We are working on the theory that this had to have happened in a private dwelling. Motels and hotels have been checked. The body appeared to have been washed and there is no presence of dirt or sand with the body parts. We are also still missing the victims false, partial, upper dental plate consisting of the front four teeth. We

are also still missing her jewelry which consisted of a timex watch, a silver ring and a turquise ring.

The victim's purse was located on the highway to Beulah, Colorado (Highway #76) about 3 miles west of town. Most of her personal paper: were found on this same highway right on the edge of town. Two days later her bra was found with the cups neatly folded one inside the other, in the same area that had been walk-searched earlier. Her panties were found laying beside the bra. A savings accound book was found near the bra and panties and was actually on the paved portion of the highway. I can see so way that the searched could have missed these items of evidence.

Another possibility worth mentioning is the fact that the babysitter, Joey Martinez dob 9/25/58 did admit to this homicide during some heavy questioning. He was later partially discounted because of a polygraph test and the fact that none of the profile seemed to fit. He was a student, along with the victim, at the Southwest Beauty College and appears to have some homosexual tendencies. His past record shows a theft involving a pistol but no record of sex offenses. He admittedly does not have much to do with any women but did state that he did not like the victim. He is not from our area and is staying with his sister and brother-in-law. We have gotten some reports back where he has told most of his friends about our interrogating him.

The Coroner has ruled the cause of death as massive blows to the head.

Included please find a copy of his autopsy report. The Colorado Bureau of Investigation did find some head hair and pubic hair, that was foreign to the victim, on some of the sheets and towels found with the body. We have not been able to match the hair samples with any of our suspects.

This body was discovered in multiple pieces found in separate garbage bags some 20 miles apart. The findings will be described as the specimens were received in the laboratory.

The first sack, found near the Pueblo Reservoir in Pueblo County, contained two arms without the hads, two breasts, and two legs amputated above the knees.

The right arm and forearm measures 43 cm. in length. There is minimal skin slippage. The anticubital fossa shows two questionable needle punctures with minimal ecchymoses of the surrounding soft tissues. The humerus has been irregularly fractured 15 cm. above the elbow although the surrounding soft tissues have been cleanly severed. The hand has been rather neatly amputated at the wrist.

The left arm and forearm measure 51 cm. in length. The humarus is irregularly fractured 23 cm. above the elbow. The metacarpal of the thumb is still attached at the wrist and the surrounding skin and soft tissues show some irregularlity of the cut margins.

One amputated breast measures 18 cm. in diameter and showsome irregularity of the lacerated skin margins. The second breast has been cleanly amputated and measures 16 cm. in diameter. Sections through the breasts are not remarkable.

The right leg has been amputated above the knee by sharp dissection through the knee joint. The posterior aspect of the proximal tibia shows a wound which appears to have been made by a saw and which nearly amputates the proximal tibia. There are irregular lacerations on the medial aspect of the knee and multiple superficial wounds compatible with hacking about the knee. A lateral laceration is 2 cm. in length.

The left leg has been amputated by sharp dissection through the knee joint. The patella is attached as it is on the righ knee. The posterior tibia again shows a clean wound apparently made by a saw which nearly amputates the proximal tibia. The dorsum of the left foot shows parallel surgical incisions 4 cm. in length and 3 cm. in length which are compatible with a previous surgical operation. Two incisions along the medial aspect measure 34 and 3 cm. in length respectively.

Included with these body parts is the head of a silver golf putter which measures $11\frac{1}{2} \times 2\frac{1}{2} \times 1\frac{1}{2}$ cm. The shaft has been broken off 0.7 cm. from the base of the club.

The second sack, found in East Pueblo approximately 20 miles from the Pueblo Reservoir, contains a head, the torso and each hand. Also included in this sack is a small yellow T-shirt with a cartoon painting of a soccer player and a blood stained yellow contour sheet.

The head is covered with reddish blonds hair. There are extensive areas of swelling and ecchymoses about the forehead, each eye and the bridge of the nose. The eyes and mouth and the wounds on the head are filled with magots. There are some weeds in the hair. The head has been neatly decapitated at about the level of C-2. The upper central and lateral incisors are missing and the adjacent canine teeth are loosened. Thehose and mandible show crepitation compatible with bony fractures.

The torso shows removal of the arms, less, breasts, and head. The body shows magots in all wounds and orafices including the vagina which is packed with magots. There are extensive areas of bruising primarily over the lateral aspect of the thorax and abdomen and over the back and buttocks. An irregular bruise in the right upper quadrant has some resemblance to the previously described putter. There is extensive skin slippage throughout. Examination of the neck shows some skin creasing but this does not appear compatible with manual strangulation. Multiple linear lacerations are seen on the anterior surface of the abdomen and extend only through the skin. These appear to have been made with a vary sharp instrument such as a razor blade. The entire torso contains extensive stab wounds and lacerations, the larger running parallel to the vagina and exposing the majority of the left side of the abdomen. Intestines are protruding through this wound. The right flank contains numerous lacerations many of which extend into the retroperitoneal and peritoneal area and penetrate the underlying internal organs. A gapping wound marks the back along the left side and extends from the back to the left buttock. The buttocks are extensively bruised and have been marked with multiple linear lacerations extending throughout the thickness of the skin and into the underlying muscle mass. The following is a taped interview with OTTIS ELWOOD TOOLE, date of birth 3-5-47, presently an inmate at the Duval County Jail in Jacksonville, Florida. Present during this interview are: Detective Rich Lipich, Pueblo Police Department; Lt. Jerry Murphy, Pueblo Country Sheriff's Office; and Detective Joe Antonio, Pueblo Country Sheriff's Office. Detective Buddy Terry, from the Duval Country Sheriff's Office in Jacksonville, Florida, was also present on occasion during the interview.

This interview began at approx. 8:00 a.m., 11-20-83. The tape begins, however, while the interview is in progress. When the interview began, the tape recorder failed to work due to weak batteries, and the first portion of the interview was not recorded.

Missing from the tape is the advisement of OTTIS TOOLE. Mr. Toole was advised of his constitutional rights using the standard advisement form by Detective Joe Antonio. He indicated a full understanding of his rights and agreed to answer questions pertaining to active homicide investigations in the State of Colorado. He declined to have an attorney present during the interview and at no time requested the presence of counsel. He was fully aware that the interview was to be tape recorded and granted permission for us to do so.

TAPE 1, Side 1 (begins with interview in progress)

Toole: Ya gotcha going now, aint ya?

Lipich: It's about time. Does that bother you? Because I

don't have to have it on.

Toole: No, that don't bother me.

Lipich: OK.

Toole: I don't even pay no attention

Lipich: The reason I got that on is just what we're talking about because I don't like to take alot of notes, and I have a hard time remembering. Because you may tell me something and I'll pass it up at the time, but if I hear it again later, you know it'll cause me to think of something that

Toole: Yeah.

Lipich: OK, this little map I drew you didn't do us a whole lot of good. What I was trying to impress on you was that if you drove through the state, chances are you

have been on that one main road.

Toole: Hiway 25.

Lipich: Yeah. I-25. And if you drove from one end of the state to the other on I-25, you'd go through all three of them towns that I mentioned, Pueblo, Colorado Springs, and Denver. You're not going to see alot of mountains in Pueblo, but you'll see them farther north. What I'm trying to do is to get you to remember if you can, if you've ever been there, if you can remember anything about it. One thing I'm curious about is that you said that you had heard the

name Pueblo. Do you say that's just from your travels, you

seem to remember hearing it?

Toole: Yeah. I try to think if I've ever been there in my mind, you know. You can picture it in your mind after a while if you've been someplace. By the way the landscape is

you know. A place you know.

Lipich: About buildings and things like that. Is that, do you

remember things like that?

Toole: Well it don't make no different what town I go to, I
would stay there going into town and seein how it looks
in town. But I get turned around on these freeways gettin
back on them motherfuckers. I have drove a hundred miles
out of my way and had to get back on the right track, you

know.

Lipich: Yeah. Ok.

Toole: That where you from, you from (inaudible).

Lipich: From Pueblo, yeah.

alot about the West Coast.

Toole: I like the West Coast better, yeah, I like California and, I like Texas, too. Yeah, I like Texas. But I don't like to be dead out in that hot sun too long, ya know. If I'm out in that sun I get me a hat to go on my head.

Lipich: Yeah.

Toole: So it won't cook my brains out, what little of them I got.

Lipich: You're originally from right here, aren't you?

Toole: Yeah. But shoot, ah, when I be on them streets, I would, ah, travel back and forth, ya know, all the way to the West Coast two or three times a year, every year. The past couple of years, it's been maybe like a once a year or twice, ya know, so. But when I get out there I stay, ya know, maybe like two weeks, three weeks (inaudible). Yeah, I drive the shit out of a car too.

Lipich: Yeah.

Toole: (inaudible). I make sure I got me a CB in the car.

Lipich: Whenever you'd go, you'd drive?

Toole: Yeah.

Lipich: Fly?

Toole: I drove alots.

Lipich: Most of the time you drove?

Toole: Most of the time.

Toole: But if I wants to get somewheres in a hurry, I would get me a, I'd catch me a jet, ya know.

Toole: I dressed all different ways when I was travelling. I dress in my regular clothes, I would dress up like a woman, ya know, and all that.

Lipich: Yeah.

Antonio: You was in drag?

Yeah. I'd dress in drag. That was when I started gettin low on money at the time, I'd say well I better get out Toole: here and play some of these bars. I gotta find me a sugar daddy that's got some money. And sometimes, I'd catch em sleepin in a motel and I'd just walk out and leave them and I wouldn't even do anything to them, ya know. Take their pants and that's all they got. They don't even got no pants to put on. I done got their pants, their keys, their watch, their ring and everything. (inaudible) but that old junkie shit, I wouldn't even bother with. I hit one of them one time. I was out on the West Coast. I remember this here. It was in a hotel but I can't, I remember it was more like a Mada, Mala Inn, or something like that. And, ah, this guy picked me up in drag and we got so fuckin drunk, and he had a diamond ring and a Longine watch that had diamonds on it, and I ended up taking about 500 dollars off of his ass. I did beat his ass and all, and left him bloody in the room and all but I don't remember if I killed him or not. was out in Colorado.

Lipich: It was in Colorado?

Toole: Yeah. It was in Colorado.

Antonio: Do you remember where it was?

Toole: It was in a, I try to say it, Mada Inn or something like that, I can't hardly say that word.

Antonio: Ramada Inn?

Toole: Yeah.

Lipich: Ramada Inn? The one that starts with an R?

Toole: Yeah. Ramada Inn.

Lipich: Alot of people call them 'Mada Inns.

Toole: Yeah. I beat him in the head with a fuckin telephone. I

hit him all over the head with a fuckin telephone. I even choked him down with my hands, ya know. Knocked him out, but I didn't look to see if he was dead or not, I just left his fuckin ass in there. I took about 500 dollars in cash off of him.

Lipich: You don't remember what city you were in? You just remember you were in a Ramada Inn?

Toole: It was a, it was out on the West Coast. I don't hardly, See when I do somethin in the city, to a certain extent, ya know, if somebody mentioned a name when I was there I could remember the name in my head, you see, but if I was just driving through by myself, I don't even pay no attention to the names.

Lipich: Now, are you talkin . . . you said that this happened in Colorado.

Toole: Yeah.

Lipich: Right?

Toole: Yeah.

Lipich: Are you referring to Colorado as being on the West Coast?
Because you just said, ah . . .

Toole: Yes, I said . . .

Lipich: It happened more on the West Coast.

Toole: I said, the reason I say it's on the West Coast is cause it's out of Florida, you see.

Lipich: Alot of people say that because it's west of the Mississippi.

Toole: That's what I thought.

Lipich: But that's why I wanted to clear that up because to me it's not on the coast. When I think of being on the West Coast I think of California or Oregon.

Toole: I didn't tie him up, I didn't tie him up with nothin, I beat his head around with that fuckin telephone. I was using my hands on his fuckin throat and chokin him to death. I don't remember if I wrapped the telephone cord around his throat or not.

Lipich: But you know definitely that you were in a Ramada Inn?

Toole: Yeah.

Lipich: OK. What was around the Ramada Inn? When you walked out the front door of the Ramada Inn, what did you see?

Toole: Oh, there was a bunch of other buildings all through there.

Lipich: Do you remember what kind? Was there a . . .

Toole: (inaudible). Oh, they weren't high buildings, they was, they were kinda scattered buildings, ya know.

Lipich: Do you remember, for instance, if there was a MacDonald's Restaurant next door, or a pizza parlor, or a, you know, anything like that?

Toole: Oh, I don't pay no attention to all that, but there was a bunch of other buildings, ya know, jammed up around there.

Lipich: Did you just go to this Ramada Inn with this guy?

Toole: Yeah, I was dressed in drag.

Lipich: You were, you went in drag, and you just went there, you didn't stay there for any length of time where you would have went to get something to eat nearby or . . .

Toole: Oh, I was drunk (inaudible). And I said well I got myself a fuckin sucker. I do, I'd go to all these lounges and I'd be settin up there and buy myself a drink and I'd be checkin the men out and all, lookin to try to see what they got, ya know.

Lipich: Does it help you to look at pictures?

Toole: Yeah.

Lipich: I imagine cops have been showing you a lot of pictures.

Toole: Lots of em wouldn't even show me pictures, they's tryin to make me quess on the deals.

Lipich: Well, you know, I want to be, I want to be truthful with ya, I, I gotta have, you know, a certain amount of detail from you. I can't just lay somethin out, and ah, because you're liable to tell me you did it when you didn't just because you've done so many, you know, that it looks like something you may have done, and I don't want...

Toole: I ain't gonna take somethin I ain't done.

Lipich: Well, I, I don't blame you. I don't blame you.

Antonio: You know Ottis is, we, we kinda got into that yesterday and I think he got a little disturbed with me at one point because I had made about the same statement and, he right, and, he ain't gonna take the blame for something he didn't do.

Toole: Cause it ain't no , I ain't no ...

Lipich: I'm glad you feel that way, cause....

Toole: It ain't no sense in me leavin somebody else out there running loose when I done it myself, ya know. I ain't gonna take somebody elses, somebody elses rap, ya know. I'm gonna try to get, uh, detail just as close as I can in my, in my mind on the details, or else if it's a house a car, in a motel room, or, uh, out on the road ya see. But if ya catch somebody out in the road, out in the open ya know, it's mostly gonna be at night if ya kill somebody in the open, it ain't gonna be in broad daylight. If a car was comin by well they could see you.

Lipich: OK lets, let's talk about when you would cut somebody up.

Toole: When I would cut them up?

Lipich: Huh? Let's talk about some of the times that you've cut some people up. Now, ya know, it's hard for you to remember where and all that, so let's just, let's just talk about ya know, things you've done in general. Did you cut men?

and women?

Toole: (inaudible)

Lipich: Just women though?

Toole: I cut some men up, but not too many of em, I mostly shoot

them bastards.

Lipich: Yeah.

Toole: The reason I call them bastards is they try to give me a

hard time.

Antonio: When you traveled with Henry, did the two of you work

together in cuttin some people up?

Toole: Well Henry would mostly do all the cuttin his self and I mostly would stab them, ya know, after they been cut on, after they been cut open, and ah, the titties and the nipples cut off the titties and they been cut straight across the chest, and stabbed in the chest, I would stab them all over too, but, but I wouldn't pay attention to how many times I would stab them, ya know. There's some people, different netctives say how many times have you stabbed a person and I say well when you're stabbin somebody you don't keep count of how many times you stabbing somebody. I mean I

Toole: ain't gonna say one, two, three and like that, ya know.

Lipich: Yeah, you'd just about have to do that.

Toole: Cause you can't, ain't, only way they can really count that how many times a person stabbed somebody is after the person is done dead and they found the person. I can't stand up and tell a person how many times they been stabbed or how many gashes ya made when you was cuttin the head off or cuttin the arms off. You can't, you can't stabilize that in your mind.

Lipich: Was there anything that you particularily liked to do?

I mean, did you, ah, ...

Toole: I mostly shootin em and stabbin em.

Lipich: I mean when you went to cutting on a body, did you, ah...

Toole: I would chop, I would chop their fuckin head off, I wouldn't dis, dismain the bodys too much, I mean I have you know cut the arms and their legs and their hands and all that off, but ah, they didn't, I say I probably maybe about a half a dozen like that were done, I couldn't tell you exactly.

Lipich: What would you do with the body parts?

Toole: Scatter them out.

Lipich: Just scatter them out?

Toole: Yeah, take em and throw her and there, I mean, not in one certain place.

Lipich: Would you just lay them out in the open? or....

Toole: No, I would just them and toss them, mostly in the fuckin (inaudible)

Lipich: But, with, with no purpose, I mean you wouldn't purposely ah, leave leave an arm where somebody would find it, or...

Toole: Oh, I wouldn't try to leave it where they'd find it, I was tryin, ah, well I was tryin, when I killed somebody I was tryin too, really I don't know what I was really tryin to do, if I was trying to hide it or not, ya know. I mean when you kill somebody at night you ain't gonna, you don't really know kind of landscape in your in somewhere when you kill somebody at night. With all that layin out there, I say it's (inaudible)...

Lipich: Yeah, but, you just throw it around. You wouldn't bury it, or ah, ...

Toole: I I've buried some of it in different places before.

Lipich: Did you ever put the parts in something to conceal it, so

Lipich: that it would be harder to find?

Toole: No, no I wouldn't....you confusin me to a certain extent.

Lipich: Huh?

Toole: I say you confusin me to a certain extent, see you goin through, you're goin through it real fast and it's gonna get confused in my mind.

Antonio: Yeah, I know it's getting confusing for you Ottis. Ottis, didn't you tell us, uh, yesterday, or, maybe I got a little confused with something that you told the other officers that interviewed you in the past, that there has been a time or two that you put parts in garbage bags, in plastic bags, and you put it here and then you just threw it out some, threw other parts out somewhere else.

Toole: Yeah.

Antonio: That's what I thought, you had told us...

Toole: Yeah I did say that, yeah. But I mostly leave em out of the garbage bags cause they would rot quicker, ya know. Garbage bags would mostly (inaudible) I mean when you throw em out in the open, ya know, what I mean in the open ya know you throw it most anywheres, you ain't trying to...when you killing somebody, you ain't really paying attention to what you're doin really to a certain extent. I mean, you try to hide it to a certain extent you know, I must have tried, when I was killin people I mostly, uh, tried to leave em way out in the woods or by the brush or somethin like that. Or not less I would run over them by the road, or shot their ass down by the road, or somethin like that.

Antonio: Okay, but you did tell the other officers, Ottis, very honestly, I'm a little bit confused, that you did, you and Henry did, least that statement's already been made.

Toole: Yeah.

Lipich: I apologize, if I'm, if I get to going to fast, just look at me and say shut the fuck up.

Toole: I ain't gonna do that.

Lipich: And I'll get the message.

Toole: (inaudible) til you started hittin me real fast like, it was blowin my mind.

Lipich: I have a tendency sometimes to do that.

Toole: It was joggin my mind and I couldn't, I was gettin

off and I couldn't stabilize it in my mind.

Lipich: Yeah.

Antonio: Rich, one of the things that we did learn in workin

with Ottis yesterday is

(TAPE 1, Side 2)

Antonio: one of the questions if he, if you rapid fire at him

he's got a problem.

Lipich: Yeah.

Toole: See now, (inaudible) I know ten real good. I know ten

real good and I know nine real good. And that's on the West Coast and I know all that real good. 'Cause I've been back and forth on that road straight across the

country.

Lipich: Yeah.

Toole: And I know all that, them roads pretty good.

Lipich: OK.

Toole: But when I would get into a big city or somethin, I

would get on a different highway, but I'd get turned around to a certain extent and then I would have to get, I would have to go to a station or somethin and get them, try to show me a may where I can mark it off and get back

on the right track where I was at.

Lipich: Yeah.

Toole: See I was, that's what I would get out of keepin one of

the United States guides, you know, with all the cities, you know, so that I could find out where I was at. I don't even know as I still had one when I got locked up or not. I'm not really sure. I did have one, and somebody could've picked it up, ya know, asked me for a map at different times.

Sometimes I'd take it and look at it, ya know, and I'd say well I feel like goin on a trip, ya know but I ain't goin right now and put it back up or I'd leave it layin down. I had one but I lost it down at the Greyhound bus station. It had the whole United States in it. It had

every city in it, the size of it (inaudible).

Lipich: Yeah. Like an Atlas, like that?

Toole: (inaudible) It would have this whole city, this whole city and that whole city, ya know, and then I would have one that

would have the whole United States on it mostly straight

across by the way I'd been.

Antonio: Ottis, there was one case that you made statements to the officer, or you told the officers, that there was one body, and you correct me, I drew the, I got the opinion that you and Henry together, were together and this body was a girl and you took her from some city and about in a kind of a wilderness area or a brushy area or somethin like that, and that you did, either you both had sex with her or you had sex with her or Henry had sex with her, one of the two, I don't, that's a little confusing to me, and that you, that she was real real bloody, and you guys washed her up, and cut her up, and then kind of scattered the parts, but there wasn't any real detail on how you scattered the parts.

Toole: That was when we chopped her head off.

Antonio: Yeah. That sounds like the same incident. That sounds like the same incident.

Toole: And that, I knew that was the one that we fileted her body. Cut her body up like a, ya know, cooked different parts and all that. Her pussy was in a bag and throwed up in a tree.

Antonio: Well, that could be. That could be, I don't know. You'd have to tell me. But I remember that they told me and they have you on tape. Incidentally, you do know these two tape recorders on goin.

Toole: Oh yeah, I do.

Antonio: And we have your permission to do that.

Toole: Oh yeah.

Antonio: But ah, I think you mentioned it yesterday that you took her pussy and threw it up in a tree.

, '

Toole: Yeah.

Antonio: And ah,

Toole: Somebody else would (inaudible) on account of they don't taste too hot.

Antonio: Yeah. I think that's the same incident. And you apparently cleaned her body up because you said it was too bloody.

Toole: Yeah.

Antonio: And there was a stream or lake or something right there close where you could clean her up, and you guys cut her up.

Toole: Yeah.

Antonio: And, and then you took the parts and you put part of her here and you put part of it some place else.

Toole: Yeah.

Antonio: Quite a ways away as I recall.

Toole: Yeah, we kinda scattered it out. Yeah, I remember that.

Antonio: And then apparently, you said yesterday that you were in a habit of takin their purses and just throwin them out the window.

Toole: Yeah.

Antonio: Out on the road.

Toole: Yeah. And then the clothes, you leave the clothes

somewheres else.

Antonio: Yeah.

Toole: Not leave the clothes there. We done that quite often, too.

What it would, what too often where, the clothes was

always found somewheres else.

Antonio: Usually or always? (inaudible)

Toole: (inaudible)

Antonio: Let's see, Becky Powell was travelling with you guys when

she was real real young?

Toole: Yeah, she was, she was young when she a, I'd say she was

maybe a, about 14, 13 or 14 when she run off with Henry

somewhere around that.

Antonio: Well, there seems to be documentation that she was somewhere

a real young kid when she first started. I'm talkin about

real young.

Toole: Yeah, when my, when my mother first passed away we got, I

took her and my brother and left town with them.

Lipich: When was that, Ottis? ~

Toole: That was, my mother, she died back in '81. And we took

the two kids and went across to the West Coast with us.

Lipich: OK.

Toole: And different times before, her and Henry went different places. He was tellin Mama about that time. He wanted

to go camp out or somethin and he'd be gone maybe three or four days, or somethin like that, ya know. Sometimes I wouldn't even go. I mean she trusted Henry with Becky because Henry was, he act like he was showin the kids lots attention, ya know, I mean he would hang around the kids

quite a bit, ya know, and do things with em.

Antonio: I think Rich has got some other things he wants to (inaudible). I knew you didn't know that and see we didn't cover that yesterday.

Lipich: Well, I'm gettin in on the tailend of this.

Antonio: See he talked, what Ottis did yesterday was he told us several things. As a matter of fact, we had, oh probably three or four hours with him yesterday. And during the course of that period of time, he told us several things that could or could not relate to, or may or may not relate to things that he knows that we're here for. And we really didn't go into depth on much of it yesterday. Yesterday we just kind of spent some time gettin to know each other and finding out that Ottis is a pretty good old boy. And Ottis probably thinks we're all right, I don't know.

Lipich: Are we okay, Ottis?

Toole: Yeah.

Antonio: And, and we didn't spend any time lying to each other or bullshittin to each other or testin each other. We kind of got just a learning experience getting to know each other and familiarizing ourselves with each other yesterday. But Ottis made many many statements yesterday.

Lipich: Yeah. Well,

Antonio: And I thought, you know, that you didn't know that and I thought you should be aware of that.

Lipich: Well, I need to catch up on what you guys did yesterday.

Toole: Because I kept kiddin with them yesterday.

Antonio: Yeah, he did. He, he kept goin to the barbequed ribs.

Toole: Yeah. Because we, cause I had cooked people alive. I would kill them and then, cut their throat and then scatter them with some of their own blood and some of an animal that I killed, ya know, and scatter the blood all over the body (inaudible) and I can't hardly say that word, ya know. Otherwise . . .

Lipich: Which word is it that you're trying to say?

Otherwise, there'd be so many people, ya know, they would dress in different kind of outfits, ya know, like a devil worships and all this, ya know, (inaudible) you couldn't tell who the person is and you didn't even know if it was your next door neighbor or somebody that lived down the street from you.

Lipich: Yeah.

Toole: They would, dress in all kind of different kind of costumes, ya know. But it was mostly, long gowns or somethin like that we dressed in. And you couldn't tell, you couldn't see the person's face, the person's hair was covered. They would have like horns on their head and all that, and some of them was like a devil and all that. But you dind't never see the person's face, their eyes, or nothin. I mean, you could see their eyes, ya know, but, and their mouth certain extent, but you couldn't never see their face, who the person was.

Lipich: Did you dress like that?

Toole: Yeah, I dressed like that.

Lipich: How often, I mean, did you go to those kind of things alot?

Toole: Oh well, I didn't go to them too often because, shit, they would have them all over the United States, ya know, different parts, ya know. And they would mostly be out in the woody area, way out, ya know. They would have like a, like a pit or somethin, like you could burn the person in, ya know, like they'd lay down on it, ya know, and you cut the person's throat, and it would be like you'd kind of roast the meat, ya know, they would have like a grill thing they would, after they cut a person up, they would run that thing through the person and they would get like new members, they would eat other, different parts of that human, human body.

Lipich: I'm not trying to go too fast for ya, but

Toole: It was mostly ribs and all.

Lipich: I want to make sure that I understand, are you, are you saying that these things were happening and when a group of people were around, not just you and Henry, or not just you by yourself.

Toole: Yeah, it was a group of people.

Lipich: And these were all . . .

Toole: But they wasn't too many kids killed in the deal, it was mostly adults.

Lipich: Mostly adults?

Toole: Mostly adults.

Lipich: How do you feel about this kind of devil worshipping thing? Did you join them?

Toole: Yeah. I was a member. It was a, it was a like a organization, ya know. To a certain extent, ya know, but you was a member, ya know. Every now and then, they would you would get a, somebody would mail list in the mail and if you didn't kill that person, ya know, you killed so many other different people, ya know.

Lipich: OK.

Toole: It was, some of them was like a bounty hunters, ya know, like, say like you a bounty hunter and you, this person's wanted in this state, you know, and a, some of them was members of, different people was in that, ya know, that got killed, ya know, cause they dropped out, you see. See once you a member you not gonna drop out. Some of them would, now, I didn't have, some of them would like a cross in the corner between their thumb and the long finger. Like a cross inbetween there. But I didn't have, didn't never get one of them.

Lipich: You didn't ever do that?

1

Toole: Huh Huh. They said I was too much of a Devil Worship anyhow. Cause I could fit in all of it.

Lipich: Yeah.

Toole: Well, I've been doin this since I was a kid, ya know.

Lipich: Well, I was, that's what I was going to ask. Can you remember about how long you've been

Toole: Well, I been killin since I was about 14 years old.

Lipich: No, I'm talkin about the devil worshipping, going to meetings, and being a member.

Toole: I'd say I got more into that when I was starting to get to about twenty and got more into devilture. I mean I was tooken more with it.

Lipich: Yeah. Do you think that this might be part of the reason that you killed people?

Toole: I'd say it is myself. Yeah. I say it is.

Lipich: OK

Toole: It ain't much different then the Ku Klux Klans or somethin.

Ku Klux Klans, ya know, they kinda taken things in their

own hands too, ya know. But this organization, ya know,

they was a, it was a, the name of it was The Hands of Death,

ya know. Anybody that got in their hands, ya know, they

can take death on a matter.

Lipich: And the name of it was The Hands of Death?

Toole: Yeah. The Hands of Death. And some of them people had, they would like have like a hand, like a hand, on that black silk gown they had on or they would have like hands on the top of their heads, ya know, like you could see the hands on them. And there was, they wore all kind of different robes and masks and all.

Lipich: About how long has it been since you've been in touch with these people before you were arrested?

Toole: I don't get in touch with them, they always get in touch you, you don't get in touch with them.

Lipich: They knew how to get in touch . . . well, when was the last time just approximately before you got arrested that they got in touch with you?

Toole: I had a, different people tell me, well you, you ought to be at so and so place on different dates, ya know. Some of it would be like on a beach, ya know, way out there somewhere. But the biggest majority of them was in a woody area. And a, back when I was a kid, ya know, when I was back about 14, 15 years old, they had one at, they had one right here in Jacksonville they did. I mean they had several since then, ya know, different years, but I can't remember the exact years. There used to be a old cemetery here in Jacksonville, but I don't know if it's still here or not. I mean it's been years since I been out there, ya know. It was out there in (inaudible).

Lipich: Where was that?

Toole: Out in Manford. That's out towards the river, it's a old graveyard out there. I don't know if it's still out there or not.

Lipich: Here in Jacksonville?

Toole: Yeah. Here in Jacksonville.

Lipich: When you think about people that you've killed, Ottis, and you try to, if I ask you to think about a person that you killed and make a picture of that person in your mind to remember what they look like, does the picture in your mind, is it a person when they were alive?

Toole: Yeah, I can focus them back in my mind.

Lipich: Or when how you saw them when they were dead?

Toole: Well, I can focus them back in my mind when they was alive, ya know.

Lipich: Do you think that you would remember the majority of the people that you killed or just a few, or very little, because . . .

Toole: I'd say I can remember quite a bit of them back in my mind.

Lipich: Well, there's been a lot of, you've said a lot of people that you killed were people that you just shot and stuff, and I would imagine that it would be the same way if I'm going down the road and some guy on the street yells something at me and I look over at him, and I don't see him for any longer than that, then you ask me a few months down the road what he looked like I'm not going to be able to tell you.

Toole: I know when you was young, I could tell you somethin about your ownself right now.

Lipich: All right, tell me.

Toole: When you was younger, somebody would yell and cuss you you be walkin down the fuckin street you'd get after their ass, wouldn't you. See I'm readin your mind. I done read your mind. Cause you the kind a person you hot tempered yourself, once you get goin you hot tempered.

Lipich: Yeah, I guess you're right.

Toole: I done read you.

Lipich: But then isn't there a little bit of that in everybody? I mean, there's some people that are really mellow but everybody's got their boiling point.

Toole: My, my personality changes real quick. I can be, I can be mad as hell one minute and the next minute just like it ain't even happened.

Lipich: Yeah.

Toole: That's the way my mind is.

Lipich: A lot of people are like that, I can do that, I've done that before, it's just called being moody.

Toole: I mean it can be, it can, it can be people you know that ah, I done already had to wip their ass, they jumped on my ass and I turned around and forgot about it the next minute later. That's like people that I really want to ah, really get close too all the way you see. Ya see, the reason I say I can fit in all this stuff pretty good, cause shoot, I, I lived with all kinda people you know, poor people, rich

Toole: people, all the way down to the slums ya know. And so I already, even in, with wino's (inaudible) you see. So I done all ready been through all them categories and ah, I know how the taste of it is. If you ain't ever dealed in it you don't really understand it.

Lipich: That's right. That's right.Like you said before, you know, some people have been, they've been served with the silver platter all their life and they never know any different.

Toole: They ain't never got no dirt on their fingersnails.

Lipich: Yeah.

Toole: They always had everything handed to them.

Lipich: Okay, do you, I get the impression honestly, and I really, I really do that, that you want to help us here if you can.

Toole: Yeah I do.

Lipich: I got that impression from Joe and Jerry when I came in this morning and I talked to them and I'm getting the impression from you that you want to help us. So, I want to help you to....

Toole: I'd like to get all these people put to rest (inaudible)

Lipich: Yeah, and I also know....

Toole: And get it cleared up, where their people know what really, what really did happen to them, ya know. That way it won't bother them no more. Some of em, the big majority of em you tell about, that people don't give a shit if they dead or not. Once they dead and in a graveyard they don't never go back and see them anyhow.

Lipich: That's not true in this case though, I'm interested, one of the things I want to talk to you about today....

Toole: I talkin about they, ah, I talking about people when they dead ya know, their own relatives, kin to them. That's what I'm talking about.

Lipich: Oh, yeah. Well, like I say, I do, I do get the impression that you want to help us, okay? And at the same time, I know, because we're just being truthful with each other here, I know that you, you kinda got a kick out of seeing all them Hollywood guys down there diggin up the streets looking for something you knew damn good and well that there never was.

Toole: I knew where it was at all the time.

Lipich: I know, and so I'm just asking you, as a favor....

Toole: You know why, you know why I was fuckin with them don't you?

I got down there and they started fuckin with me so I started fuckin with them right back . I was fuckin with them a little bit harder, I was making it hurt.

Lipich: That's ah, that's the name of the game, ya know.

Toole: And I say, well, I done go tell this guy the truth for that kid can go on and get put to rest right.

Lipich: Yeah, Well, you know that's the important thing. There's a lot of people out there that, that ah, are never going to be at rest. You know?

Toole: That's right.

Lipich: And ah, I'll, I'll be completely honest with you, right now what happens in a court room doesn't mean shit to me.

Toole: It don't to me, cause they gonna do what they want to do anyhow.

Lipich: They're going to do what they want to do, what ever is going to happen is going to happen, but that, ya know, that doesn't mean shit to me. That's what I'm after, I'm after....

Toole: See, See myself...

Lipich:putting these things to rest.

Toole: ...myself ya know, I ain't trying to go through all this fucking publicity shit you see. I mean, at first ya know, I wouldn't try to go through all this publicity shit cause really, really, ah, it made me feel like ya know, to a certain extent ya know, all this fuckin publicity comin out, I ain't really gonna get no fair trial to start with. See now, since I done ready been, I'm done ready well known now, they done shoot me in the paper and on television and all, if I was, ah, I wouldn't never get a fair trial out of all of it anyhow. Because ah, the jury, the people has done ready read about it so much that they already got it all fucked in their mind ya see.

Lipich: Yeah, I see your point.

Toole: You won't ah, you won't ever get a fair deal out of it. I mean you won't get no fair trial .

Lipich: Tell me, what, what is it that you want out of this? I mean does spending a long time, or possibly the rest of your life in jail, does it bother you?

Toole: Tell you, tell you the truth, tell you the truth since my, since my father died and my mother died, I don't really care what happens to me.

Lipich: My mother died in 1981 too. Now and I'm, and I'm serious when I say that I know what your talking about.

Toole: I don't care what happens to me. If I know'd my, know'd my mother could come back alive right now, they could kill me, they could kill me any kinda way, it wouldn't matter.

Lipich: If there was a way to have it done it would be worth it, ya know?

Toole: I mean it don't ah, it don't really bother me you know, and I ain't really ah, I ain't scared to die cause I know I'm gonna have to die one of these day ya know. Just like when I go to sleep at night, I don't what's goin on around me. I could die in my sleep ya know, when you go to sleep at night, you don't know whats goin on around you, you don't know if somebody's in the same room with you, or somebody's around your house or what's goin on.

Lipich: True.

Toole: Well, it's really true.

Antonio: No, it, your absolutely right, you don't know.

Toole: I mean you don't know if you are just in a sleep, ya know, you don't know if you dead or not, that's all the same as bein dead. It's just the kinda thing that if you wake up you wake up, if you don't wake up, you still, you still gone ya know.

Lipich: Now, the only thing I'm tryin to tell ya is that I want you to help me, and ah, I want you to help all of us. So that...

Toole: I'm gonna try my, I'm gonna try my best.

Lipich: ...so that like you said, we can, we can put to rest some of this stuff.

Toole: I'm gonna try my best.

Lipich: And we want to help you remember because we know it's hard. ah, and, and its hard to, trying to figure out a way to do that too, because we're, we're gonna, we want to talk to you about some things that happened a long time ago.

Toole: I've been doin this shit, I've been doin it for a long time.
You figure that since 14 years old, shit, 22 years.

Lipich: Yeah, right. So, ya know, things are gonna be hard to remember.

Toole: When people ask me how many people I have killed I say ah, I killed over, way over a hundred and twenty five, I just be quessin on about a hundred and twenty five but I say way over a hundred and twenty five, ya know. I mean I can't, I can't just hit my mind into the point, cause I didn't keep no record, I didn't keep no diary or nothin.

Lipich: Yeah.

I can't pin point it down there to the point. Toole:

Antonio: Now Ottis, when you say you killed over 125 people, are

you talking about you killed alone 125?

Yeah. Toole:

Antonio: How many did ah, would you estimate that you killed with

Henry?

Well I told Lucas on the telephone, bout, about 50 or 60, Toole:

he said no I killed more than that.

Antonio: How about with someone else? Besides Henry.

Well, unless I killed em by myself. Toole:

Antonio: What about, didn't you kill them with Jack Smart also?

That name keeps comin up all the time, all the time. Toole:

Antonio: Well, I think your a little nervous about Jack. Are ya?

It does shake my nerves, I can't figure out who he is dead Toole: in my mind. I might know him if I seen him, but the name don't hit my, the name don't hit me ya see. See now, when [first met Lucas I wasn't really sure that Henry's name

was really Henry Lucas you see, but it really was, it

really is Henry Lucas.

Antonio: Yes, it is.

I mean I wasn't sure and all when I met him , but I kept Toole: tellin my mother all the time, I said, I said they get ah, I mean ah, I told her one time, I said I could (inaudible) but she said no . See Henry was, I was in love with Henry you know, Henry was a gettin on my nerves to a certain extent . Henry could lead me, Henry could lead me to do anything, all he had to do is say it, but Henry could say

what he wanted and I would do it (inaudible) just like that, and I, I still do, I still love Henry

Antonio: I know that.

Toole: I do.

Antonio: I know that, we talked about that yesterday. We talked about that particular relationship. Even though you're miles apart that doesn't stop the love. It doesn't stop the relationship.

T mean if he did kill my neice, you know, that's still, but Toole: ah, it still, it still puzzles me to a certain extent about my neice ya know, cause ah, I ain't seen no pictures of her dead or anything ya know. I seen pictures of him in the paper, rights ups in the paper you know, that I got different people to read to me ya know. I mean I had a whole pile of these clippings in my cell over there and one of them fuckin officers took all that shit out of my cell over there, clippings I had.

Lipich: Oh yeah?

Because shoot, when I traveled around, ah, I tripped with quit a bit people ya know, I mean I don't, they tell me their first names (inaudible) I done forgot about their first names but I can remember the person in my mind, ya know. If they was any good or if they was wore out.

Antonio: Well we got the impression that ah, you know, that, I'll just go ahead and leave it.

Toole: Maybe he was the leader in some of that.

Antonio: Of the cult, or what? I mean, the leader of what?

Toole: The Hands of death. Maybe he's got something to do with it. That's why maybe Henry told me not to come in contact with him. Because he probably wanted to, ah, wanted to fuck me up or somethin.

Lipich: Didn't Henry, ah, was, wasn't Henry into this devil worshiping thing?

Toole: Oh yeah, Henry was in that too, to a certain extent. But

He's done cut the person open and fucked em and all that shit. And I have been right there with him when ah, when he killed a person, cut the throat, cut them open and all that shit. Have sex with em before and after they was dead. (inaudible) and I asked Henry ya know, when I talked to him ah, on long distance, is my mind normal ya know about it, when we take some people, parts of different people on the bed ya know, when they're cut up, and I tell him if my mind was normal and he say ah, I was just ah, other people would think ah, that ah, we was more devil worshipors and ah, we would, we was more like cannibals ya know, we don't classify it like that ya know, (inaudible) in my mind. And different times when I done fires ya know, burn up things ya know, I burned people alive in cars, in trucks and all that shit, burned down and melt doors and all in a house and burn the fuckin person alive in the fuckin house. I done that before too.

Antonio: Ottis, you told me yesterday that you really didn't

have any one certain way.

Toole: Yeah.

Antonio: And also, that you really didn't have any one certain on how you got hold of these people. You told me that, occasionally you'd just be drivin down the street, see somebody walkin, grab them, pull them there in the car

away with you.

Toole: That's right.

Antonio: You told me that you picked them up in bars.

Toole: Yeah.

Antonio: You told me you just picked them up hitchhiking.

Toole: Yeah.

Antonio: You told me that you may just be drivin down the street and see somebody out in their yard, stop, honk the horn, wave at them, and have them just walk up, and just kill them and drive away.

Toole: One time, that's it.

Antonio: Ah, so there was really, but it seems like most of the people . . .

Antonio: That was a normal thing.

Toole: I'd just say that was a normal thing, ya know, because I done it all these years, ya know, until, I done already had it stabalized in my mind, and it's normal to do that. But really, when I was doin all this stuff, I would make quite a bit too (inaudible).

Toole: They say, different people say they don't know what they're doin when they're drunk but they do. They just make that for an excuse to cover up because of they have to.

Antonio: When you pulled into a town, did you have more of a tendency of trying to get on an off ramp right in the downtown area as opposed to the outskirts or was there any particular way?

Toole: (Inaudible)

Antonio: Did you go on the off ramps, did you just . . .

Toole: I tried, when I'd go somewheres, if I go to a big city or somethin, I try to play it, I try to pay attention to where I gettin off at where I can get back on. And I try to not go too far off from the area where I can't find my way back, ya see. I do get lost pretty easy.

Antonio: How far would too far be?

Toole: I'd say maybe, ah, not over maybe three or four miles.

Antonio: Would you say that you took more people from right close to the highway or a mile or two away?

Antonio: Did you, did you prefer the downtown areas more or did you prefer the suburbs area.

Toole: I say the suburb areas, more.

Antonio: Do we to give Ottis a break? Bathroom, stretch your legs?

Anything like that?

Toole: Yeah (inaudible).

Antonio: You do understand that? OK, do you still understand that you have the right to remain silent?

Antonio: Do you also recall that you have the right to talk to a lawyer and have him present with you while you're being questioned?

Toole: Yeah. I understand that.

Antonio: And you do understand that if you can not afford to hire a lawyer, one will be appointed to represent you before any questioning if you wish?

Antonio: And you could be represented by the public defender?

Antonio: And still having these right in mind, do you wish to continue on talking to us?

Lipich: And then I'm going to ask you without showing you anything further if you can give me as much detail as possible. Now I know, OK, I want you to understand that I know that what I'm asking is going to be very difficult for you.

Toole: Yeah.

Lipich: But, possibly, if you see the girl's face and you recognize that girl then something will, then all I want you to do is tell me, ya know, anything that should come up.

Toole: 'cah.

Lipich: Ottis, this is a, I'm going to show you two pictures here. And they're both of the same girl.

Toole: Yeah.

Lipich: The reason I'm showing, gonna show them to you both, is because to me, they look different, and it's simply because in one photograph she had her hair fixed up and it was obvious that she fixed herself up to go take this photograph. The other one's a driver's license photo, and it looks like probably her hair wasn't as fixed, fixed as nice, and she may have been busy that day or whatever. But it's both the same girl.

Toole: Hum. (long pause) I can't hit nothin.

Lipich: I'm sorry, I didn't hear you.

Toole: I said I can't hit nothin in my mind.

Lipich: Huh Huh. Ok on the back side of this sheet, Ottis, there's some pictures of the girl. Let me get around here where I can show ya. These are family pictures. That's her, and this is her, and this is her, and this is her, and this is her. These are different periods of time, taken with family and so forth. She looks a little different in each picture. Her hair strie's a little different and so forth.

Toole: (long pause) It's no hittin my mind. (long pause)

Antonio: Rich, do you know if she was wearing glasses that night?

Toole: [got my mind on somethin, but I can't quite get it.

Lipich: Well, let's come back to it. Let's come back to it ah, some of these photographs aren't going to help you because they're keyed in on such a small area. There's a...

Toole: (long pause) I say we got rid of it the same night.

Antonio: Are you sure of that or are you just guessin?

Toole: I ain't guessin, I'm sure of that. (pause) No, I ain't guessin.

Toole: Oh, I'd say I did, yeah.

Antonio: Why do you say that, Ottis?

Toole: Well, I try to figure it out if he was or he wasn't. I can't really I try to draw a picture in my mind out the rest of the way. See Henry's got a habit of puttin' people in garbage bags, and I don't. I don't put 'em in garbage bags. I do barely once in awhile but not too much. 'Cause a person they would rotten quicker out in garbage bags than they would in garbage bags. I have, but not too many. But this could be one that I put in it, in a garbage bag. See I tryin to picture that in my mind too.

Antonio: OK. Look here again now. Because you told us earlier all right? That you had, that you put her in garbage bags.

Toole: Yeah, I did.

Antonio: All right, bags.

Toole: Yeah.

Antonio: All right. That means

Toole: Scatter her apart, different parts of her.

Antonio: Oh, is that what that mean?

Toole: Yeah.

Antonio: You would put her parts in different places?

Lipich: Okay, that's fine, that's fine. It's probably best not to make any guesses, if you don't know, don't be afraid to tell me, just tell me that you don't know because that's understandable.

Toole: I won't.

Lipich: Okay, ah, Do you, this question has been asked, ah before and I'm asking it again because maybe something that we've said in the mean, mean time has jogged your memory a little bit. Do you, do you remember what the circumstances were ah, how you, how did we put it before, how you made contact with this girl, how you picked her up, how you got ahold of her?

Toole: Well, I have bumped into their car, and if their havin car trouble and ah, I offer to come and give them a ride or somethin like that, it could have been on, on the same deal as this ya know.

Lipich: Okay, you say you have done something like that before and this could have been something along the same lines but you don't recall exactly with this girl.

Toole: No, not exactly, no.

Lipich: ∪kay, ah, you've said that you, you hit the girl.

Toole: Yeah.

Lipich: Ah, let's just go back over that, did you, again another question that's been asked, ah, and I'm not tryin to be pushy, I just, I'm hoping that things, you know, things will come out. Did you hit her with something or did you just hit her with your fists?

Toole: Ah, the biggest majority of them, I always would slap them, slap them around ya know.

Lipich: A-huh. Did you slap them around hard enough, I mean when you say slapped them around, did you slap them with your open hand or would you hit them with your fist hard enough so that....

Toole: Well I've done, I've done both, ya know.

Lipich: You've done both. Have you ever hit any of the girls with an object of some type?

Toole: Yeah, I have, yeah. I have hit em in the head with a gun before, ah....

Lipich: Okay, do you remember anything, and if you don't, that's fine, do you remember anything specifically about this girl, whether or not you did strike her or hit her, and whether or not you hit her with something?

Toole: I could have, I ain't dead sure.

Lipich: Okay, you're not sure about that. Okay, ah, now you've said that, It's stopping, you wanna check that plug?..
You said that you remember ah, putting this woman in ah, garbage bags.

Toole: Yeah.

Lipich: Now, is that something that you think happened, or are you pretty sure about that?

Toole: I'm pretty sure about that.

Lipich: Okay, ah, do you remember how many different garbage bags you put her in or did you all, put her all in one, or did you put her in several? And if you can remember specifically how many, tell me, if you can't remember, that's okay.

Toole: I can't remember.

Lipich: Okay, we talked a little bit before, ah, Officer Antonio talked to you about how you cut this girl up, and you

talked to you about how you cut this girl up, and you were very specific, pointing out different areas on his body where you cut her. And I just want to make sure that I understand it correctly. You, you are pretty

sure....

Toole: Yeah.

Lipich: Correct me if I'm wrong. You are pretty sure that you

cut her head off?

Toole: Yeah.

Lipich: Her arms off.

Toole: Yeah.

Lipich: What did you say about the hands?

Toole: I have chopped the hands off to the joint, and I have

left the hands on different ones.

Lipich: But do you recall on this girl? One way or the other, or

at all?

Toole: I'm pretty sure that I did cut it off at the joint.

Lipich: OK. And then you said that you also cut her legs.

Toole: Yeah.

Lipich: Was there anything else that you cut off of her? Earlier

earlier you had made mention, I don't whether you said Henry did it or you did it, that you had made mention of

cutting the tits off.

Toole: Yeah.

Lipich: Was that the case with this girl or not?

Toole: I can't quite remember. If I did or not.

Lipich: OK. Thinking specifically of this girl that was killed,

you said that you would have probably gotten rid of the

body the same night or the same day that you killed her.

Toole: Yeah.

Lipich: Do you recall that for sure? Or was that just a guess?

Toole: I'm pretty sure that it was the same night.

Lipich: OK. In any of your, the women, or the men, or the people

chat you've killed.....

Toole: I don't like haulin them a long distance.

Lipich: Oh yeah. OK. In any of the people that you killed, have you ever kept either the body or parts of the body for a period of, you know, more than just the day that you that you killed them. You know, say for two or three

days?

Toole: Nah.

Lipich: You've never done that?

Toole: Nah.

Lipich: OK. Now you have talked about fileting and made mention

of grinding one persons one time?

Toole: Yeah.

Lipich: Have you ever done anything like anything to preserve part of a body so that you could do this the following

day or two days later.? In other words, the parts of a body that you may have grinded up, did you, did you have them kept someplace in a, in a refrigerator type

setting, where it would stay preserved?

Toole: No, I would get rid of them, I would. I wouldn't keep

their body.

Lipich: OK. You've never done that with anybody, or any of the

people that you've killed?

Toole: No.

Lipich: OK. All right. Is there anything that you can tell me

....Is there anything that you can tell me, Ottis, that you can think of? I've been asking all these questions and I know that that's hard for you. And you've been sitting there thinking about this whole thing. Is there anything you can think of that would help me? You know, like the, like you told me a little while ago that that guy that came in and talked to you from Colorado, and on that killing in Denver where you said something about you

shot her through the window or something like that?

Toole: Yeah.

Lipich: You said that you gave him all kinds of details. You just spelled it out, and these officers from Hollywood

that came in this morning, you ah, after some careful thinking about it, you provided them with some really good detail on stuff. Is there anything you can, I want you to help me. Is there anything that you can think of? Any little thing at all. It may not even seem important to you, it may ring just the right bell with me. Is there anything that you can think of about this girl that you killed that would be a detail, you know, a thing that I

can relate to?

Toole: No.

Lipich: OK. So basically what you're saying is that you did

kill this girl,

Toole: Yeah.

Lipich: But that, this girl was many, or one of many people that

you killed and you don't remember, or you remember little,

or very little about the details?

Toole: Shit, if I could remember all the details, I'd be a genius.

Lipich: Sure. Sure.

Toole: I ain't trying to be cute or smart.

Lipich: No, and I'm not trying to be pushy. I'm really not.

Toole: And I have fucked them before, I have. I fucked before,

before I killed em, and I have fucked em after they was

dead.

Lipich: OK.

Antonio: Ottis, one thing you might remember, and I think you might

remember this. You know, you took this girl, you apparently

had her in your car, your truck or something?

Toole: Yeah.

Antonio: Maybe Henry's with you? You took her, you know, you may have fucked her, you may not have. You may have had her

give you oral sex or head, or you may not have, but the

one thing that you did do is cut her up, right?

Toole: Yeah.

Antonio: Where did you cut her up at? Where were you, what location?

Were you in a house, were you in a motel, were you outside, were up a tree, were you, where were you when you chopped

this girl up?

Toole: I say outside.

Lipich: Do you remember specifically? Or are you guessin?

Toole: Just guessin.

Lipich: I know it's hard for you. I'm gonna give you a little

bit of time to collect your thoughts. (pause) We're going to look at some pictures now. You told, ah, told Officer

Antonio that these don't bother you, right?

Toole: Huh huh.

Lipich: I'll let you look at both of those together, because, ah,

their both the same photo, just a.....(long pause). OK,

have you taken a real good look at those?

Toole: Yeah.

Lipich: This is still another angle of the girl's head. For the records, the photo that Ottis is looking at now are two photos, both of the head of this girl. And they're just different angles of the same photo. Is there anything

about this photo that you're looking at that looks familiar to you, a certain thing about it that you can

relate to, or that you can recall having done specifically?

Toole: Look like she was cut up in the face. (pause)

Lipich: OK, you made the comment that it looks like from the

photograph you're looking at that she was cut in the face.

Toole: Yeah, but you can't really tell about that.

Lipich: OK. OK, is the fact that she was cut in the face, or if in fact she was cut in the face, does, does that tell you

anything about whether or not....

Toole: Oh, I have done that before, hittin em, hittin them in

the face.

Lipich: OK. I've got a lot of pictures here to show you. Maybe one of them will stimulate you a little bit. This is

a photograph of, an evidence photo, of the backside of the torso. Tell me anything that comes to mind while you're looking at that photo. (long pause) Is there anything about that photo that looks familiar to you in

terms of the way you killed her? (pause)

Toole: Well, at night you don't pay no attention to a certain extent how you cut, how you cut a person all up. Not less

you in a house or something like that. And I wouldn't be in a house cuttin up somebody, if I'm gonna kill somebody,

I pretty well do away with them right there.

Lipich: OK. Let me ask you this, Ottis. Did you cut this head off?

Toole: I say I did, yeah.

Lipich: Do you feel very certain of that?

Toole: Yeah.

Lipich: OK. And did you in fact, cut this torso the way it

appears here in this evidence photo?

Toole: Yeah.

Lipich: Do any of these cuts, and the manner and style, I realize that it's very hard for you to look back, especially at that period of time, and remember exactly how you cut somebody, but do any of these marks on her body recall to you, or bring back something to you that you can

remember specifically?

Toole: (pause) Well, when I cuttin up all different, different ways, Idon't know, I mean, and leave the rest of them there, I have sliced them up all different parts like that.

Lipich: Now you have said, yes I cut this head off, and yes I cut this torso.....

Toole: Yeah.

Lipich: Why can you say that, how can you say that so positively?

Are you, what makes you say?

Toole: Well, the hair, the head's done, the way the head's cut off, I have cut people's head off like that. And so it does it does fit my pattern.

Lipich: OK. I'm not questioning the fact that you did it, I just, I want you to tell me, you know, why you look at the photos and say yes I did that.

Toole: Well I cut, cut the heads off pretty close down, I would never cut them way out mostly. (inaudible)

Lipich: OK.

Antonio: Ottis, yeah, that's what I want, look at me, check me out.

Did you cut that girls head off?

Toole: Yeah.

Antonio: Is that the girl's head? That you cut off? For sure?

Toole: Yeah, yeah.

Antonio: Now you tell me why you think you cut it off.

Toole: Because that, that's the pattern of style that I cut peoples heads off.

Antonio: Okay. Show me where you hit her with the machete.

Toole: Like I said, back in there.

Antonio: Okay. Was she layin down on her face? Or on her back?

Toole: She was layin on her face

Antonio: Okay, you remember that you told me that you had to turn

her head a little bit?

Toole: Yeah, I did.

Antonio: Which way did you turn her head?

Toole: Kinda sideways.

Antonio: Which side?

Toole: On this side.

Antonio: Okay, so you're goin this way? So is this part of the face

up?

Toole: Yeah.

Antonio: Now you tell me you did this.

Toole: Yeah.

Antonio: Now, look up here at me now, alright? You tell me you did

that, but you tell me that was Henry's style.

Toole: Well, Henry does do it like that, generally he does.

Antonio: Did you do that?

Toole: I have done it like that, yeah.

Antonio: Did you do this one?

Toole: I'm pretty sure I did, I'm real sure of it.

Antonio: Tell me what in there, tells you that you done this one.

Toole: Cause I know in my mind that I done it.

Antonio: No special marks? You did this one?

Toole: Yeah.

Antonio: Why did you open that back up like that? Did you ever open

one up like that before?

Toole: Yeah, I have started to cuttin up the back like that, I've

cut em up the back before.

Antonio: Why, why are you doin that?

Toole: Well, sometimes when I get cuttin, I just get, start cutting

all kinda ways after I get goin.

Antonio: Okay, okay. How about this down here? You remember what you

told me the other day?

Toole: Yeah.

Antonio: About that particular area?

Toole: I said I told you I don't like to ah, really fuck somebody

in the ass.

Antonio: I know that, I know that, but you did tell me that you cut

the ass out sometimes, didn't you?

Toole: Yeah.

Antonio: And do you remember how you described it to me? How you

did it? You said sometimes you went right for the piece.

Toole: Yeah, yeah.

Antonio: And other times you butchered it out like a hog.

Toole: Yeah.

Antonio: What is that?

Toole: That's butchered out like a hog.

Antonio: Where's those hands cut off at?

Toole: Towards here, down here, like I said. Towards the joints.

Antonio: What would make you think that you cut those hands off?

Toole: Well, I've chopped them off like that before.

Antonio: But if I was going to take somebody's hands off, which I've

never done, I would take them off right at the joint too.

Toole: Yeah.

Antonio: So are you telling me there's nothin special about this,

that you know about?

Toole: Yeah.

Antonio: Okay, your not telling me that? Or you are telling me that.

Toole: That's just the way I done it.

Antonio: That's just the way you done it huh. Did you ever make cuts

like that before?

(pause) ... and the titties cut off too. Yeah. Toole:

Tell me how you described that to me yesterday, how you Antonio: cut the titties off.

Sometimes I would cut the nipples off and then cut around, Toole:

the whole part.

Antonio: Did you always cut the nipples off?

Not all the time. Sometimes I would ah, it wasn't too often Toole:

that I would ah, cut them around like that. I'd mostly cut

the nipples off.

But when you told me that you cut the titties off, what you, Antonio:

remember I had you draw on my chest, where you would cut

them and you went clear up around here like this...

Toole: And I said around, yeah, just like this.

And what you just demonstrated on yourself, is clear out Antonio:

around, wasn't it?

Toole: Yeah.

Antonio: Now take a look at that.

That's the same way. Before I even looked at the picture. Toole:

Antonio: Okay, when you were doing it to me yesterday, you were

clear out around, remember?

Your right, and that's clear out around, the same way. Toole:

Is there anything special there that you remember? Antonio:

Toole: I sure, I sure butchered her!

That you did! Do you understand I ain't mad at you? Antonio:

Toole: Huh?

Antonio: Do you understand I ain't mad at you?

Toole: Cause I told you the truth., didn't lie.

That's right. Cause you told me the truth. Antonio:

Toole: And her pussy was cut out too.

Antonio: What did you tell me you done with that?

Toole: Throw'd it up in a tree on purpose somewheres.

Ottis, going back to this picture, you said that you cut Lipich:

the head off with a machete, right?

Toole: Yeah.

And the arms, legs, I assume you used a machete also. Lipich:

And I have used a butcher knife too. Toole:

Okay. How did you cut those breasts out? Off of there? Lipich:

With what? Was, was it with the machete, or ...

The machete would be too big. You would have to use the Toole:

butcher knife.

Do you remember specifically using a butcher knife on Lipich:

this girl, on the torso that you see in that photograph?

Toole: Yeah, I'm pretty sure. I'm dead sure.

Lipich: What did you....

Cause I kept all kinda stuff like that in the car, butcher Toole:

knives, machete's, twenty two pistols, twenty five automatic, shotgun, I used to keep all that kind a shit in

the car.

What did you ever do with all that stuff? Lipich:

I got rid of all that stuff. Buddy knows all that too, cause Toole:

I told him.

Okay, take a look at some of these photo's, there's ah, Lipich:

they're in color.

Toole: The feet was left on wasn't they. I said sometimes I've left

the feet on.

Do you remember putting those ah, now that you've looked at Lipich:

these photo's, again, I'm not tryin to push you, I'm just asking you because we, we've gone a little farther and maybe your memory has gotten better. Do you remember putting those body parts in those bags? Let me show you this photo.Do you

remember puttin those body parts in those bags?

Toole: I'm pretty sure I used more than one bag.

Lipich: Okay, I....

Toole: That's only one bag there.

I, we both know that you probably can't put a whole body in Lipich: one bag, but what I'm asking is if you, if you can think in

your own mind and actually remember, going back to that time even though it was a long time ago, now that you've recalled

Lipich: ...and you said that you did kill this girl, do you, can you recall in your own mind actually taking those body parts

and placing them in that bag?

Toole: I'm real sure that I did. Dead sure.

....

Lipich: Okay, but do you remember specifically doing it, I mean can you think in your own mind, just like you were back there now, and can you remember actually placing the body

parts in the bag?

Toole: Yeah.

Lipich: Okay, now I'm going to ask you, and I want you to keep thinking that way, I want you to think as if, as if you

are doing it right now,...

Toole: Yeah.

Lipich: Was there anything else besides this girls body that you

put in those bags?

Toole: Anything else? I don't know exactly.

Lipich: Okay, think hard about it, think real hard and ah, in doing so, you know, like I say, try to go back to that time and remember actually, ya know, opening the bag, puttin it in,

ъh,

Toole: Maybe I was stupid and I put the butcher knife in there.

Lipich: Well, did you put the butcher knife in there? Or didn't

you.

Toole: I have, I have misplaced butcher knives sometimes, and tried to find the damn thing and couldn't find it. I could have

done it on this one.

Lipich: Oh, really?

Toole: I could have. I ain't really dead sure.

Lipich: Okay, but you don't, you don't know for sure.

Toole: Well, I generally try to keep all that, all that stuff

together without losing it.

Lipich: Do you remember anything else that you put in that bag?

Anything at all?

Toole: No.

Lipich: Okay, I want to show you another picture here. Now this is of the bag with the legs and arms are in and you can

see in these photographs that there are other things....

Toole: The fuckin clothes are in there. I see that.

Lipich: Also there's this. What is that?

Toole: Look's like a piece of fuckin pipe, don't it?

Lipich: Do ah, do you know what it is? I ah, I know that you can look at the photograph and tell me what it looks like it is, I can do that and Jerry can do that, uh, and ah, Joe Antonio can do that but I'm asking you if you can remember from personal experience what that is.

Control

Toole: Can't remember.

Lipich: Okay. Okay, if I told you that that....

Toole: You probably say it was a pool stick.

Lipich: Huh?

Toole: You probably say it was a pool stick.

Lipich: No, it's not a pool stick.

Toole: Not a pool stick.

Lipich: Okay, I'm going to tell you what it is, and ah, I'm going to ask you if you remember, and remember it being there and if you remember it being there then I want you to tell me how it came to be there. It's a ah, it's the shaft of a golf club.

Toole: The shaft of a golf club.

Lipich: And actually the ah,...Do you ever play golf? Have you ever in your life played golf?

Toole: Yeah, I've played golf, before, minature golf.

Lipich: Okay, well then you know how, you know the difference between a putter and a....

Toole: That's what she got busted in her head with wasn't it?

Lipich: I....

Toole: You ain't gonna tell me.

Lipich: Well, to be honest with you, I don't know. Nobody does, except for the person that was there. So I have to ask you that question. I have to ask you that question, was that what she was hit in the head with? And did you hit her in the head with that golf club?

Toole: Well, I told you awhile ago I didn't know what it was.

Lipich: Well I, I understand that and I'm not trying to push you into saying anything that you don't remember, if you don't remember, that's fine. I'm just hoping that as we go along, you remember things. You know, that's what we've been talking about all day, that things hit you and it starts coming back to you. (pause)

Toole: Yeah, I'm pretty sure I hit her in the head with that.
I ain't just sayin that cause I seen th∉ picture. It
wouldn't be there if I didn't do all that other shit.

Lipich: Where would you, you've said that you've, you rode around with butcher knives, and machetes and guns and pistols and everything in your car....

Toole: But it's kinda hard for me to place that golf thing.

Lipich: Where would you, where would you get the golf club?

Toole: (inaudible)

Lipich: Did you have something like that in your car?

Toole: Huh.

Lipich: Where would you get something like that? I mean do you remember anything?

Toole: I don't remember. I ain't gonna lie about it, I do know it was mine.

Lipich: OK. You've already seen that there's clothes in that bag and you've made the statement that, ah.....

Toole: Sometimes I throw the clothes away and sometimes I left the clothes right there (inaudible)

Lipich: OK. You've seen these black and white photos and you've seen the clothes kinda laying in a heap there, ah, do you remember in your own mind, do you remember what this girl was wearing when you killed her?

Toole: No.

Lipich: Do you remember colors?

Toole: No.

Lipich: OK.

Toole: I ain't gonna lie about it.

(m)

Lipich: OK. My next question is, ah, you've said that you remember using a machete to cut her up and you've also said that you remember using a butcher knife to cut the tits.

Toole: Yeah. I said that too, yeah.

Lipich: OK. Did you use, or can you remember using any other type of instrument, weapon, ah, or anything? Did you use anything besides the machete and the butcher knife?

Toole: No.

Lipich: Are you absolutely sure of that?

Toole: No I ain't dead sure.

Lipich: Are you absolutely sure that you killed this girl?

Toole: Yeah. I'm sure.

Lipich: The time right now is 2:40 p.m. and we're still on the 20th of November, Sunday, and I'm going to shut this tape recorder off for just moment and we're all going to take a little bit of break because I think I've been hittin you with questions right and left, and ah, I'm sorry to do that to you.

Toole: I understand.

Lipich: OK. You've been more than cooperative and I appreciate everything. But we are going to take a break now. Ah, 2:40 p.m.

THE REMAINDER OF TAPE 3, SIDE 1 IS BLANK, FOR UNKNOWN REASONS THE REMAINING PART OF THAT INTERVIEW DID NOT RECORD.

(Tape 3, Side 2. The date is now 11-21-83)

Lipich: Ah, I know that that's hard.

Toole: OK, I'll unseparate it in my mind.

Lipich: OK, let's go back to, to some points that you do remember, or that you said yesterday that you remember, because we talked a little bit about the way that you chopped this girl up, OK? Can you tell me again how she was chopped up? And....

Toole: Keep on, after awhile I'm gonna tell you I ain't killed her.

Lipich: What's that? What's that, Ottis?

Toole: You're confusin me to a certain extent. You wanta go back over and back over and back over.

Lipich: Well I'm, I realize that I'm pushing you a little bit, OK? And ah, I'm not trying to confuse you.

Oh, I remember all the details, I tell you dead in my mind. I chopped her head off, I chopped her arms off, I chopped her hands off, ah, I cut her breasts off with a butcher knife, so where I killed her at, I took the parts to somewheres else to another place and dumped them, got rid of them.

Lipich: OK. Can you try for me to remember where, or anything about that place, where you dumped the body, or parts of the body?

Toole: Side some mountains, like. Down a rocky road, or dirt road or whatever you wanta call it.

Lipich: Do you remember being there?

Toole: If I hadn't been there, I wouldn't

Lipich: The reason I ask.....

Toole: [wouldn't a tooken the body down there. (pause) See but I, but I messed up all that other case, they kept going a repeat and a repeatin, and kept gettin turned around on different stories.

Lipich: I know, Ottis, and I, I'm having a hard time dealin with how I should talk to you, OK? I don't want to make you mad at me. I'm really not trying to do that. I, we sat here for a couple of days now and I think we've gotten along pretty good together, 'don't you? If you don't think so, tell me. Because you know, I think that we've treated you right, and you even said yourself, I don't want you to confuse us with some of the other officers that you've talked to, you've even said yourself, that we've been alot easier to talk to than some....

Toole: Ya'll have, yeah.

Lipich: But I can't lose sight of what the reason is, and what the purpose is for me coming here, and I, ya know, I need to ask you these questions. And the only reason I'm asking you to go over certain parts of it is to help refresh you memory, because I think you're being truthful with me, ottis, I just think that you're having trouble remembering, and I think that you've done that in other cases.

Toole: You're trying, you're tryin to get ever little detail, is what you're tryin to do. You ain't gonna get ever little detail.

Lipich: No, I'm not trying

Toole: You'll get close to it, but you won't get ever little detail.

Lipich: Well, that's all I'm trying to do is get close to it.

Toole: Well, you done gotten real close to it already.

Lipich: Well, I guess you're right, I guess I'm looking for detail. That's, I'm sorry....

Toole: You, you lookin for all, ever little detail.

Lipich: No, I'm not looking for every little detail, I'm looking for some detail. Ah,

Toole: Well, the way you do it, you looking for ever little detail.

Lipich: OK, tell me how to do it. I'm serious now. You tell me, ah, I won't ask you one question. You just tell me everything that you can tell me about this case and I'll shut up and I won't ask you another question.

Toole: Well, she's all chopped up, you got the body and all, what do you want me to do, you want me to chop myself up and give you a meat tray? I could do that too. (inaudible)

Lipich: What's the matter today, Ottis? (pause) Forget all this for a minute. What's the matter today? Because we seem to get along pretty good yesterday and all of a sudden to day you, you act like you're getting mad because I want to talk to you about this. What's the matter? Did something happen before we came in the room? Did those did the other officers you talked to get you mad or have I gotten you mad?

Toole: No, I already gotten it pictured in my mind, I bout gave you all I can really give you, ya know.

Lipich: I understand that. I understand that. Just do this favor for me, OK. I have never once thought bad about you for anything you've done, or.....

Toole: I don't care if you do or not.

Lipich: I know you don't. I know you don't. But give me the same courtesy. I mean, you know, give me the same thing back. Don't think bad of me for the job that I have to lo.

Toole: Fuck ya.

Lipich: I have to do this.

Toole: Yeah, but the way you doin it, you won't let me get all your cases solved. You're lookin for too many details. Dead to the fact. I ain't tryin to play games with ya, I'm tryin to be honest with ya, dead on the nose.

Lipich: Well, that's what I think you're trying to do. And I'm not for a minute saying that you're not being honest with me.

Toole: I ain't not.

Lipich: I have not said that you're not trying to be honest with me. I think you are being honest with me.

Toole: Well, I pictured it in my mind last night, ya know, I said, I had told ya about all I can really tell and dead to the point of it. Dead all the way to it.

Lipich: OK. All right. Let me, ah. Let's get off that for a minute, OK? Let's, that's gettin old, and I'm not going to push you anymore, and, I think you're right.

Toole: Oh, I can keep through it and that's why, it starts changin and changin, ya know. I mean, that's the way, if somebody keep hittin me on the same case, case, on the same case over and over, I start makin it change in my mind the way I want it to change, the way the whole thing be all screwed up.

Lipich: OK. Let's just don't talk about it anymore. If that's what you want to do, that's fine with me, you know, I ain't trying to push it. I got another, a couple of cases and ah, I'll ask you about them.

Toole: Yeah.

Lipich: OK? I think you've been truthful with me all along, I don't have any problem with it so I'm not going, I'm going to go into any heavy questioning or anything like that, I'm just going to tell you about these cases and ask you if you done it, OK? One girl, ah, was shot. And she was shot right here in the center of the chest.

Toole: Yeah.

Lipich: She was shot by a man that was driving a car, drove up in front of her house, she came out of her house...

Toole: Shot her and left.

Lipich: Shot her and left.

Toole: Didn't do shit.

Lipich: I'm sorry. You didn't do that? Is that what you said?

Toole: No what I was tryin to say whoever, the person whoever shot her, they shot her right there and left, they didn't do anything, they just (inaudible). I done shit like that before too.

Lipich: Yeah, I know. We've talked a little bit about some of those that you did and that's why I'm asking you about this girl. Ah, again I'm asking you to think about this, but can you relate any like that you've done with the same area where you killed this, where you chopped this other girl up? Meaning Pueblo, Colorado?

Toole: (pause) I ain't sure.

Lipich: OK. That's fine. That's fine. Let me show you a picture of this girl and see what, see what you think, OK? Have you ever seen that girl before? Does she look familiar to you at all, Ottis?

Toole: Nah.

Lipich: Not at all? There's another picture of her on the other side, just a different shot of her.

Toole: (pause) Nah.

Lipich: OK. Do you remember, I know that you've owned a lot of cars, a lot of different kind of cars. Do you ever remember owning a Mustang? Did you ever own a Mustang?

Toole: Mustang?

Lipich: That was kind of along this style here?

Toole: A Mustang.

Lipich: Yeah. You never owned a car like that?

Toole: I never did own a Mustang.

Lipich: The pictures you're looking at now are how the body of this girl was found, and of course, she was found immediately.

Toole: Nah. Never did own a Mustang.

Lipich: OK.

Toole: I don't like small cars myself, I like big cars.

Lipich: You like big cars?

Toole: Yeah.

Lipich: OK. I believe you. OK? You're doin fine.

Toole: A little car ain't nothin but a impact car. You can

get run over quicker. Cracker box.

Lipich: OK.

Toole: That what I call them, cracker boxes. I want somethin what got some room, I want do somethin, (inaudible).

Lipich: All right. Let's forget that one.

Toole: Well, it's just as well to, cause I didn't do that one.

Lipich: Yeah, that's fine. We've also got a case in Pueblo that involves the killing of an older man and he was, he was beat on the head with some kind of a blunt instrument, we don't know what. But he had a lot, it just cracked his skull and he was left at his house, lying in the back yard. At least that's where he was found. Ah,

Toole: I can't even get my mind on that. Let me see what you've

got.

Lipich: The only photo's I've got....

Toole: see if anything can jar me, she if it'll jar me or if it won't jar me.

Lipich: OK, the only photo's I've got Ottis, are, photo's of his body, I don't have a photo of him when he was alive, and these are a little bit difficult to see what he looked like exactly, but this is how he was left laying in the yard.

Toole: I see, somebody done beated the fuckin hell out of him didn't they.

Lipich: Yeah.

Toole: Is that the back of the house?

Lipich: This is the ah, the back of the house and this is the ah, how the house looks from kinda the front and side.

How the house rooms from Armad the from and brace

Toole: huh-huh

Lipich: None of that looks familiar to you?

Toole: Not a bit of it.

OK. This ah, this man is a little older than some of the Lipich: people you've talked about killing ah, did you ever, have

you ever killed anybody that old?

I don't even know how old he is. Toole:

Well, let me... Lipich:

I don't pay no attention to the age of people, I just... Tcole:

Let's see, he died in 73 and he was born in 04, that was Libich: ten years ago, he was about ah....

Antonio: 59.

59 years old, almost 60 years old. Lipich:

Oh, I killed em that age, yeah. I didn't kill this one Tcole: though.

OK. Lipich:

Antonio: Are you getting tired?

Toole: Oh, I'm alright. I been tryin to get them to move me, I been tryin to get them to put me back in population.

That's gonna be hard Ottis. That's gonna be hard. Antonio:

(inaudible) it don't make a difference if somebody wants Toole: you it don't make a difference if you're locked up by yourself, they gonna get you either way you go.

Antonio: Now, let me try and jog your memory.

Toole: Alright.

Antonio: I don't want to get you confused. Do you remember something

about your momma and the 38?

Toole: Well, I had a 38 back in them days, and ah, she hit the

trigger on it and ah, I forgot and I left the safety off of it. But back then I was on more a 38 than I was a 22

or a 25, back then. And that's why I say a 38.

Antonio: See, you're doin really good. You're doin really good. Now,

let's calm down a little bit and take it easy now.

Toole: Yeah.

Antonio: Alright, you're doin real, real good. Now then, I really

would like to have you go back to Rich for a minute and see if you can help him out a little bit, talk about the girl that was chopped up, now I don't want you gettin mad.

Toole: Alright.

Antonio: I don't want you gettin upset.

Toole: Alright.

Antonio: Cause you're doin real good, and Rich is tryin real hard

and you understand that this is a real important thing to clear out, and, and you want his people (inaudible) I know that, I know that's your reasoning. But that isn't that isn't the object of it. The object of it is to clear the case, alright? And we know that you've never

claimed anything that you didn't do, alright?

Toole: Yeah. It wouldn't be right.

Lipich: Let's face it, the, the point is, ya know, I've come a long way to talk to you and like Joe says you are important to me. Very important to me. Ah, I have to satisfy some people. It's not me that has to be satisfied.

Toole: Well, I think you tryin to satisfy them too much.

Lipich: Yeah, yeah, well, ya know, they're always asking for more than I can give them, but my job is to satisfy them as much as I possibly can and if this is as much as I can send to them....

Toole: You know why, you know why they wantin to be satisfied too much?

Lipich: Why's that?

Toole: Cause they always had a gold spoon in their fuckin mouth.

Lipich: Yeah, some of em, yeah, you're right, and we talked yesterday about people with the gold spoons in their mouth, so I agree with you.

Toole: That's the kind, that's the kind a people that ain't never had no dirt on their fuckin hands before. Ain't never had to really get out and work for what they got. They ah, here it is, you got it.

Lipich: Yeah.

Toole: That's the kind they are. That's why they want too many facts.

Lipich: Some of them are. Some of them are.

Toole: I can read it pretty good.

Lipich: Yeah, I know, I know. But ah, I'm not that way. Tell me if you think, ah, if that's your opinion, you've talked to me for two days, if that's your opinion, tell me.

Toole: Well, that is my opinion to a certain extent.

Lipich: Why do you feel that way?

Toole: Cause, ah, you tryin to ah, you tryin to get every ah, every detail. You cannot remember....

Lipich: I'm tryin to do my job Ottis.

Toole: I know, but you cannot remember every detail.

Lipich: I realize that.

Toole: If I did, if I did I would have, I could go through all this shit, Boom! in no time.

Lipich: I realize that Ottis, I realize that. And I'm not tryin to get every little detail, I'm just tryin to, like Joe said I'm tryin to say something that will help you, jar your memory a little bit, help to lock in on a certain thing, ya know? I know that you, you've killed a lot of people, you've gone to a lot of places. It's almost impossible to remember every little detail.

Toole: I might be dumb in education, but I got a pretty good mind.

Lipich: Hey, let me tell you, dumb is not the way I would describe you.

Toole: See, I can read a little bit, but not a whole lot, ya see.

Lipich: Reading has nothing to do with it.

Toole: And ah, as far as education, I ain't got none, I run clean out one door and out the back door just as hard as I can run.

Lipich: Yeah, I know a lot of educated people that are....

Toole: They more dumber that I am.

Lipich: That's right. That's right.

Toole: Some of em go to college and all that, and they're out there working a garbage truck someplace. Or else shovelin shit. Cause they too stupid really to get out and really do it in their mind. They done paid all that money to go to college and all that, they ain't, they ain't nothin to be shit to start with. They end up bein sorry, wantin somebody to take care of em.

Lipich: Yeah, yeah. Let me ask you, is, let me ask you this, talkin about the case that Joe talked to you about here, I was listenin and ah, I was really impressed, cause you, you seemed to come out with lot of good detail. And for some reason, that, that case seems to come back to you and you remembered the different colors of the car, the fact that she was wearing slacks, where you shot her....

Toole: I said that before he even showed me the car.

Lipich: Yeah, sure. The reason I'm asking about that is because...

Lipich:that case happened before this girl was chopped up, and I guess that's why I keep tryin Ottis, to get, to get more and more detail because, because you, you were able to remember certain things about that case that happened even longer, or ah, a longer period of time ah....

Toole: Well well when I do things, when I do things more by myself I can remember the details more. When you with somebody else you ain't payin quite as much attention to all the details ya see?

Lipich: Yeah, I can understand that.

Toole: Because you got two, you got two parties see, and you got, there's two different people and they got two different minds, they don't think the same, they do things different.

Lipich: Yeah.

Toole: Just like if me and you was out here right now see, me and you out here picked up this woman, you might want to fuck her ten minutes and I might want to fuck her two hours. that's the difference.

Lipich: It might be the other way around.

Toole: (laugh) and you maybe want to be one of them quick rabbits.

Lipich: (laugh) Well....

Toole: I know it's on tape what I'm sayin.

Lipich: Nobody's, pays attention to that.

Antonio: Hell Ottis, you said a whole bunch worse than that.

Toole: Yeah, that's life. I can do it all. (laugh)

Lipich: Let me ask you this, just, just about my case, the girl that was chopped up. Would it make any difference to you, and I'm just askin this, would it make any difference to you if you knew that I wasn't interested in prosecuting you at all?

Toole: That really don't matter. It's really clearin up the person, so the person know that I really killed the person.

Lipich: Yeah. Yeah, ah, that's why I asked that question, I, I just wondered if....

Toole: And if it goes to trial, I have to be there cause I'm locked up (laugh). If I was on the streets, if ah, I was bein tried for somethin I would go to court because ah, even when I got tickets and all at different times, I was appearing in

Toole: court, I didn't try to dodge them.

Lipich: Do you remember different times that you were arrested? For different things, or, or are you a little fuzzy on that?

Toole: Oh, over the years, on the years, yeah.

Lipich: Do you remember ah....

Toole: Cause I been doin ah, bullshit all my life.

Lipich: Yeah, well you know that I, I mean, I haven't told you but, I'm sure that you're smart enough to know that I've looked at different documents and things and done some research on you to try to....

Toole: I can fit all different patterns.

Lipich: Sure, but, I've looked at ah, what they call an FBI Rap sheet, it's just, lists different times that you were arrested and stuff like that, and I saw where ah, in June, the month of June in 1976, you were arrested for lewd and ah, lascivious behavior.

Antonio: Lascivious.

Lipich: Lascivious. That word doesn't come out good. Ah,

Antonio: You know what Lascivious is?

Toole: What does civious mean?

Antonio: (laugh) it's bullshit, don't worry about it.

Lipich: Yeah, that's just, that's just a title they put on it.

Toole: Well ah, I, I been arrest for different times when I ah, when I been enticed by ah, police officers ya know ah, they be in a, a sex movie house and ah, I would hit up on em, next thing I know they would throw that fuckin badge up in my face. Them was a chicken shit bastards too.

Lipich: Yeah. Do you remember...

Toole: It's them ought to got tried for the shit not me, cause they the ones that enticed me. I went right on in, fell right on in on it and ah, and ah, they put charges on my ass that ought to been the other way around, they ought to been charged. They ah, entice people. Just like when you get out here and lay down on the street with billfold hangin out of his pocket and ah, you see twenty dollar bills and all that shit. They oughtn't do...

Toole:that shit either. Cause them fuckers the ones that ought

to get tried, not the person that's snatchin it from em.

Lipich: Yeah.

Toole: That's what you call a chicken shit, no good, sorry bastard

policeman. That's one that's too ah, scared to really get

out and work. Classified.

Lipich: Well yeah, there's some trickery that goes on, and ah...

Toole: I tell em like it is, if they don't like it, fuck em. (inaudible) fuckin ass. And the horse he road in on.

Lipich: Well, what I'm tryin to get after, if you, if I can....

Toole: I ain't mad now, just cause you said that, I ain't mad.

Lipich:and talk about you being arrested for that, is because

I've looked on the reports....

Toole: I got busted (inaudible)

Lipich: (eah, but I saw that you got arrested in the month June

Lipich: OK. In one of those charges....

Toole: All I did was touch the guy, goin down the fuckin hall

and they was tryin to say I was ah, puttin my hands on

Lipich: Yeah, well, let me tell you...

Toole: I remember that.

Lipich: Ottis let me tell you exactly what happened according to

the records....

Toole: And the next time...

Lipich: I, I'm not, I'm not even interested in, in why you were

arrested, I mean, if you want to tell me...

Toole: Oh, I wanna tell you. The next time, the fuckin Detective,

he was sittin in the fuckin booth with his dick out and invitin me in the fuckin booth. So he, that bastard is

the one that ought to been charged, not me.

Lipich: Where did that happen?

Ottis: Here in Jacksonville. He had the booth open, settin up

on the stool with his dick out, shakin it at me. So that bitch oughten to be locked up, not me. So that's what you call a no good sorry, low down bitch, what's too scared to work. He don't earn his job, he ought to be

out here shovlin shit in his ass somewheres.

Lipich: 'eah. OK.

Toole: That's what you call a phoney bastard.

Lipich: OK.

Toole: I'll tell em that too.

Lipich: Alright, let me, let me, talk to me now Ottis, okay?

Toole: 'kay.

Lipich: Okay. Ah, exactly what happened according to the records that have been kept, is that when you were arrested in June of 1976, you bonded, or you bailed the next day and you were back out on the street, okay? Then you were suppose to appear....

Ottis: I didn't show up (laugh).

Lipich: And you, Right, right. You didn't show up and then you, you went until October of 1976 before they arrested you, they arrested you on a failure to appear warrant, (clearing throat) excuse me, and....

Ottis: what they did, I was down in the park down town hittin up on a trick and they arrested me, they was gonna take me to detox but they traced down I had a warrant on me. I was drinkin.

Lipich: Well, this is great. Ottis, Ottis, this is exactly what I'm tryin to do. I'm trying to re, I'm tryin to get you to remember that period of time and that's what you're doin. Sounds like you got a hell of a memory for those two arrests. This girl that was chopped up Ottis, was chopped up between those two dates, in other words, you were arrested in June, the girl was chopped up in August of the same year and then you were arrested again in October. So, if you can remember those two dates, does it help you at all to remember anything about this tilling? Because it would have been after the first time you were arrested and before the second time you were arrested.

Ottis: Oh, I see what you mean now.

Lipich: You see what I'm gettin at?

Ottis: Yeah, I see what you mean now. What month was I locked up in now?

Lipich: You were arrested in June, 1976, but you didn't stay in jail, you bailed out the next day. And then you arrested again in October because you failed to appear at that ourt appearance.

Ottis: And that happened between that period of time, right?

Lipich: A-huh.

Antonio: Would you excuse me for a minute?

Toole: I sure will. Bring me back a cup.

Antonio: Okay. I'll get you one.

Toole: I appreciate it.

Lipich: Now, ya know, I'm bringing that up just to help, get you to relate to the exact period of time Ottis, when all this

happened. Does it help at all, or am I off base?

Toole: (long pause) You say that happened in between them two

times?

Lipich: Yeah.

Toole: That I was arrested, but I was back on the street?

Lipich: Yeah, so that means that some time after the first time you were arrested you had to have left Jacksonville and

gone to Colorado.

Ottis: Yeah. Shoot, that is a pretty good piece back.

Lipich: Yeah, it's a long time ago. Long time.

Ottis: You're tryin to get me stabilized where I was at at that

time.

Lipich: Well, that's what I'm tryin to do, okay? I'm not tryin to

play with your mind or anything, I'm just tryin to help

you.

(long pause)

Ottis: 76, you say?

Lipich: Yeah.

Ottis: What kinda car I had in 76? I have to think back in my mind.

Lipich: Think about those dates that you were arrested. After you were arrested the first time in June, what kind of a car

did you have when you 'got out of jail and got back out on

the street?

Ottis: I had two, three cars that year. I had a 6, ah, 66 Galaxie.

Lipich: Do you remember what color that Galaxie was?

Ottis: Yeah, Ivory green. But I don't remember if it was in my mo,

mothers name or in my step fathers name. And I had a 61

Cadillac and I had a 63 Cadillac, gray.

Lipich: The 61 Cadillac was gray?

Ottis: Solid gray, it was a 2-door coupe deville, and I had a 1964

'adillac, it had a white, light top, painted top and a gray

bottom. I told you I was into Cadillac's didn't I?

Lipich: Yeah. Cadillac's are good cars. They say they last forever.

Toole: And I ain't, I ain't dead sure on that year that I had a 66, I had a 64 Chrysler too, a green chrysler.

Lipich: 64?

Toole: 64 Chrysler, green. And I had a 70, I mean, no, a 70, I had a fuckin chrysler, a fuckin white chrysler, it was in the 60's model, I can't remember what year it was. It could have been maybe about a, bout a 61 or 62, could have been, I ain't dead sure on that.

Lipich: White one?

Ottis: Solid white.

Lipich: Does lockin those two dates in when you were arrested, does it, is it bringin any of your memory back, are you, you're remembering now the cars that you had then, does it help you to remember comin to Colorado, does it help you, killing this girl, choppin her up and so forth?

Ottis: I'm real sure I did kill that girl.

Lipich: Well, but, but again, ya know, I'm asking for detail and I'm sorry I gotta do that, but I'm, I'm tryin to get us much as I can, does it help you to remember any of that?

Ottis: I had a shit pot full of cars, didn't I?

Lipich: Yeah, you had a lot of cars.

Ottis: I always had three or four cars at one time. All the time.

Lipich: Yeah.

Ottis: Cause I would buy them real cheap, I would. I'd go down to the mission and buy me a car.

Lipich: Well, does it help you to remember anything about this girl?

DETECTIVE WALKS IN FROM ANOTHER AGENCY (ARKANSAS)

Arkansas Detective: Looks like we're gettin ready to leave pretty soon Ottis.

Toole: Are ya? You gonna take me out and buy me a steak dinner?

Arkansas Dotective: I can't, they didn't give me no money.

Toole: That ain't no good.

Arkansas Detective: These guys here are gonna buy my lunch.

Toole: What a poor trick!

Arkansas Detective: Sorry about that.

Toole: I don't know what kinda trick you are, ya'all ain't gonna

feed me or nothin. Shit I'd have to starve, I'd have to

feed that fucker.

(laugh)

BREAK IN TAPE WHILE ARKANSAS DETECTIVES REMOVE VIDEO EQUIPMENT FROM ROOM.

Lipich: Okay, for the benefit of this tape, the time now is 1:45 pm, were still on November 21st, 1983 and it's still Monday, we took a short break, ah, Ottis had some lunch and we're back to business now, ah, again just for the benefit of the tape, I want you to take a look at the advisement form you signed Ottis, ah, all of your rights

are on there, you, the miranda warning was explained to you, do you still understand all of these rights?

Toole: Yeah I understand all of that, yeah.

Lipich: You still understand that you don't have to talk to me

if you don't want too?

Toole: Yeah, I understand that too.

Lipich: and about your rights to an attorney, and all that.

Toole: I understand all that.

Lipich: OK. This has been done several times over the last couple

of days so I think you do.

Toole: Yeah, yeah.

Lipich: I know, Ottis, that you're a little upset with me about

trying to get detail on this case.

Toole: Yeah. You right.

Lipich: Yeah. But let me tell you a story, okay? Eight years ago,

when this girl was killed and cut up, I was there, pickin up her body and helpin get it to the morgue so that we could have it examined. I ah, have talked to her family, and I've talked to people who have been really upset, okay? They're upset because she was killed obviously, but they're upset because they'll never, they'll never

rest until they know who did it.

Toole: Yeah.

Lipich: Now I can go back and tell them, Ottis Toole did it, Ottis

Toole said he did it.

Toole: Yeah.

Lipich: But they're gonna want to know why I know for sure that

Ottis Toole did it, Okay? Now, I know for sure that you

did it, because you told me you did it.

not tryin to do that. So far all you've told me Ottis is that you killed her, okay? I'm not asking you to go

Antonio: back very simply to, ah, the specifics, that you told us yesterday, that you just recalled and you spontaneously stated, can you tell us again, what those points were?

Toole: I said there was more than one bag.

Antonio: Did you say how many bags there were?

Toole: I said there coulda been two or three.

Antonio: Do you recall telling us specifically, exactly how many there were?

Toole: Not exactly. But more than one.

Antonio: OK. Can you tell us what you done with those bags?

Toole: (pause) I left one kinda at the edge of town, I can't remember where at.

Antonio: OK. Do you remember where you left the other one?

Toole: Side that mountain. Bout side of the mountain.

Antonio: OK. Do you remember talking about the particular girl, what her, if I said demeanor, do you understand what that means?

Toole: (inaudible)

Antonio: OK. You said something about her, her style, her class.

Toole: Well, she didn't have no class.

Antonio: She didn't have any class?

Toole: No. She didn't know how to dress.

Antonio: Yeah. You said something about her attitude. What it was like. Do you recall what that was?

Toole: I can't really stabalize that.

Antonio: OK. By any chance, do you recall if she was aggressive or she was, just cooperative? Aggressive, I mean, did she mouth off to you?

Toole: Oh yeah, she had kinda like a foul mouth.

Antonio: She did have a foul mouth?

Toole: Yeah.

Antonio: Do you remember anything that she said to you by

any chance?

Toole: Nah. I ain't gonna lie to ya about that.

Antonio: OK, please don't. You know, that's a, we've, we've held

that kind of bond between us that you wouldn't lie to us and, and, you haven't yet, and we appreciate that, and and, I don't just want you to just spit something out. We talked about we don't want you to tell us something just because you think we want to hear it. And you haven't done that, you've been real good with us.

And we've had a good time. Ah, as far as, we've had good rapport between us. You haven't bullshit us, we haven't

bullshit you.

Toole: Yeah.

Antonio: And we do appreciate that. Ottis, by any chance, do

you recall where you got hold of this girl?

Toole: (pause) No, not dead sure.

Antonio: Not dead sure. Can you recall anything, does anything

come to your mind on where you got hold of her, how you got hold of her? (long pause) Do you remember, by any chance, I know that you've said before that you put her in garbage bags, and I know that you've said that you left at least one out by a kinda mountain area, ah, and you described, I believe it's on tape, or described

Antonio: That's true. We don't want you guessing. Now are you real positive about leaving one bag, at least one bag, out in this mountain-type area with the dirt road and all that and leaving one bag in a town area?

Toole: Yeah.

Antonio: OK. Now, yesterday, just to refresh your memory a little bit, ah, that was pretty much what you told us, except that you changed that just a little bit, because you said today, that you left it, that you left one bag on the edge of town, and what you said yesterday, was that you, you dropped one bag in town.

Toole: Yeah. Yeah, I did say that. (pause) It's I said I left it in town yesterday, and I said on the edge of town today.

Antonio: Huh huh.

Toole: Well, it's all about the same to me (inaudible). On the edge town, downtown, it's all about the same to me.

Antonio: OK. Do you by any chance, remember, assuming that you did leave one bag in town....

Toole: Yeah.

Antonio: Do you recall putting it any special place? Do you recall putting it, just, just leaving it out in the open or anything like that or putting it somewhere?

Toole: No, I ain't sure.

Antonio: OK. That's fine. That's fine. You're doin great, on your memory. And Ottis, are we talkin about the same thing that we're talking about the girl that we

Toole: was cut up, yeah.

Antonio: OK. Could you describe for me again how you cut her up? Could you recall that as best you can?

Toole: All right. Her head was chopped off.

Antonio: OK.

Toole: And her arms was chopped off.

Antonio: OK.

Toole: And her hands was chopped off.

Antonio: OK.

Toole: And her legs was chopped off.

Antonio: OK. Where were her legs chopped off?

Toole: Towards the joints. Towards the joints.

Antonio: OK. You're tapping your hand on your knee. Is that

Toole: Yeah.

Antonio: OK.

Toole: And, ah, her titties was cut out, cut off with, out with a butcher knife around, and ah, her hands was chopped off too, ya know. That pretty close I could get.

Antonio: OK. That's fine. And do you remember how you killed her?

Antonio: Nah, I remember that, I remember you tellin us that, and you didn't tell us how you initially killed her. And we know, you recall that you told us that she gave

Toole: Well, when I cut her in all, in different parts of her back, ya know.

Antonio: You did what to her. "

Toole: Cut her in different parts of her back. But I can't remember exactly where at.

Antonio: OK. That's in addition?

Toole: Yeah.

Antonio: OK. We have that on tape anyway, don't we?

Lipich: Yeah.



Antonio: Let me help you just a little bit. What you told us prior was that you beat her all over the face.

Toole: Yeah.

Antonio: And that you cut her throat.

Toole: Yeah, I did, I did beat her a little bit. And I cut

her in the face.

Antonio: But you said you cut her throat. That's how you intially

killed her.

Toole: yeah.

Antonio: Is that, is that true?

Toole: Yeah.

Antonio: OK. By any chance, do you remember beating on her body

at all?

Toole: Not as I can remember.

Antonio: You mean you just don't remember or

Toole: I don't, I, I can't really get it to click in my mind.

Antonio: OK. Ottis, you're doin real good, you're doin real good.

Let me ask you a question now, ah, do you recall, ah,

having any sex with this girl?

Toole: (pause) I thought I did, but I ain't sure.

Antonio: You're not sure.

Toole: Ain't sure.

Antonio: OK. Now you told me that she gave you a hard time.

Toole: Yeah.

Antonio: By any chance at all, do you remember anything she said?

Toole: \h, it's been so long, I would get it fouled up, with someone

else.

Antonio: OK. That's fine. That's fine. Is there anything else that

you can remember that you think we should know?

Toole: Huh huh. Not about her.

Antonio: Ottis, during that period of time, ah, and you realize

we're going clear back to 1976,

Toole: Yeah.

Antonio: And that's, 8 years ago.

Toole: Yeah.

Antonio: But during that period of time, did you own any dogs?

Toole: Did I own any dogs?

Antonio: Yeah. Now you have to go back 8 years, I know that's

going to be a little tough.

Toole: Yeah, but I didn't take em travellin with me too much.

Antonio: You didn't have them travelling with you too much?

Toole: Not too much, no. Cause they would be more hard to take

care of travellin around.

Antonio: Now, one thing that's come up, is that initially, in other

words, the first time....

Toole: Yeah.

Antonio: That we talked to you about that, again, again, you did

subsequently admit that you did kill this girl, and some

of the things that you done to her.

Toole: Yeah.

Antonio: You told us that you were with Henry, and that was probably

some of the reason that you was having some problem

remembering what was done because you both did kind of

different things.

Toole: Yeah.

Antonio: Ah, that sometimes you didn't pay any attention to what

Henry was doin, you just kinda done your thing.

Toole: Yeah.

Antonio: Ah, subsequently, later after that, ah, Rich talked to you,

ah, and you said that Henry wasn't with you afterall. You had decided that ah, that ah, during that particular time

period, or at least at the time of this particular murder

Toole: Yeah.

Antonio: that Henry wasn't with you.

Toole: Yeah.

Antonio: Do you recall now whether Henry was with you or he was

not with you?

Toole: I'm real sure he wasn't with me.

Antonio: OK. Ottis, are there things that Henry would do to

a body that you didn't do?

Toole: Oh, Henry would do all different things to the body.

Antonio: Pardon?

Toole: I say you can't never tell which way Henry's patterns

goin. Which way his mind, mind's goin.

Antonio: Well, are there any special marks or anything that Henry

liked to leave on a body that you didn't, or did you

both leave the same kind of marks?

Toole: Well, sometimes, ah, Henry would put a cross on it.

Antonio: OK. When you say put a cross on it, does that mean make

a cross and lay it on the body or does that cut a cross

in?

Toole: Cut a cross like on the legs and ah, make a cross outta

a piece, like two pieces of wood together and make a

cross out of them.

Antonio: OK. So he would make a cross out of two pieces of wood

and put it in her legs?

Toole: By, by her legs.

Antonio: OK. At one point you did tell us that sometimes, and I

can't remember whether you said that you did it, or Henry

it, you would actually cut a cross or crosses

Toole: Yeah.

Antonio: On their bodies.

Toole: Yeah. Yeah, I did say that, yeah.

Antonio: Yeah. Do you recall whether that was you or Henry, or was

it both of you?

Toole: Well, I did it at different times too.

Antonio: You have?

Toole: Yeah.

Antonio: Where did you prefer to cut those crosses?

Toole: Most anywhere.

Antonio: Most anywhere. Did Henry have any special place that he would put those crosses? I'm talkin about the

ones you cut.

Toole: He would mostly do it on the leg.

Antonio: OK. In talkin to you about crosses, wait a minute, excuse me. Let me go back just a little bit. You say on the legs.

Would that be up high on the legs or....

Toole: Down towards the bottom of the legs, towards the feet

joints.

Antonio: OK. But have there been other places that either you or

Henry have cut crosses, other than the legs?

Toole: I ain't real sure on that so I ain't gonna try to

(inaudible) my mind.

Antonio: OK. When we, when we talked about crosses, you told us,

Monday, we said crosses or X's, you said to you their all

the same.

Toole: All crosses, all the same.

Antonio: They are all the same?

Toole: Yeah, that's what I said.

Antonio: OK. In other words if you took an X and you turned it this

way it's a cross?

Toole: That's right.

Antonio: OK. That makes sense to me. Um, Jerry did you have

anything that you wanted to ask Ottis?

Murphy: Yeah, I just had a couple of things. Ah, you told us

earlier that you were part of this Hands of Death ...

Toole: Yeah.

Murphy: Organization.

Toole: Yeah.

Murphy: Was this girl, ah, part of your ceremony one night? Do

you recall?

Toole: If she was I woulda burned her up.

Murphy: You'd a burned her up if she'd been?

Toole: Yeah.

Murphy: So she wasn't one of your sacrifices then?

Toole: Nah.

Antonio: Rich, did you have anything that you wanted to ask Ottis?

Lipich: Well, ah, I think that Ottis has told us just about everything that he can remember, and I'm satisfied with that. I don't, I think yesterday he didn't think I was, but I am. And, I ain't gonna keep tryin but, ah, I know it's hard for you. We talked to Buddy last night and he, he says its hard for you to remember, and I know it is. Plus you've got the compounded problem of having to talk to several different people day after day after day after day, and that kind of

jumbles up your mind. It would mine, anyway.

Toole: Well, if you keep goin back through it, it keeps changin

certain extent, it's like

Lipich: Yeah.

Toole: maybe certain changes (inaudible).

Lipich: Yeah..

Antonio: But that's all right. That's all right. We expect it.

Toole: Good.

Lipich: I kind of would like to do this because it may be my last

opportunity to talk you....

Toole: Yeah.

Lipich: Ah, rather than asking you for more detail, or going over

any of that garbage again, let me give you a little bit

of detail.

Toole: Yeah.

Lipich: OK? Ah, I'll ask you a question along with the.....

Antonio: I'm sorry Rich.

.Lipich: Got a problem?

Antonio: No, No. It's a problem that I have. It's an error in (inaudible).

Lipich: Oh. I would like to give you a little bit of detail, just from what I know about the case, and I, I may ask you a question along with it, but its only because I'm hoping that the detail that I give you helps you remember some details back to give, to give back to me. This girl, from what we know, Ottis, was, was ah, travelling that night from bar to bar

Toole: Yeah.

Lipich: And she did, or she was last seen, at one particular bar in Pueblo. Ah, we don't know whether that was the place that ah, whoever killed her got ahold of her. But, we know that she was last seen there and then she disappeared and nobody saw her anymore. Does that jog your memory any? Do you remember anything about a bar in relation to this girl?

Toole: No, not exactly, no.

Lipich: Nothing at all, huh? OK. All Right.

Toole: But it coulda been cause we, cause I have got women from bars. So it coulda been a possible way. But it kinda, I ain't dead sure.

Lipich: Well, I appreciate that. And I really think you are doing good. We talked last night, and we've really been amazed at how good you've done, you know. And I know I've been a little hard on you, but, but I mean it when I say that you've done one hell of a job trying to remember.

Toole: I'm gonna be hard too on somebody today. (laugh)

Lipich: Who's that?

Toole: (laugh) He ain't in here now, but I gonna be hard on him.

Lipich: OK. Let me ask you this, Ottis, because I think that this is an area that we haven't gone over. You say that you have picked up girls in bars before?

Toole: Yeah.

Lipich: When you do that, how do you do it? I mean, what....

There ain't nothin to it. All you do is just like you tryin to pick up one you want, want to fuck more than the other. You talkin to them a little bit, and buying em a drink and the next thing you just say Well let's change bars, or somethin. They all for it, you know. This bar here isn't lively enough or, it ain't got enough getup to it and they go for it.

Yeah. Then what you're saying is when you go into a Lipich: bar to pick up a girl, you don't by any means take her out of the bar forcibly, you talk to her, she ends up going with you willingly...

That's right. Toole:

And you kill her later. After you've gone someplace. Lipich:

Yeah. That's right. Toole:

Lipich: That makes sense to me.

You can't just walk up and say "Bam! You're goin. Bam! Toole: You're goin with us!"

(laugh) That'd be a hell of a way to pick up a girl. Lipich:

You can't do that! Toole:

Yeah. OK. Lipich:

There'd be a big fuckin fight! Toole:

OK. Lipich:

OK, Ottis, just a touch, I'm sorry Rich.... Are you done? Antonio:

No, but go ahead if you Lipich:

OK, if I can. Antonio:

Lipich: Sure.

That's fine. There's a couple points that I did want to Antonio: re-establish with him. Ottis, at one point, you did tell us that you thought that you had, you recollected, ah, chopping this girl up, and you recollected being in a house or a room or something like that.

Toole: Yeah.

Do you recall now where you chopped her up at? Antonio:

I can't dead put, put my hand on it. I've been tryin to, Toole: but, it's been so long, I can't, ah, can't trace it dead to the point.

OK. But you did tell us that? Antonio:

Yeah, I did. Toole:

Antonio: OK. Ottis...

Toole: It is, it is pretty possible I was in a house choppin

her up. But I can't really, really be positive.

Antonio: OK. That's fine. Ottis, how many times have you been

advised of your rights in the past three, four days with

us? Would it be....

Toole: Alots of times.

Antonio: Pardon?

Toole: Alots of times.

Antonio: OK. And how many times have you been advised of your

rights in the past seven or eight months?

Toole: Oh, I couldn't even tell ya.

Antonio: OK. Do you feel like you understand those rights at all

times?

Toole: Yeah.

Antonio: And do you feel that you know that we're police officers you're talking to, that any evidence, or any statements

that you make, can be used against you in a court of law?

Toole: Yeah. I understand that.

Antonio: Have you forgotten that this morning, by any chance? Before

we started talking to you?

Toole: No. Sure haven't.

Antonio: So you did have your rights in mind?

Toole: Yeah.

Antonio: Then we don't have any problem with that then?

Toole: No.

Antonio: And, and I had told you over and over throughout all of

our interviews, every time, that any factual information that you give to us, could lead to your prosecution, and subsequent conviction, could lead to, up to and including,

the death penalty?

Toole: Yeah. Yeah, I understand that.

Antonio: OK. Have I told you over, that over and over?

Toole: Yeah.

Antonio: OK. Ah, I would like to have you sign this form again.

This is another one. And this is probably, what, the fourth or fifth minimum, that we've gotten from you. This is again your rights. I want to make sure that you understand them, all right? And, and I would like to have you tell me if this is what you remembered as of

this morning prior to our talk.

Toole: Yeah.

Antonio: You have the right to remain silent.

Toole: Yeah.

Antonio: OK. And you elected to waive that right and talk to us

anyway?

Toole: Yeah.

Antonio: Anything you say can and will be used against you

in a court of law?

Toole: Yeah, I understand that one too.

Antonio: OK. And did you understand it prior to this morning?

Toole: Yeah.

Antonio: You have the right to talk to a lawyer and have him

present while you're being questioned.

Toole: Yeah, I understand that too.

Antonio: If you cannot afford to hire a lawyer, one will be appointed

to represent you, before any questioning if you wish.

Toole: Yeah, yeah I understand that, too.

Antonio: OK. And you remember, Ottis, what's continuing rights?

What does that mean?

Toole: Continuing rights?

Antonio: Continuing rights.

Toole: That means you can detinue to keep talkin on, or you can

stop any time.

Antonio: OK. That's fine. That's fine. Ottis, what I need you to do is initial these little things in here along side each one. And what you're initialling is just exactly

what I told you. (pause) OK. Mark here, and initial along side of the mark. (pause) And your signature will go right there. And that says signature of suspect, OK?

Toole: Huh huh.

Antonio: And you do know what a suspect is?

Toole: Yeah.

Antonio: OK. Could you date that for me? Ottis, today is the,

November 22.

Toole: Today's the 22nd?

Antonio: Yes. (pause) OK. Right above where you dated that, would

you put the time as being 8:18 a.m.? OK.

Lipich: You look tired today, Ottis.

Toole: Huh?

Lipich: You look tired.

Toole: I don't feel too good. I still got a tooth need to come

out.

Lipich: You got a toothache? Boy, I'll tell you, there ain't

nothin worse than a toothache.

Antonio: Are they giving you any medication, Ottis? What are they

giving you?

Toole: Oh, they're givin me that stuff that you smear on it.

Antonio: Oh, smear on the tooth? Is that a narcotic?

Toole: Ah, it ain't. I'd say it ain't. It just somethin to keep

the (inaudible).

Antonio: Oh, ok.

Toole: I can't pull it out myself.

Murphy: It is a little swollen.
