- A. SO I, WE GET OUT AND UH; WE GET OUT OF THE LOCK UP. THIS WAS A LOCK UP SITUATION WHERE WE WERE.
- Q. RIGHT, RIGHT.
- A. WE GET OUT OF LOCK UP, WE'RE IN POPULATION AND WE'RE ON THE SAME WING. AND OTTIS IS WALKING AROUND, HE'S PICKING UP CIGARETTE BUTTS, AND HE'S MAKING CIGARETTES OUT OF CIGARETTE BUTTS, I'M THINKING, "THIS GUY DOESN'T HAVE ANY MONEY" WHICH HE DOESN'T. AND I SAID "OTTIS, YOU DON'T HAVE TO PICK UP THIS CRAP OFF THE FLOOR" I SAID (UNINTELLIGIBLE)... HE SAID "WHAT DO YOU MEAN?" YOU KNOW, HE SAYS, IF YOU'VE EVER MET HIM, HAVE YOU EVER MET HIM?

- A. OK, YOU KNOW HOW HE'S..

- A. HE'S REAL DULL, RIGHT?

- A. SO HE SAYS, "WHAT DO YOU MEAN?" I SAID "THE REAL, LOOK, DO YOU KNOW HOW TO DRAW A PICTURE?" "NO, SHOW ME" I SAID "OK, HERE. GET A PIECE OF WHITE PAPER AND UH, CAN YOU, WHAT WOULD YOU LIKE TO...WHAT DO YOU LIKE?" HE SAYS, "HOW ABOUT, I LIKE TOMBSTONES" I SAID "CAN YOU DRAW ONE?" - A. NOT THAT I EVER HEARD.
- Q. IN OTHER WORDS, OTTIS IS OBVIOUSLY SMART ENOUGH, I MEAN HE'S NOT STUPID, HE'S NOT A BRAIN SURGEON EITHER.
- A. NO.
- O. BUT HE'S SMART ENOUGH TO REMEMBER SOMETHING SOMEBODY ELSE TOLD HIM AND THEN HE MIGHT SAY (PAUSE) DO YOU KNOW WHAT I'M GETTING AT?
- A. OH SURE, LIKE YEAH, SOMEBODY ELSE DID IT AND THEY GAVE HIM THE DETAILS AND HE WANTS TO BE A HERO...
- Q. YEAH.

- A. AND HE SAYS OH YEAR I DID IT.
- Q. OR FOR WHATEVER REASON HE WOULD.
- A. WHATEVER.
- Q, YEAH,
- A. YOU KNOW; YEAH; YEAH; HE'S PROBABLY THAT SMART. UH. YEAH; I'D SAY THAT. SURE. IT'S UH; BUT YOU'RE PERSONAL OPINION IS WHAT?
- A. I BELIEVED HIM WHEN HE TOLD ME HE DID IT...BECAUSE OF THE WAY HE TOLD ME AND IT'S...BECAUSE OF THE WAY HE WAS...BECAUSE OF THE WAY HE..
- Q. WAS HE MAKING EYE CONTACT WITH YOU WHEN YOU SAID IT; WHEN HE SAID IT?
- A. OH YEAH, WE TALK JUST LIKE YOU AND ME, SITTING ON THE GARBAGE CAN, I MEAN LIKE THERE'S A, TRASH CAN.
- G. UH HUH.
- A. AND I'M SITTING ON THE BED AND HE'S TELLING ME THESE THINGS, RIGHT?
- Q. UH HUH.
- A. AND YOU CAN LIKE GET A FEEL FOR THE GUY WHETHER HE'S BEING TRUTHFUL OR WHETHER HE'S BULLSHITTING.
- Q. AND HE TOLD, HE TOLD YOU ABOUT THE OTHER ONES TOO?
- A. YEAH AND HE.
- Q. HE OPENED UP TO YOU ABOUT ANYTHING HE SUPPOSEDLY WAS INVOLVED IN? I'M NOT...
- A. WELL, NOT EVERY ONE I DON'T BELIEVE.
- G. NO. BUT UH, A LOT OF THEM.
- A. YES. MORE THAN ONE, YOU KNOW AND WHEN YOU'RE TALKING ABOUT THE ONE AND THEN YOU'RE TALKING ABOUT THE OTHER AND THE BODY LANGUAGE IS THE SAME AND THE VOICE INFLECTIONS ARE THE SAME AND THE DEMEANOR IS THE SAME. YOU KNOW, I'VE BEEN THROUGH THE ACADEMY TOO, YOU KNOW, ABOUT HOW TO INTERROGATE PEOPLE.

- A. AND WATCH TO SEE THE, HOW THEY'RE REACTING TO THINGS. AND I FELT THAT THE GUY WAS BEING FRANK WITH ME. BUT COULD I SWEAR THAT HE DID IT? NO I CAN'T.
