THIS STATEMENT IS BEING TAKEN BY DETECTIVE MARK SMITH, BADGE 1163, AT THE LOCATION OF THE FEDERAL PROBATION OFFICE IN HOLLYWOOD, ADDRESS 6100 HOLLYWOOD BOULEVARD. ALSO PRESENT AT THIS TIME IS ITERRY GRAVESI FROM THE U.S. PROBATION OFFICE, UH, DEPARTMENT. STATEMENT IS COMMENCING ON 6-21-95 AT APPROXIMATELY 1:45 PM.

- Q. MICHAEL, AT THIS TIME I WOULD LIKE TO PLACE YOU UNDER DATH BY VIRTUE OF MY COMMISSION AS A POLICE OFFICER FOR THE CITY OF HOLLYWOOD, COUNTY OF BROWARD, STATE OF FLORIDA. FIRST OFF, ARE YOU AWARE IT IS A CRIME TO LIE UNDER OATH?
- A. YES I DO.
- G. WOULD YOU RAISE YOUR RIGHT HAND PLEASE? LET THE RECORD REFLECT HE'S DOING SO. DO YOU SOLEMNLY SWEAR TO TELL THE TRUTH, THE WHOLE TRUTH, AND NOTHING BUT THE TRUTH SO HELP YOU GOD?
- A. I DO.
- Q. MICHAEL MONAHAN, HAVING APPEARED BEFORE ME AS A POLICE OFFICER FOR THE CITY OF HOLLYWOOD, COUNTY OF BROWARD, STATE OF FLORIDA, HAVING BEEN DULY SWORN DEPOSES AND STATES. FOR THE RECORD MICHAEL, WOULD YOU JUST STATE YOUR FULL NAME, BIRTH DATE, AND YOUR ADDRESS OF, OF RECORD.
- A. MICHAEL B. MONAHAN, I RESIDE AT 700 DIPLOMAT PARKWAY HALLANDALE, FLORIDA AND MY BIRTH DATE IS 5-24-68.
- Q. ALRIGHT MICHAEL, I SPOKE WITH YOU FOR THE FIRST TIME YESTERDAY OVER THE PHONE. I HAD TALKED TO TERRY, YOUR PROBATION OFFICER, AND THEN I SPOKE TO YOU AND JUST TO SET THE RECORD STRAIGHT, BEFORE WE EVEN WENT ON TAPE HERE, WE TALKED ABOUT, UH, WHAT WE WERE GOING TO TALK ABOUT AND YOUR KNOWLEDGE OF SOME ACCUSATIONS MADE BY, ABOUT YOU IN REGARDS TO THIS CASE, IS THAT CORRECT?
- A. THAT IS CORRECT.
- Q. COULD YOU SPEAK UP JUST A LITTLE BIT FOR ME?
- A. THAT IT CORRECT, YES.
- Q. SO IT'S NO, IT WASN'T A SECRET AND IT'S NOT, YOU'RE NOT HEARING IT FROM ME FOR THE FIRST TIME, FOR THE FIRST TIME THAT UH, THAT YOU ARE ALLEGED TO BE INVOLVED IN THIS UH, ADAM WALSH ABDUCTION/HOMICIDE, IS THAT CORRECT?

- A. I UNDERSTAND.
- Q. OK. I CAME HERE TO SPEAK WITH YOU IN REGARDS TO THOSE ALLEGATIONS WHICH WERE KNOWN TO YOU AND WERE NOT BROUGHT UP BY ME TO YOU, IS THAT CORRECT?
- A. THAT IS CORRECT.
- Q. AND I WOULD ALSO LIKE TO COVER AS MUCH AS WE CAN TO THE BEST OF YOUR RECOLLECTION ABOUT UH, THE ORIGINAL INCIDENT WHICH HAPPENED IN JULY OF 81. OK?
- A. UH, QUITE SOME TIME AGO, I'LL GIVE YOU MY BEST.
- Q. OK. NOW, LET'S START WITH FIRST THE DAY THAT YOU RECALL HEARING ABOUT THE ABDUCTION. AT FIRST IT WAS BELIEVED TO BE AN ABDUCTION, IS THAT CORRECT?
- A. RIGHT.
- Q. BEFORE IT WAS DETERMINED TO BE A HOMICIDE.
- A, THE DAY, I DON'T KNOW EXACTLY WHAT DAY BUT WHEN I HEARD IT I HAD HEARD IT OVER THE RADIO STATION AND I, I DON'T KNOW IF IT WAS LATE AFTERNOON WHEN I HEARD THE NEWS OF IT, I'D GONE TO THE HOUSE TO SEE IF I COULD, YOU KNOW, DO ANYTHING TO ASSIST THEM.
- Q. LET ME ASK YOU FIRST, YOU, WHEN YOU SAY YOU HEARD IT OVER A RADIO STATION, DID YOU HEAR THE WHOLE NAME MENTIONED OVER THE RADIO?
- A. ADAM WALSH.
- Q. OK IT WAS MENTIONED, THE NAME WAS MENTIONED.
- A. CERTAINLY.
- Q. YOU WERE IN A CAR WHEN YOU HEARD THIS, LATE AFTERNOON?
- A. I WAS IN A CAR, CORRECT.
- Q. OK, WHO WERE YOU WITH?
- A. UH, WITH MY GIRLFRIEND, CHRIS FEHLMABER.
- Q. I'LL HAVE TO SPELL THAT..
- A. F.E.H.L.H.A.B.E.R.
- Q. CHRIS WAS A GIRLFRIEND OF YOURS AT THE TIME?
- A. YES SHE WAS.
- Q. AND DO YOU REMEMBER WHERE YOU WERE, I KNOW IT'S A LONG TIME AGO, WHERE YOU WERE AT THE TIME YOU HEARD IT?

- A. NO I DON'T. UH, JUST THAT UH, ANYBODY THAT KNOWS ABOUT THE UH, THE INCIDENT, IF THEY HAD, THAT THE KID IS MISSING AND HE'S MISSING AND IF ANYBODY SEEN A LITTLE BOY WEARING A, I BELIEVE THEY MENTIONED WHAT HE WAS WEARING. HE WAS MISSING OUT OF THE MALL. THAT'S...I MAY BE WRONG, IT'S AGAIN..
- G. YOU BELIEVE IT WAS THE SAME DAY?
- A. UH, I DO.
- Q. OF HIM MISSING, THE ABDUCTION?
- A. I DO. BECAUSE THE NATURE OF THE RADIO STATION, THEY, YOU KNOW, THAT HE WAS MISSING.
- Q. OK. WHERE WERE YOU LIVING AT THE TIME?
- A. UHHH..AT THAT PARTICULAR TIME I WAS EITHER IN MARGATE OR AT MY FATHER'S HOUSE.
- Q. YOU DON'T REMEMBER WHICH ONE?
- A. I DON'T RECALL.
- Q. OK. YOU'RE WITH CHRIS.
- A. CORRECT.
- Q. YOU HEAR THIS ON THE RADIO, YOU MENTIONED WHERE YOU WERE AT, LAS OLAS..
- A. RIGHT.
- Q. IN FORT LAUDERDALE.

- A. RIGHT.
- Q. AND APPROXIMATE TIME OF DAY WHICH YOU MENTIONED WAS WHAT, LATE AFTERNOON YOU MENTIONED?
- A. LATE AFTERNOON.
- Q. IT HADN'T GOTTEN DARK YET?
- A. NO I DON'T BELIEVE SO.
- Q. WHAT DID YOU DO NEXT?
- A. I WENT OVER TO THE HOUSE I BELIEVE.
- Q. THE WALSH, THE WALSH HOUSE?
- A. EXACTLY. I WENT OVER THERE. I DON'T KNOW IF THERE'S A DELAY, IF WE MADE A STOP BUT WE UH, WENT OVER TO THE HOUSE.
- Q. CHRIS WAS WITH YOU?
- A. CHRIS WAS WITH ME. SHE CAN TELL YOU, I KNOW.. AND I CAN'T REMEMBER IF SHE HAS, I THINK SHE HAD, BECAUSE I HAD BEEN GOING OUT WITH HER FOR A WHILE I THINK SHE HAD IN FACT MET ADAM SO SHE KNEW, SHE KNEW AS WELL AS I DID, YOU KNOW, WHO IT WAS.
- Q. YOU BELIEVE SHE, YOU BELIEVE SHE HAD MET HIM BEFORE?
- A. I THINK SHE DID, YEAH, BECAUSE YOU KNOW, THEY USED TO COME DOWN TO THE BEACH AND I'D BRING CHRIS DOWN TO THE BEACH AS WELL.

- Q. TO THE WALSH HOUSE.
- A. WELL I DON'T KNOW IF I'VE TAKEN HER OVER THERE BUT I KNOW THAT SHE, I'M PRETTY SURE THAT SHE KNEW ADAM. I MAY BE WRONG. BUT UH, BECAUSE I REMEMBER HER BEING STARTLED AS WELL.
- Q. WHAT HAPPENED WHEN YOU WENT OVER TO THE WALSH HOUSE?

- A. UMMM, I WAS MET OUTSIDE BY ONE OF THEIR FRIENDS AND WE WERE TRYING TO HELP IN ANY WAY WE COULD. - Q. OREEGAN?
- A. OREEGAN. HE LIVES UP SOMEWHERE UP NORTH, IN MAINE OR SOMETHING. UH, AND THAT'S THAT'S WHO I BELIEVE IT WAS.
- G. WHEN YOU AND CHRIS WENT OVER THERE, DID THEY HAVE FLIERS ALREADY PREPARED?
- A. I BELIEVE THEY DID. THAT'S WHAT UH, TO THE BEST OF MY KNOWLEDGE I THINK IT WAS, IT SEEMS ODD THAT THEY HAD THEM READY THAT, YOU KNOW, THAT QUICKLY. - A. I DON'T. I BELIEVE SHE WAS, DRIVING AROUND, I BELIEVE SHE WAS. AGAIN, YOU MIGHT WANT TO ASK HER, SHE PROBABLY WOULD KNOW. MAYBE RECALL SOMETHING I DON'T.
- Q. (PAUSE) FROM THAT DAY ON UNTIL IT WAS ANNOUNCED THAT THE HEAD WAS FOUND, CAN YOU RECOUNT TO THE BEST OF YOUR RECOLLECTION UH...WHERE YOU WERE? WHO YOU MIGHT HAVE BEEN WITH? WHO YOU MIGHT HAVE BEEN LIVING WITH AT THE TIME?

- A. I KNOW I WOULD HAVE SPENT, AT THAT PARTICULAR TIME I WAS SPENDING CONSIDERABLE TIME WITH HER. I TRY TO SPEND AS MUCH TIME AS

- UH, AS POSSIBLE WITH HER. IT WAS LIKE, AT THAT PARTICULAR TIME I CARED FOR HER SO MUCH . SHE WAS, PRETTY MUCH MY NUMBER ONE PRIORITY.
- SO IS IT POSSIBLE YOU COULD HAVE SPENT SOME TIME AT HER HOME.. G.
- Α. VERY MUCH SO, YES.
- Q. IN HER FATHER'S HOME, PARENT'S HOME?
- Αa YEAH, UH HUH.
- (PAUSE) IT WAS BROUGHT, TO YOUR; OUR ATTENTION; I'M NOT QUITE Q. SURE WHAT POINT, THERE WAS AN INCIDENT IN DAKLAND PARK WHERE UH, WHICH LISTED YOU AS BEING ARRESTED IN AN INCIDENT ..
- NO SIR, I WAS NEVER ARRESTED FOR THAT INCIDENT.
- Q. OH, CAUSE YOU WERE NEVER TAKEN INTO CUSTODY?
- NO SIR. A.
- Q. OK. LET ME SEE HOW THAT WENT. IT WAS REPORTED TO THE OAKLAND POLICE THAT UH, WHO I BELIEVE EITHER ATTEMPTED TO FILE CHARGES PARK OR THEY DID OR DIDN'T FILE CHARGES, BUT IT WAS ALLEGED THAT YOU COMMITTED AN AGGRAVATED ASSAULT OR SOMETHING ON SOMEONE.

- A. UH, NO I DON'T.
- Q. DO YOU REMEMBER...
- A. IT WAS ONE, ONE BLOCK WEST OF 441...AND I CAN'T REMEMBER, I KNOW I USED TO GET THERE BY GOING ATLANTIC BOULEVARD, BUT WHICHEVER ONE IT IS THAT'S UH, RIGHT PAST THE POMPANO HARNESS TRACK.
- Q. DO YOU REMEMBER WHO YOU WERE LIVING WITH AT THAT MARGATE HOME?
- A. YEAH, A FRIEND OF MINE THAT I WENT TO HIGH SCHOOL WITH, HIS NAME IS DONALD POMPI.
- Q. DO YOU REMEMBER HOW TO SPELL HIS LAST NAME?
- A. VERY SIMPLE, P.O.M.P.I.
- Q. P.O.M...
- A. P.O.M.P.I.
- Q. OK.
- A. HE WAS, AS I TOLD YOU EARLIER HE WAS UH, HIT AND KILLED BY A DRUNK DRIVER...WHICH HE WAS..A REALLY DECENT GUY.
- Q. DO YOU REMEMBER HOW LONG YOU LIVED AT THAT HOME, APPROXIMATELY?
- A. UH..
- Q. OR HOW LONG YOU LIVED WITH..
- A. COUPLE OF MONTHS MAYBE.
- Q. BUT IT WAS AT THAT TIME OF THIS GAKLAND PARK INCIDENT IS WHERE YOU LIVING?
- A. YES. YES.

- Q. OK. IS IT POSSIBLE THAT YOU WERE LIVING AT THAT ADDRESS WHEN THE ABDUCTION/HOMICIDE OF ADAM WALSH HAPPENED?
- A. UH, IT'S POSSIBLE, AGAIN, THE TIME FRAME WAS..I DON'T..I CAN'T RECALL BECAUSE IT'S SO LONG AGO BUT I COULD HAVE BEEN THERE OR, IT'S EITHER THERE OR MY FATHER'S HOUSE, ONE OF THE TWO.
- Q. WHEN YOU WERE WITH CHRIS ON THE DAY THAT YOU HEARD THIS ON THE RADIO, BEFORE WE WENT ON TAPE WE TALKED, YOU MENTIONED, YOU BELIEVED YOU WERE DRIVING HER CAR?
- A. NO SIR. SHE WAS DRIVING AND I WAS PASSENGER.
- Q. OK. SHE DROVE.
- A. RIGHT.
- Q. IT WAS HER CAR.
- A. IT WAS HER CAR. CORRECT.
- Q. AND TO THE BEST OF YOUR RECOLLECTION IT WAS WHAT KIND OF CAR?
- A. 79 CAMERO. IT WAS GREEN WITH A BROWN BIG BAND PIN STRIPE.
- ©. OK NOW, AGAIN AT THIS TIME, THIS UH, JULY OF 81, DO YOU REMEMBER WHAT YOU WERE DRIVING, IF YOU HAD A CAR?
- A. JULY, I BELIEVE IT WAS AN OLD RAMBLER I HAD, 330 OR 440 RAMBLER.
- Q. AND YOU RECALL BUYING THAT AT, AT AN AUTO SALES ...
- A. YEAH, I PURCHASED IT I BELIEVE FOR \$150 DOLLARS AT KALLIE AUTO SALES ON...ORANGE DRIVE APPROXIMATELY A HALF A MILE TO 3/4 MILES WEST OF 441.
- G. NOW THAT'S TO THE BEST OF YOUR RECOLLECTION YOU BELIEVE THAT IS THE CAR YOU HAD AT THIS TIME?
- A. I BELIEVE SO.
- Q. IS THERE ANYTHING UNUSUAL ABOUT THAT CAR AS FAR AS, UH, HOW YOU BOUGHT IT?
- A. WELL THE ONLY THING UNUSUAL, IT HAD AN IMPROPER TAG, I NEVER REGISTERED IT IN MY NAME. SO, IT WAS A.,
- Q. NOW THIS IS A TAG THAT YOU GOT FROM THE DEALER?
- A. WELL THE TAG THAT WAS ON THERE, CORRECT. IT WAS, IT WAS A DEALER TAG THAT UH, HE WAS, HAD IT OBVIOUSLY OFF ANOTHER VEHICLE. WHETHER IT WAS ONE THAT WAS A STANDARD, HAD MAGNETS ON IT AND IT WAS

JUST BOLTED ON, YOU KNOW, I GUESS FOR, YOU KNOW, THAT HE COULD SELL THE CAR, SERVICE THE CAR, HE'D DRIVE IT AROUND THE STREET SO HE HAD THE MAGNET, EASY TO TAKE ON, EASY TO TAKE OFF RATHER THAN MESSING WITH BOLTS. AND I DROVE OFF WITH THE CAR, I BELIEVE HE, HIMSELF FORGOT AS WELL AS MYSELF THAT THE TAG WAS OFF THERE. BUT YOU KNOW, ONCE THE TAG WAS THERE I NEVER MADE ANY ATTEMPT TO GIVE IT BACK TO HIM. IT KIND OF BOUGHT ME A LITTLE BIT OF TIME BEFORE I HAD TO BECOME RESPONSIBLE ENOUGH TO...GO GET THE CAR REGISTERED MYSELF.

- A. UH HUH.
- Q. YOU NEVER SIGNED OVER, YOU NEVER SIGNED OR REGISTERED THE CAR IN YOUR NAME?
- A. YEAH I BELIEVE I SIGNED EVERYTHING, I SIGNED IT, HAD IT NOTARIZED, BUT I NEVER DID HAVE IT REGISTERED, I NEVER HAD A TAG OR INSURANCE OR ANYTHING, YOU KNOW, THAT YOU'RE SUPPOSED TO HAVE.
- Q. OK. AND SOME TIME AFTER THAT IT WAS BROUGHT TO YOUR ATTENTION AFTER YOU GOT STOPPED WHICH WE TALKED ABOUT BEFORE WE WENT ON TAPE.
- A. RIGHT I WAS, ON ONE PARTICULAR DAY I WAS GOING TO B.C.C. I WAS IN A HURRY, I WAS LATE.
- Q. CENTRAL CAMPUS?
- A. CENTRAL CAMPUS ON DAVIE, THROUGH A BACK STREET AND I, RAN A STOP SIGN. I GOT PULLED OVER IMMEDIATELY BY DAVIE POLICE DEPARTMENT, I BELIEVE IT WAS DAVIE, B.S.O., OR, AND THEY UH, I BELIEVE, I'M NOT SURE IF THE GUY ISSUED A CITATION OR NOT. - Q. DO YOU REMEMBER WHERE YOU PARKED IT?
- A. NO I DON'T. IT WAS ACROSS FROM THE CAMPUS ON UH, DAVIE ROAD, IS THAT DAVIE ROAD? OR DAVIE ROAD EXTENSION...UM, SOMEWHERE RIGHT ACROSS THE...THE STREET THERE.
- Q. THERE'S A TRAILER PARK THERE, THERE'S SOME STORES.
- A. NO, SOMETHING IT WAS IN FRONT OF A STORE, IT WAS A STORE FRONT. OR MAYBE THE STORE THEMSELVES HAD IT TOWED, BUT WHEN I WENT BACK THE CAR WAS GONE.

- A. RIGHT.
- Q. BUT IT'S IMPORTANT THAT WE TRY TO AT LEAST, OK?
- A. RIGHT.
- Q. SO SOME OF MY QUESTIONS MIGHT SEEM A LITTLE RIDICULOUS, FOR YOU TO REMEMBER BUT I'M GONNA ASK THEM. UH...LET'S GET INTO YOUR PERSONAL RELATIONSHIP WITH THE WALSH FAMILY. I UNDERSTAND YOU'VE KNOWN THEM. THEY HAD COME DOWN..
- A. RIGHT...
- Q. THEY LIVED SOMEWHERE.. (UNINTELLIGIBLE)
- A. I THINK THEY LIVED IN NEW YORK, I'M NOT EXACTLY...WHICH PART OF NEW YORK IT IS. ANYWAY UH, BUFFALO POSSIBLY, I THINK BUFFALO, YEAH. ANYWAY THEY CAME DOWN, JOHN WAS WORKING AS A POOL ATTENDANT FOR THE DIPLOMAT GOLF AND RACQUET WHICH IS NOW THE RAMADA AT UH, RIGHT ON THE CORNER OF HALLANDALE BEACH BOULEVARD..
- Q. RIGHT.

- A. AND DIPLOMAT PARKWAY AND HE WAS A POOL BOY THERE AND YOU KNOW, HE'S A NICE, NICE GUY, MY DAD AND I WE USED TO ALWAYS GO DOWN TO THE POOL AND TAKE A SWIM AND I GUESS MY DAD MET HIM AND KIND OF GRAVITATED TOWARDS HIM AND LATER ON I THINK HE HELPED (UNINTELLIGIBLE) GET A JOB AT THE MAIN EAST BUILDING, WHICH IS THE DIPLOMAT, THE MAIN DIPLOMAT HOTEL ON THE BEACH.
