THIS STATEMENT IS BEING TAKEN IN REGARD TO CERTAIN KNOWLEDGE THAT MISS CARLES HAS CONCERNING AND INCIDENT THIS POLICE DEPARTMENT'S CURRENTLY INVESTIGATING IN REFERENCE TO, THE ABOVE LISTED INCIDENT, LISTED AS A HOMICIDE WHICH OCCURRED IN THE CITY OF HOLLYWOOD, COUNTY OF BROWARD, STATE OF FLORIDA ON 7/27/81 AT A TIME OF, OFFICIAL TIME REPORT OF 12:30 HOURS, LOCATION 300 HOLLYWOOD MALL, THIS STATEMENT IS BEING TAKEN BY DETECTIVE MARK SMITH, BADGE 1163 OF THE HOLLYWOOD POLICE DEPARTMENT. Q. I'D, CAROL AT THIS TIME I'D LIKE TO PLACE YOU UNDER OATH BY VIRTUE OF MY COMMISSION AS A POLICE OFFICER WITH, CERTIFIED WITH THE STATE OF FLORIDA. FIRST OFF ARE YOU AWARE IT IS A CRIME TO LIE UNDER OATH?

A. YES.

Q. WOULD YOU RAISE YOUR RIGHT HAND PLEASE? LET THE RECORD, RECORD REFLECT SHE IS DOING SO. DO YOU SOLEMNLY SWEAR TO TELL THE TRUTH, THE WHOLE TRUTH AND NOTHING BUT THE TRUTH SO HELP YOU GOD?

A. YES.

- Q. CAROL CARLES HAVING APPEARED BEFORE ME AS A POLICE OFFICER FOR THE CITY OF HOLLYWOOD, COUNTY OF BROWARD, STATE OF FLORIDA AND HAVING BEEN DULY SWORN DEPOSES AND STATES. FOR THE RECORD CAROL WOULD YOU STATE YOUR FULL NAME AND BIRTH DATE PLEASE?
- A. MAIDEN NAME OR MARRIED NAME?
- Q. YOUR NAME, CURRENT NAME.
- A. CAROL ANN CARLES, MY BIRTH DATE IS THE 4TH, IS THE 29 OF APRIL 1953.
- Q. OK. CAROL WE'RE HERE TO, TO INTERVIEW YOU. AGENT CONDON PHONED, I GUESS YOU GOT A, YOU BEEPED HIM AND HE CALLED YOU BACK AND ASKED IF WE COULD COME OVER AND SPEAK TO YOU APPROXIMATELY AN HOUR AGO, HALF HOUR AGO. WE CAME OVER HERE TO INTERVIEW YOU AND WE SAT DOWN AND WE EXPLAINED TO YOU THAT THE REASON FOR THE INTERVIEW IT'S REGARDING THE ADAM WALSH GASE. DO, YOU DO RECALL SPEAKING WITH AGENT CONDON SEVERAL DAYS AGO REGARDING THE SAME SUBJECT DO YOU NOT?
- A. YES.
- Q. OK. IF I'M NOT MISTAKEN BACK THEN YOU EXPLAINED TO AGENT CONDON,

WELL, WELL WE'LL GET INTO WHAT WAS, WAS DISCUSSED THEN BUT NOW AS WE, AS WE ARE HERE NOW, TODAY, WHAT KNOWLEDGE DO YOU HAVE OF THE ADAMS WALSH HOMICIDE?

- A. I HAVE NO KNOWLEDGE.
- Q. OK. HAVE YOU EVER DISCUSSED WITH ANYBODY ANY KNOWLEDGE THAT YOU HAD HAD OR DID HAVE REGARDING THIS CASE?
- A. FIRST HAND KNOWLEDGE, SEEN KNOWLEDGE NO.
- Q. FIRST HAND KNOWLEDGE.
- A. NO.
- Q. OK. DID YOU, DID YOU EVER HAVE AN OPINION OR ANY SECOND HAND KNOWLEDGE OR ANY CONVERSATION WITH SOMEONE ELSE WHO DID HAVE KNOWLEDGE ABOUT WHAT HAD HAPPENED?
- A. OH, YOU ALWAYS HAVE SPECULATION WITH, YOU KNOW ABOUT EVERYTHING THAT MEANT SOMETHING.
- Q. RIGHT. AND HAVE YOU FORMED AN OPINION ABOUT WHAT HAD HAPPENED?
- A. NO NOT AN OPINION, A SPECULATION.
- Q. WAS IT BASED ON ANYTHING IN PARTICULAR?
- A. NO. NO, IT'S BASED ON A LOT OF THINGS.
- Q. DO YOU MIND IF WE GET, GET INTO THEM?
- A. SURE.
- Q. OK. WHEN YOU SAY A LOT OF THINGS IS IT A LOT OF THINGS THAT YOU PERSONALLY OBSERVED OR, OR JUST A LOT OF THINGS THAT PEOPLE, THAT YOU OVERHEARD OR SOMETHING ELSE?
- A. IT'S BASED ON FEELINGS ABOUT HOW I FELT ABOUT MIAMI AND THE AREA AND THINGS THAT WERE HAPPENING IN MIAMI AND YOU KNOW THAT'S IT. AND THAT, YOU FORM AN OPINION ABOUT DIFFERENT THINGS.
- Q. ALRIGHT. GO AHEAD.
- A. I MEAN WHAT PARTICULARS DID YOU WANT? I'M, I'M LOST.
- Q. WELL I WANT (UI) TO HEAR WHAT, WHAT YOU SAY.
- A. YEAH.
- Q. I MEAN YOU.
- PM. MAY, MAYBE HOW YOU CAME TO, TO KNOW THE MONAHANS AND, AND SUBSEQUENTLY I GUESS THE WALSH'S.

- A. OH, I DIDN'T KNOW THE WALSH'S I HAD MET THE WALSH'S OK SOCIALLY.
- Q. THROUGH.
- A. THROUGH, AT THE MONAHANS HOUSE, OK?
- Q. THROUGH. HOW DID YOU GET DOWN TO THE MONAHANS HOUSE?
- A. MY EXHUSBAND AT THE TIME I WAS DATING HIM, WE WEREN'T MARRIED AND HE WAS WORKING FOR JOHN MONAHAN AND STAYING AT HIS HOUSE.
- Q. OK. SO YOU WERE GOING DOWN THERE?
- A. I WOULD GO, I WENT DOWN THERE ABOUT FOUR TIMES TO VISIT HIM. BUT NO REAL LENGTH OF TIME JUST FOUR TIMES TO VISIT HIM.
- Q. WHAT WAS THE LONGEST TIME THAT YOU STAYED DOWN THERE?
- A. MAYBE TWO WEEKS, MAYBE. (UI).
- Q. WAS IT MORE OFTEN SHORTER THAN THAT?
- A. WELL I ONLY WENT FOUR TIMES USUALLY IT WAS JUST A WEEKEND.
- Q. OK.
- A. I WOULD (UI) DOWN.
- Q. AND YOU STAYED AT THE MONAHAN RESIDENCE.
- A. YEAH.
- Q. AND WHILE THERE YOU MET THE WALSH'S ONE, A FEW TIMES, ONE OR TWO, THREE OR FOUR?
- A. A COUPLE OF TIMES.
- Q. AND WHAT, IN WHAT WAY I MEAN WAS IT, WERE THEY COMING OVER FOR A PARTY OR WHAT?
- A. YEAH, THEY WERE, THEY WERE GOING OUT SOCIALLY YOU KNOW. THEY CAME BY. THEY CAME BY A COUPLE OF TIMES I'M SURE.
- Q. (UI).
- A. YOU KNOW BEFORE GOING ONTO ANOTHER PLACE AND ONCE AT JOHN MONAHANS OFFICE CAUSE OF THE, WE WERE THERE FOR THE BEACH AND STUFF AND IT WAS ON THE OCEAN, (UI) WAS THERE.
- Q. OK. DURING THAT TIME IS THERE ANYTHING THAT YOU OBSERVED THAT YOU LATER HAD SPECULATED MIGHT HAVE CONTRIBUTED TO WHAT HAPPENED TO ADAM?
- A. NO.

- Q. DID IT HAPPEN LATER?
- A. NO. IT MY FEELING ABOUT WHAT WAS MY FEELINGS ABOUT THINGS THAT WERE HAPPENING TO MY EXHUSBAND. OK?
- Q. LIKE.
- A. SO I DIDN'T LIKE, I WAS VERY UNCOMFORTABLE WITH THE WHOLE AREA DOWN THERE, I DIDN'T LIKE IT AT ALL.
- Q. WHAT, WHAT KIND OF THINGS WERE HAPPENING TO YOUR EXHUSBAND?
- A. WELL HE WAS, YOU KNOW HE HAD A JOB HERE AND HE WORKED HIS JOB HERE TO, HERE TO GO DOWN THERE UNDER PRETENSES OF BEING YOU KNOW, KNOWING THE TOURISM BUSINESS HERE AND THEN BEING IN THE TOURIST BUSINESS DOWN THERE WITH COUNTRIES TOURISM TO BRING THEM, KIND OF LIKE A LIAISON.
- Q. UH-HUH.
- A. YOU KNOW OF THEM DOING A HOLIDAY CENTER THERE, A HOLIDAY CENTER HERE THOSE THINGS I WOULDN'T KNOW ABOUT IT BUT HE WOULD JUST SPEND ALL OF HIS TIME JUST SITTING ON THE COUCH.
- Q. ALRIGHT.
- A. GO AND PICK UP DRY CLEANING AND THE ONLY ONE TIME I EVER SAW HIM DO ANYTHING WAS DRIVE TO THE AIRPORT, PICK UP PEOPLE UP CONTINUALLY OR GO AND SHOW SOMEBODY GOLF CARTS IN ALL THOSE MONTHS AND HE WAS MAKING NO MONEY DURING THAT TIME AND THEN YOU READ THE NEWSPAPER, YOU SEE THE TELEVISION YOU KNOW IT, IT WAS, I WAS VERY FRUSTRATED, IT WAS A COLD ENVIRONMENT, IT WAS, IT WAS AN AWFUL ENVIRONMENT.
- Q. WHEN YOU SAY READ THE NEWSPAPER AND SEE THE TV, WHAT ARE YOU TALKING ABOUT THE VIOLENCE DOWN IN MIAMI OR WHAT?
- A. THAT'S THE FIRST TIME I'D EVER SEEN CARS ON THE SIDE OF THE ROAD WITH DEAD BODIES IN THE TRUNK YOU KNOW. IT WAS ON THE NEWS THE VERY FIRST NIGHT I GOT THERE, THE FIRST TIME I EVER VISITED MIAMI IT WAS YOU KNOW THAT KIND OF STUFF, THAT CERTAINLY FIFTEEN YEARS AGO, AND I'M NOT TALKING ABOUT TODAY, BUT FIFTEEN YEARS AGO NOT IN ORLANDO YOU KNOW AND HERE I HAD MY LITTLE FOUR YEAR OLD CHILD WITH ME YOU KNOW IT WAS LIKE YOU KNOW WHERE THE HELL AM I? YOU KNOW.
- Q. OK.
- A. AND EVERYTHING, THE FEELING OF EVERY BIT OF THAT CAME TO YOU KNOW AND IT WAS.
- DC. WAS, WAS THERE EVER A TIME WHEN YOU, WHEN YOU LEFT SOUTH FLORIDALIKE UNDER A SENSE OF URGENCY?
- A. NO. YOU ASKED ME THAT THE OTHER DAY. NO.

DC. WELL, WELL ONE OF THE, ONE OF THE THINGS THAT CAME UP WITH OUR INTERVIEW.

Q. WHY DON'T WE GO AHEAD, I MEAN LET'S, WE'VE GONE PHIL HAVE YOU GOT ANYTHING TO SAY BEFORE WE GET INTO?

PM. WHAT, WHAT OBVIOUSLY THERE CAME A TIME WHEN YOU NO LONGER WENT TO THE MONAHANS HOUSE.

A. RIGHT.

PM. HOW, HOW DID THAT COME ABOUT? WHAT DID THAT (UI)?

A. BECAUSE YOU KNOW I MEAN JUST EVERYTHING ABOUT YOU KNOW. JOHN MONAHAN WAS BIGGER THAN GOD YOU KNOW HE WAS JUST, HE JUST WAS A WONDERFUL HUMAN BEING. I MEAN I JUST COULD NOT SEE IT.

Q. (UI).

A. YOU KNOW AND HE JUST WAS YOU KNOW, IT WAS, HE WOULD SIT ON THE COUCH CAUSE JOHN WANTED HIM TO SIT ON THE COUCH AND WAIT FOR THE PHONE TO RING WITH A SHIRT AND TIE ON SINCE 9 D'CLOCK IN THE MORNING UNTIL SIX O'CLOCK HE'D NEVER LEAVE THAT COUCH YOU KNOW HOPING THAT JOHN WOULD CALL FOR HIM TO GO PICK UP HIS DRY CLEANING. I MEAN YOU KNOW HOW OFTEN DO YOU VISIT SOMEBODY AND SAY WHOA TIME OUT, DO YOU THINK I'M GOING TO LIVE IN THIS ENVIRONMENT? DON'T THINK SO.

PM. OK. SO BASICALLY WHAT I'M GETTING AT IS ON, AND CORRECT ME IF I'M WRONG, YOU FELT THAT JOHN MONAHAN WAS TAKING ADVANTAGE OF YOUR EXHUSBAND.

A. VERY MUCH SO.

PM. AND B YOU WERE UNCOMFORTABLE FOR YOUR SAFETY AND THE SAFETY OF YOUR CHILD IN THAT AREA, NOT THAT PARTICULAR HOUSE BUT IN THAT AREA.

A. IN MIAMI YEAH. NOT THAT HOUSE YOU KNOW I MEAN THINGS HAPPENED WHILE I WAS THERE YOU KNOW I MEAN THERE WAS ONE NIGHT A VAN WAS, THE VAN BROKEN INTO YOU KNOW. I DON'T EVEN THINK WE WERE HOME BUT CAME HOME OR, JUST, I JUST REMEMBER THE VAN BEING BROKEN INTO YOU KNOW AND RIGHT THERE ON THE FRONT YARD YOU KNOW.

Q. DID BERN?

PM. DID SOMETHING OCCUR THAT CAUSED (UI) BREAK?

A. AND I REMEMBER BEFORE THE VAN THERE WAS A BREAK IN IN THE HOUSE, YOU KNOW BEFORE I EVER WENT DOWN THERE AND THEN HE TOLD ME ABOUT THE BREAK. YEAH, YOU KNOW I MEAN AND THEN YOU READ THE NEWSPAPER AND YOU SEE THE TELEVISION AND THEN THE ENVIRONMENT. IT, IT WAS JUST NOT FOR ME.

PM. WHAT, WHAT BASICALLY CAUSED YOU TO CEASE GOING?

- A. BECAUSE BERNIE WASN'T GOING TO LEAVE IT.
- PM. DID HE STAY THERE AND HE'D COME BACK HERE TO (UI)?
- A. HE STAYED THERE A COUPLE MORE MONTHS, HE YOU KNOW I, WE ENDED THAT WAS SEE YA.
- PM. THAT WAS THE END OF THE RELATIONSHIP?
- A. YEAH, AND YOU KNOW WHEN YOU CAN GET IT TOGETHER YOU KNOW WHERE TO FIND ME IN ORLANDO.
- PM. YOU LEFT VOLUNTARILY, I MEAN NOBODY CONTROLLED YOU IN ANY WAY OR FORCED YOU TO LEAVE.
- A. OH, YEAH, NO, NO, NO, NO, NO, NO, NO SCREAMING, ARGUING, FIGHT, IT WAS VERY PLEASANT, IT WAS YOU KNOW I UNDERSTOOD WHY HE WAS DOING IT I MEAN HE HAD (UI) OF FAITH IN THIS INDIVIDUAL YOU KNOW SO WHAT DO YOU FIGHT WITH SOMEBODY WHO THINKS GOOD THINGS OF SOMETHING ELSE, YOU JUST HAVE TO TELL HIM LISTEN YOU KNOW WHEN YOU COME TO THE REALITY OF WHAT THIS IS.
- PM. DID BERNIE EVER TELL YOU TO LEAVE FOR YOUR OWN SAFETY BECAUSE OF WHAT WAS GOING ON?
- A. NO.
- Q. DID?
- A. IF I FELT THAT WAY I WOULDN'T HAVE TAKEN MY SON DOWN THERE.
- Q. ALRIGHT SO, YOU'RE, WHAT YOU'RE SAYING TODAY IS BERNIE DIDN'T TELL YOU OR INSINUATE ANY, THERE WAS ANY, YOU WERE IN ANY DANGER, ANYONE WAS IN ANY DANGER, THERE WAS ANY THREATS MADE?
- A. NO. NO.
- Q. THAT ANYTHING WAS GOING TO HAPPEN FOR YOU TO LEAVE?
- A. NO.
- Q. OK. WHEN? DID YOU EVER GO BACK AFTER THAT?
- A. (UI).
- Q. THE LAST TIME, THE LAST TIME?
- A. YEAH, WE'VE BEEN BACK TO, I'VE BEEN BACK TO MIAMI MANY TIMES FOR FOOTBALL GAMES AND THINGS LIKE THAT YOU KNOW.
- Q. I MEAN BACK TO WHERE THE MONAHANS LIVED OR.
- A. NO.

- Q. JUST TO VISIT THE MONAHANS.
- A. NO.
- Q. SEPARATE FROM WHEN BERNIE WAS WITH YOU?
- A. NO: NO.
- Q. ALRIGHT.
- PM. WHEN DID YOU FIRST LEARN ABOUT THE ADAM WALSH CASE?
- A. ON TELEVISION WHEN JOHN, HE WENT ON TELEVISION TO PLEA FOR WHOEVER HAD HIS CHILD.
- PM. DID YOU (UI)?
- A. I MEAN HE WAS GIVING A DATE A MINUTE AGO AND I'M THINKING OH, IS THAT WHEN IT WAS?
- Q. THE MURDER WAS, THE, OK, JULY 27, 1981. OK?
- A. WAS, WAS WHEN HIS, WHEN HE WAS MISSING?
- Q. MISSING TWO WEEKS LATER HE WAS FOUND MURDERED.
- A. IT WAS WHAT RIGHT AFTER, RIGHT AFTER THAT HE WENT ON TELEVISION YOU KNOW AND THAT'S WHEN I SAW HIM ON GOOD MORNING AMERICA.
- PM. SO IT'S (UI) THAT YOU HEARD.
- A. YOU KNOW I SAID OH, MY GOD YEAH, AND IT WAS IN THE NEWSPAPERS.
- Q. HOW LONG, HOW LONG HAD YOU BEEN BACK IN ORLANDO WHEN, WHEN YOU HEARD THAT, OR HEARD THAT ON TV OR NOTICED THAT ON TV?
- A. I THINK I WAS ABOUT SIX MONTHS, IT WAS ABOUT SIX MONTHS.
- Q. YOU HAD BEEN BACK FOR SIX MONTHS?
- A. I HADN'T BEEN BACK TO MIAMI IN SIX MONTHS.
- Q. OK. AND BERNIE, WAS BERNIE STILL WORKING DOWN IN SOUTH FLORIDA?
- A. NO HE WORKED IN ORLANDO, HE CAME BACK A COUPLE MONTHS AFTER YOU KNOW.
- Q. AFTER YOU?
- A. I MEAN SHORT, WHEN I SAID I WASN'T GOING DOWN THERE ANYMORE IT WAS WITHIN A COUPLE MONTHS HE WAS BACK IN ORLANDO TO STAY.
- $\ensuremath{\text{O}}$. OK. DO YOU HAVE ANOTHER QUESTION ON THOSE LINES OR I'M GOING TO CHANGE THE SUBJECT?

PEVIEWER:

PM. JUST THE ONE (UI). NOW YOU HEARD (UI) MENTIONED THE (UI) WAS SHORTLY, SHORTLY AFTER THE ACTUAL (UI). DID THERE COME A TIME AFTER THAT FROM RIGHT UP TILL TODAY THAT YOU HAD ANY CONTACT OR CAME TO ANY ADDITIONAL INFORMATION (UI)?

- A. OTHER THAN WATCH THE TELEVISION AND WHAT THESE PRESS PEOPLE YOU KNOW BUT, ABOUT SIX MONTHS AGO YOU KNOW IT COULD BE (UI) THAN THAT YOU KNOW BECAUSE THE NEWSPAPER PEOPLE LAST NIGHT TOLD ME THAT I PROBABLY WAS OFF ON THAT DATE. FINE, OK THAT THE ALABAMA (UI) NEWSPAPER, CHRONICLE OR SOMETHING CALLED ME AND SAID THAT THEY WERE OPENING THE CASE, TRYING TO GET THE CASE OPENED AND THEY WERE WORKING WITH I THINK THEY SAID THE MIAMI HERALD THAT THEY WERE GOING TO DO IT AS WELL AND THAT THEY FELT THERE WAS MORE INFORMATION TO IT AND THEY WANTED TO GET INTO THOSE FILES THAT THEY YOU KNOW, THAT GUY WHO KNOWS, SAID BITS AND PIECES OF STUFF.
- Q. DO YOU REMEMBER WHO IT WAS?
- A. NO I DON'T REMEMBER (UI).
- Q. THE ALABAMA REPORTER YOU'RE TALKING ABOUT?
- A. YEAH.
- Q. HE CALLED YOU?
- A. HE CALLED MY UNLISTED PHONE NUMBER. HE SAID HE HAD SOME KIND OF SOURCE, WOULDN'T TELL ME HOW HE GOT MY NUMBER, WHAT HIS SOURCE WAS, HE WOULDN'T TELL ME WHAT THE SOURCE HAD TOLD HIM, HE JUST FELT ABSOLUTELY CONVINCE THAT I SUPPOSEDLY KNEW SOMETHING AND I.
- PM. DID HE SAY WHAT HE THOUGHT YOU KNEW?
- A. NO WOULDN'T TELL ME ANYTHING. HE JUST THEN I HUNG UP WHEN I SAID YOU KNOW I DON'T KNOW WHAT YOU THINK YOU KNOW OR WHAT YOUR SOURCE SAYS (UI).
- PM. DO YOU RECALL IF HE ASKED YOU ANY QUESTIONS THAT GAVE YOU, GAVE YOU A HINT OF WHAT HE THOUGHT YOU MIGHT KNOW?
- A. NO HE JUST TALKED ABOUT ADAMS CASE AND IF THINGS, WITH LITTLE PIECES ON AND ON OF WHY THEY WERE OPENING AND WHY THEY WANTED TO GET INTO THE FILES AND THAT KIND OF STUFF.
- Q. COULD YOU TELL WHAT DIRECTION HE WAS TRYING TO GO IN?
- A. NO BECAUSE I ASKED HIM THE SAME WAY, I SAID YOU KNOW WHY DON'T YOU JUST COME OUT AND ASK ME THE QUESTION AND MAYBE I CAN GIVE YOU AN ANSWER BECAUSE I DON'T YOU KNOW WE'RE PLAYING IN A BALL PARK HERE, WE'RE YOU KNOW WHAT YOU KNOW.
- Q. DID HE MENTION ANY NAMES?

- A. NO AND THEN HE CALLED BACK TEN MINUTES LATER AND SAYS LET ME GIVE YOU MY PHONE NUMBER AND EVERYTHING IN CASE YOU CAN THINK OF SOMETHING YOU KNOW, SOMETHING WILL COME TO YOU AND YOU'LL WANT TO TALK TO ME.
- Q. YOU DON'T REMEMBER HIS NAME DO YOU?
- A. NO I NEVER WROTE IT DOWN, DIDN'T WRITE HIS PHONE NUMBER DOWN BECAUSE I HAD NOTHING TO SAY TO THE GUY.
